COMMISSION ANNOUNCEMENTS

CHAIRMAN LEVITT TO TESTIFY AT APPROPRIATIONS HEARING

Chairman Levitt will testify on Thursday, March 25, before the Subcommittee on Commerce, Justice, State, and the Judiciary of the Committee on Appropriations concerning appropriations for fiscal year 2000 at the U.S. Capitol Building, Room S-146, at 10:00 a.m.

COMMISSIONER UNGER TO TESTIFY

Commissioner Laura Unger will testify before the House Subcommittee on Capital Markets, Securities, and Government-Sponsored Enterprises on Thursday, March 25 concerning the effect of technology on the capital markets. The hearing will begin at 10:00 am in Room 2128 of the Rayburn House Office Building.

RULES AND RELATED MATTERS

EXTENSION OF THE COMMENT PERIOD FOR THE REGULATION OF SECURITIES OFFERINGS PROPOSALS

The Commission extended the comment period for its proposals to modernize and clarify the regulatory structure for offerings under the Securities Act of 1933. Those proposals are in Securities Act Release No. 7606A (11/13/98), 63 FR 67174 (12/4/98) (Proposing Release). The original comment deadline established by the Proposing Release was April 5, 1999. The new deadline is June 30, 1999. ENFORCEMENT PROCEEDINGS

COMMISSION INSTITUTES ADMINISTRATIVE PROCEEDING AGAINST RODGER REES

The Commission issued an administrative proceeding as to Rodger Evans Rees, the former president of Buckhead Financial Corporation. The Order alleges that Rees was responsible for supervising two

Buckhead registered representatives who recommended and sold the common stock of Marcorp, Inc. to their customers without an adequate basis. The Order also alleges, among other things, that one representative assisted in the manipulation of Marcorp, received Marcorp stock for his efforts, and failed to disclose the compensation to his customers, and that the other representative received \$10,000 from a principal of Marcorp for selling Marcorp stock and failed to disclose the compensation to his customers. The Order alleges that Rees did not reasonably delegate to others his supervisory responsibilities as Buckhead's president, and that he failed reasonably to supervise the representatives with a view to preventing violations of the federal securities laws. NICHOLAS HOWARD SANCTIONED

Nicholas P. Howard has been suspended for three months from association with a broker-dealer, fined \$50,000, and ordered to cease and desist from violations of the antifraud and other provisions of the federal securities laws.

The sanctions were imposed after a hearing before an administrative law judge. The law judge found that Howard aided and abetted securities law violations by his employer, James Capel, Inc. (JCI), and a customer, New Europe Hotels (NEH). The violations occurred in connection with JCI's "best efforts" marketing of two private placements of NEH stock in 1990 and 1991.

JCI and NEH violated the antifraud provisions and Exchange Act Rule 10b-9, which applies to part or none (also known as minimum-maximum) offerings. Rule 10b-9 requires that the minimum proceeds specified in a part or none offering be received by the date specified. If not, all investor funds must be returned. One purpose of the rule is to assure that the issuer has sufficient capital to go forward with its business plan. Another is to give investors some reasonable indication that they are paying a fair market price; hence funds must be raised from bona fide sales.

The first NEH offering was a part or none offering, and was closed without receiving the required minimum proceeds from bona fide sales. JCI itself purchased shares to reach the minimum, and another investor's purchase was financed from the proceeds of the offering through a loan scheme approved by JCI and NEH's board of directors. Investor funds were retained rather than returned, and subscribers in neither offering were informed of the irregularities.

JCI also violated Section 17(a) of the Investment Company Act when it sold NEH shares to a mutual fund to which it was an investment adviser.

Howard was in charge of marketing the offerings to qualified institutional investors. The law judge concluded that some of his actions substantially assisted JCI's and NEH's violations. For example, he informed subscribers in the first offering that JCI ;

planned to invest but not that JCI's investment would be counted toward the minimum. Also, as an NEH director he voted to approve the loan scheme. The law judge concluded that he did not know that his role was part of an overall activity that was improper, but that he was reckless in not knowing this. His lack of knowledge stemmed from his failure to learn the requirements of the part or none offering he was selling, which was a breach of his duty as a salesman. Based on his substantial assistance and reckless lack of knowledge, the law judge concluded that he aided and abetted JCI's and NEH's violations. (Initial Decision No. 138; File No. 3-8873)

LAWRENCE KNAPP BARRED FROM SECURITIES INDUSTRY

The Commission has entered an Order pursuant to Sections 15(b) and 19(h) of the Securities Exchange Act of 1934 Making Findings and Imposing Remedial Sanctions (Order) against Lawrence M. Knapp (Knapp) of Arvada, Colorado. The Order finds that Knapp admitted in a criminal plea agreement that he misappropriated \$37,269 in funds from two clients while associated with a broker-dealer. The Order further finds that Knapp pled guilty to an information charging one count of wire fraud on July 15, 1997, and was sentenced by the United States District Court for the District of Colorado on September 23, 1997. The court entered a final judgment on the guilty plea on October 31, 1997, sentenced Knapp to five months in prison and three years of probation, and ordered him to pay restitution (United States v. Lawrence Marvin Knapp, Case No. 97-CR-204-S, D. Colo. 1997).

Knapp consented to the Order, without admitting or denying the Commission's findings, and consented to a bar from association with any broker, dealer, municipal securities dealer, investment adviser or investment company. (Rel. 34-41205; File No. 3-9774)

INVESTMENT COMPANY ACT RELEASES

THE VICTORY PORTFOLIOS, ET AL.

An order has been issued on an application filed by The Victory Portfolios, et al. granting an exemption from Section 17(a) of the Investment Company Act. The order permits the Victory Special Growth Fund, a series of The Victory Portfolios, to acquire all of the assets and liabilities of the Gradison Opportunity Growth Trust, a series of Gradison Growth Trust. Because of certain affiliations, applicants may not rely on Rule 17a-8 under the Act. (Rel. IC-23747 - March 23)

WARBURG DILLON READ LLC

An order has been issued on an application filed by Warburg Dillon Read LLC (Warburg) exempting T-REX Trusts for which Warburg will serve as a principal underwriter from Section 12(d)(1) and Section 14(a) of the Investment Company Act, and exempting Warburg and the

Trusts from Section 17(a) of the Act. The order would permit other registered investment companies, and companies excepted from the definition of investment company under Sections 3(c)(1) and (c)(7) of the Act, to own a greater percentage of the total outstanding voting stock of the Trusts than that permitted by Section 12(d)(1) of the Act. The order would also exempt the Trusts from the initial net worth requirements of Section 14(a) of the Act and permit the Trusts to purchase U.S. Government securities from Warburg at the time of a Trust's initial issuance of Securities. CHARTWELL DIVIDEND AND INCOME FUND, INC.

A notice has been issued giving interested persons until April 19, 1999, to request a hearing on an application filed by Chartwell Dividend and Income Fund, Inc. for an order granting an exemption from Section 19(b) of the Investment Company Act and Rule 19b-1 under the Act. The order would permit the applicant, a registered closed-end investment company, to make periodic capital gains distributions with respect to its common stock pursuant to a distribution policy. (Rel. IC-23749 - March 23)

HOLDING COMPANY ACT RELEASES

AMEREN CORPORATION, ET AL.

An order has been issued authorizing Ameren Corporation, a registered holding company, its electric and gas public utility subsidiaries, Union Electric Company and Central Illinois Public Service Company, and its service company subsidiary, Ameren Services Company, to establish and participate in a money pool. (Rel. 35-26993)
