# EXTENSION OF COMMENT PERIOD FOR REPROPOSED AMENDMENTS TO RULES 15c2-11 AND 17A-4

The Commission is extending the comment period for a release reproposing amendments to Rules 15c2-11 and 17a-4 under the Securities Exchange Act of 1934 (Release No. 34-41110) which was published in the Federal Register on March 8, 1999, (64 FR 11124). The reproposed rule amendments would require broker-dealers to review issuer information before initiating priced quotes for over-the-counter securities. In addition, broker-dealers publishing priced quotations will have to review updated information annually. Broker-dealers will also have to document their review and record information regarding any significant relationships that they have with the issuer or others, including the receipt of any compensation to make a market. The comment period for Release No 34-41110, is being extended to May 8, 1999.

## ENFORCEMENT PROCEEDINGS

# INITIAL DECISION ISSUED IN QUEST CAPITAL STRATEGIES, INC. AND DAVID CHEN YU

On April 12, Administrative Law Judge Lillian A. McEwen issued an initial decision in the matter of Quest Capital Strategies, Inc. and David Chen Yu. Quest Capital Strategies, a registered broker-dealer and investment adviser, and David Chen Yu, Quest's president, were charged with failing reasonably to supervise John Nakoski, a registered representative of Quest, with a view toward preventing his violations of the federal securities laws. The Initial Decision finds that Nakoski failed to register as an investment adviser, defrauded investors in violation of the Securities Act, Exchange Act, and Advisers Act, and violated certain custody and disclosure requirements of the Advisers Act. The Decision concludes that although Nakoski was subject to the supervision of Quest and Yu when he violated the federal securities laws, Respondents reasonably supervised him with a view to preventing his securities laws violations. The Decision orders that the proceedings against Respondents Quest Capital Strategies Inc. and David Chen Yu be dismissed. (Initial Decision No. 141; File No. 3-8966)

# INVESTMENT COMPANY ACT RELEASES

# PAINEWEBBER INCORPORATED AND PAINEWEBBER EQUITY TRUST, ABCs TRUST SERIES 1

A notice has been issued giving interested persons until May 5, 1999, to request a hearing on an application filed by PaineWebber Incorporated and PaineWebber Equity Trust, ABCs Series 1. Applicants request an order under Sections 6(c) and 17(b) of the Investment Company Act for an exemption from Section 17(a) of the Act. The order would permit certain terminating series of a unit investment trust (UIT) to sell portfolio securities to certain new series of the UIT. (Rel. IC-23780 - April 9)

# HOLDING COMPANY ACT RELEASES

#### SYSTEM ENERGY RESOURCES, INC.

A memorandum opinion and supplemental order has been issued authorizing a proposal by Entergy Corporation (Entergy), a registered holding company, its electric generating subsidiary company, System Energy Resources, Inc. (SERI), and four of Entergy's five operating subsidiary companies, Entergy Arkansas, Inc., Entergy Louisiana, Inc., Entergy Mississippi, Inc. and Entergy New Orleans, Inc. The order authorizes SERI to increase its aggregate outstanding principal amount of first mortgage bonds and/or debentures from \$540 million to \$685 million and its tax-exempt bonds from \$350 million to \$515 million. A request for a hearing on the proposal filed by the City of New Orleans has been denied. (Rel. 35-27003)

#### CONSOLIDATED NATURAL GAS COMPANY, ET AL.

A supplemental order has been issued authorizing Consolidated Natural Gas Company, a registered holding company, and its nonutility subsidiary, CNG International Corporation, to invest up to \$100 million in a foreign gas pipeline project. (Rel. 35-27002; International Series Rel. 1191)

#### NORTHEAST UTILITIES, ET AL.

A notice has been issued giving interested persons until May 4, 1999, to request a hearing on a proposal by Northeast Utilities (Northeast), a registered holding company, Northeast's public utility subsidiaries, The Connecticut Light and Power Company, Western Massachusetts Electric Company, Public Service Company of New Hampshire, Holyoke Water Power Company, and North Atlantic Energy Corporation, and Northeast's nonutility subsidiaries, NU Enterprises, Inc., Northeast Generation Service Company, Northeast Generation Company, Select Energy, Inc., and Mode 1 Communications, Inc. In exchange, GTC will convey to Georgia Power all its rights, title and interests in and to real and personal property comprising up to four of GTC's distribution and transmission substation facilities, an exchange equalization payment of \$3,808,831, and an additional payment of \$560,000 to ensure that Georgia Power suffers no after-tax loss on the exchange.
