RULES AND RELATED MATTERS

REVISED COMPLIANCE DATES AND TECHNICAL AMENDMENT FOR THE REGULATION OF ALTERNATIVE TRADING SYSTEMS AND EXCHANGES

The Commission approved the publication of a release to modify compliance dates and make technical changes relating to the regulation of alternative trading systems and exchanges. The release revises the compliance dates for Rule 301(b)(3) relating to the public display of alternative trading systems' best priced orders. The release also makes a technical change to Rule 202.3 regarding the processing of exchanges' applications for registration as national securities exchanges or exemption from registration based on such exchanges' limited volume of transactions. INVESTMENT COMPANY ACT RELEASES

COLCHESTER STREET TRUST, ET AL.

A notice has been issued giving interested persons until May 10, 1999, to request a hearing on an application filed by Colchester Street Trust, et al. for an order under Section 6(c) of the Investment Company Act granting an exemption from Sections 18(f) and 21(b) of the Act, under Section 12(d)(1)(J) of the Act granting an exemption from Section 12(d)(1) of the Act, under Sections 6(c) and 17(b) of the Act granting an exemption from Sections 17(a)(1) and 17(a)(3) of the Act, and under Section 17(d) of the Act and Rule 17d-1 under the Act to permit certain joint transactions. The requested order would supersede an existing order that permits certain registered management investment companies to participate in a joint lending and borrowing facility. (Rel. INVESCO BOND FUNDS, INC., ET AL.
