#### ENFORCEMENT PROCEEDINGS

## ADMINISTRATIVE PROCEEDINGS SETTLED AGAINST JOSEPH FALLIN

On May 5, the Commission entered an Order Making Findings and Imposing Remedial Sanctions and Cease And Desist Order (Order) against Joseph O. Fallin of Houston, Texas. The Commission accepted Fallin's Offer of Settlement, in which he agreed to be suspended from association with any broker, dealer, municipal securities dealer, investment adviser, or investment company for a period of twelve months; Fallin also agreed to an order for him to cease and desist from committing or causing any violations of, and any future violation of, Section 17(a) of the Securities Act of 1933, Section 10(b) of the Exchange Act and Rule 10b-5 thereunder. Additionally, Fallin agreed to pay disgorgement of \$26,059, plus prejudgment interest. The Commission agreed to waive payment of this amount and not to impose civil money penalties against Fallin, based on his demonstrated financial inability to pay.

The Order finds that while Fallin was a registered representative of a registered broker-dealer, he made material misrepresentations and omissions in the sale of collateralized mortgage obligations to the City of Williamsburg, Virginia. (Rel. 33-7675; 34-41369; File No. 3-9702)

## INVESTMENT COMPANY ACT RELEASES

## WARBURG PINCUS ASSET MANAGEMENT, INC., ET AL.

A notice has been issued giving interested persons until May 27, 1999, to request a hearing on an application filed by Warburg Pincus Asset Management, Inc., Credit Suisse Asset Management, Abbott Capital Management, LLC and Blackrock Institutional Management Corporation for an order under Section 6(c) of the Investment Company Act exempting applicants from Section 15(a) of the Act. The order would permit the implementation, without prior shareholder approval, of certain new advisory and sub-advisory agreements (New Agreements) in connection with the acquisition of Warburg, Pincus Asset Management Holdings, Inc. by Credit Suisse Group (Acquisition). The order would cover a period of up to 150 days

following the later of: (i) the date on which the Acquisition is consummated, or (ii) the date on which the requested order is issued (but in no event later than December 31, 1999) (Interim Period). The order also would permit applicants to receive all fees earned under the New Agreements during the Interim Period following shareholder approval. (Rel. IC-23824 - May 5)

# INVESCO GLOBAL HEALTH SCIENCES FUND, ET AL.

An order has been issued on an application filed by INVESCO Global Health Sciences Fund, et al. granting an exemption from Section 19(b) of the Investment Company Act and Rule 19b-1 under the Act. The order amends a prior order permitting INVESCO Global Health Sciences Fund (Fund) to make up to four distributions of net longterm capital gains in any one taxable year, so long as the Fund maintains in effect a distribution policy calling for quarterly distributions of a fixed percentage of its net asset value. #### HOLDING COMPANY ACT RELEASES

## CINERGY CORP., ET AL.

An order has been issued authorizing the domestic nonutility subsidiaries of Cinergy Corp. (Cinergy), a registered holding company, to enter into service agreements with Cinergy's utility subsidiaries under which the nonutility subsidiaries may provide a range of services to the utility affiliates, and vice versa. The order also authorizes each of Cinergy's domestic nonutility subsidiaries (including future nonutility subsidiaries), other than exempt telecommunications companies and foreign utility companies, to enter into a separate but substantially similar contract with each of Cinergy's utility subsidiaries. # SELF-REGULATORY ORGANIZATIONS

#### IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

A proposed rule change filed by the <u>Philadelphia Stock Exchange</u> establishing a \$200 registration fee and a \$200 annual fee for off-floor traders for which the Exchange is the Designated Examining Authority (SR-Phlx-99-08) has become effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Publication of the proposal is expected in the <u>Federal Register</u> during the week of May 10. (Rel. 34-41361)

#### PROPOSED RULE CHANGE

The <u>New York Stock Exchange</u> filed a proposed rule change (SR-NYSE-98-41) to amend its opening imbalance publication procedures for expiration days. Publication of the notice in the <u>Federal Register</u> is expected during the week of May 10. (Rel. 34-41359)
