FILERS CAN USE EDGAR Y2K TEST SYSTEM BEGINNING JULY 12

EDGAR filers are reminded that starting at 8:00 a.m. on July 12, the EDGAR test system clock will be set to February 21, 2000 and will continue until the system clock reaches 10:00 p.m., March 10, 2000, on July 30, 1999. Filers are strongly encouraged to use this opportunity to test their EDGAR filing equipment and procedures for Y2K readiness.

EDGAR filer support staff will be available during operating hours to assist filers with any EDGAR Y2K issues encountered. JAIME LIZARRAGA, DEPUTY DIRECTOR OF LEGISLATIVE AFFAIRS, TO LEAVE SEC

The Commission today announced that Jaime E. Lizarraga, Deputy Director of the SEC's Office of Legislative Affairs, will leave the Commission next week to join the Democratic staff of the Committee on Banking and Financial Services at the U.S. House of Representatives. Mr. Lizarraga will serve as a senior professional staff member and will advise the Ranking Member, John J. LaFalce (D-NY), and Democratic Members on major financial institutions, legislative, and regulatory matters before the Committee.

As Deputy Director, Mr. Lizarraga, who arrived at the Commission in February of this year, advised the Chairman, Commissioners, and senior staff of the SEC on various legislative matters, including financial services modernization, accounting, and enforcement issues. He also facilitated close and continuing contacts between the Commission and congressional staff, committees, and Members of Congress.

SEC Chairman Arthur Levitt said, "During his short stay, Jaime was a valuable resource to those who worked with him. His affable

personality as well as his diligence, energy, and familiarity with the legislative process were a great asset to the Commission. I wish him continued success in the legislative arena." (Press Rel. 99-80)

INVESTMENT COMPANY ACT RELEASES

WACHOVIA FUNDS, ET AL.

A notice has been issued giving interested persons until July 29 to request a hearing on an application filed by Wachovia Funds, et al. for an order exempting applicants from Section 17(a) of the Investment Company Act. The order would permit certain common trust funds to transfer their assets to certain series of registered openend management investment companies in exchange for shares of the series. (Rel. SALOMON BROTHERS SERIES FUNDS INC., ET AL.

An order has been issued on an application filed by the Salomon Brothers Series Fund Inc., et al. for an exemption from Section 17(a) of the Investment Company Act. The order permits a series of Salomon Brothers Series Funds Inc. to acquire all of the assets and liabilities of a series of Smith Barney Investment Funds Inc. Because of certain affiliations, applicants may not rely on Rule 17a-8 under the Act. (Rel. IC-23901 - July 9)

HOLDING COMPANY ACT RELEASES

ATLANTIC CITY ELECTRIC COMPANY

A corrected order has been issued authorizing a proposal by Atlantic City Electric Company (ACE), a utility subsidiary of Conectiv, a registered holding company, to acquire a combustion turbine generating facility currently under lease to ACE. (Rel. 35-27043A)

APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change submitted under Rule 19b-4 by the New York Stock Exchange (SR-NYSE-98-41) amending its opening imbalance publication procedures for expiration days. (Rel. 34-41598)

The Commission approved a proposed rule change and Amendment No. 1 thereto, and granted accelerated approval to Amendment No. 2

thereto, submitted under Rule 19b-4 by the <u>National Association of Securities Dealers</u> (SR-NASD-98-08) relating to trade reporting rules. (Rel. 34-41606)

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

A proposed rule change filed by the <u>Philadelphia Stock Exchange</u> relating to participation on the Auto-X Wheel (SR-Phlx-99-18) has become effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Publication of the proposal is expected in the <u>Federal Register</u> during the week of July 12. (Rel. 34-41600)
