#### COMMISSION ANNOUNCEMENTS

The <u>Government Securities Clearing Corporation</u> filed with the Commission pursuant to Section 19(a) of the Securities Exchange Act of 1934 a request for extension of its registration as a clearing agency under Section 17A of the Act. The Commission has extended GSCC's temporary registration as a clearing agency through January 14, 2000. Publication of the notice and order is expected in the <u>Federal Register</u> during the week of September 6. (Rel. 34-41805)

## ENFORCEMENT PROCEEDINGS

# COMMISSION SETS ASIDE NASD'S DETERMINATION TO DENY A MEMBER FIRM'S CONTINUANCE APPLICATION

On August 31, 1999, the Commission set aside a determination by the National Association of Securities Dealers, Inc. to deny a member's application to employ Jacob Adoni as a registered representative. In early 1997, the United States District Court for the District of New Jersey entered a final judgment of permanent injunction against Adoni prohibiting him from violating Section 13(b)(5) of the Securities Exchange Act of 1934, and Exchange Act Rules 13b2-1 and 13b2-2. The NASD determined that this injunction subjected Adoni to a statutory disqualification because it fell within the category of injunctions that enjoin a conduct or practice in connection with the purchase or sale of a security.

The Commission held that Adoni's injunction did not enjoin a conduct or practice "in connection with" the purchase or sale of a security within the meaning of the Exchange Act. The complaint in the injunctive action did not allege and the record did not support a finding that any false or misleading information reached the public as a result of Adoni's conduct. Moreover, Adoni's injunction did not otherwise meet the Exchange Act's definition of a statutory disqualification. (Rel. 34-41813; File No. 3-9700)

# REBECCA ERDMAN AND LESLIE CHEKIN SETTLE COMMISSION ACTION

On August 31, 1999, the Commission announced that it reached a settlement with relief defendants Rebecca W. Erdman and Leslie Chekin in SEC v. Phebe Erdman, et al. On July 27, 1999, Judge William P. Dimitrouleas entered final judgments of disgorgement against the two relief defendants. Rebecca Erdman was ordered to pay disgorgement of \$20,211, plus prejudgment interest, but was required to pay only \$5,000 based on her inability to pay more. Leslie Chekin was ordered to pay \$27,110, but payment was waived based on her demonstrated inability to pay. Both Rebecca Erdman and Leslie Chekin consented to the entry of the final judgments without admitting or denying the allegations in the Commission's complaint. These settlements conclude the Commission's injunctive action.

On May 15, 1998, the Commission filed a complaint alleging that the defendants to the action, Phebe W. Erdman, Hans L. Erdman and David M. Lemon, conducted a fraudulent unregistered offering of stock in a worthless shell corporation called International Trade and Commerce Corp. (ITC). Relief defendants Rebecca Erdman and Leslie Chekin, family members of Phebe Erdman and Hans Erdman, sold ITC stock in the offering. [SEC v. Phebe W. Erdman, et al., U.S.D.C. Southern Florida, C.A. # INVESTMENT COMPANY ACT RELEASES

# ALLMERICA FINANCIAL LIFE INSURANCE AND ANNUITY COMPANY, ET AL.

A notice has been issued giving interested persons until September 24 to request a hearing on an application filed by Allmerica Financial Life and Annuity Company (Allmerica), Separate Account VA-K of Allmerica, Separate Account VA-P of Allmerica, Separate Account KG of Allmerica, Allmerica Select Separate Account of Allmerica, and Allmerica Investments, Inc. (collectively Applicants). Applicants seek an order under Section 6(c) of the Investment Company Act granting exemptions from the provisions of Sections 2(a)(32), 22(c), and 27(i)(2)(A) of the Act and Rule 22c-1 thereunder to permit the recapture of credits of up to 5% applied to contributions made under certain deferred variable annuity contracts. Applicants also request that the order extend to such credits applied to contributions made under contracts that Allmerica may in the future issue through the Separate Accounts or any future Separate Account of Allmerica, which contracts are substantially similar in all material respects to the contracts (future contracts). In addition, Applicants request that the order extend to any other National Association of Securities Dealers, Inc. member broker-dealer controlling or controlled by, or under common control with, Allmerica that serves as a distributor or principal underwriter for the contracts or future contracts. ## SELF-REGULATORY ORGANIZATIONS

#### PROPOSED RULE CHANGE

The <u>Chicago Board Options Exchange</u> filed with the Commission a proposed rule change under Rule 19b-4 (SR-CBOE-99-43) to amend its Constitution pertaining to corporate governance. Publication of the notice is expected in the <u>Federal Register</u> during the week of September 6. (Rel. 34-41791)

#### ACCELERATED APPROVAL OF PROPOSED RULE CHANGES

The <u>Depository Trust Company</u> filed a proposed rule change (SR-DTC-99-20) under Section 19(b)(1) of the Exchange Act. The proposed rule change implements a freeze on new participant accounts and a Year 2000 contingency plan for withdrawal by transfer transactions. The Commission has approved the proposed rule change on an accelerated basis. Publication of the proposal is expected in the <u>Federal Register</u> during the week of September 6. (Rel. 34-41799)

The Commission granted accelerated approval of a proposed rule change (SR-GSCC-99-03) filed by the <u>Government Securities Clearing Corporation</u> under Section 19(b) of the Securities Exchange Act. The proposed rule change will replace GSCC's current letter of credit form with a letter of credit form developed by the Unified Clearing Group. (Rel. 34-41802)

The Commission granted accelerated approval of a proposed rule change (SR-MBSCC-99-05) filed by the MBS Clearing Corporation under Section 19(b) of the Securities Exchange Act. The proposed rule change will replace MBSCC's current letter of credit form with a letter of credit form developed by the UCG. (Rel. 34-41803)

## IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

A proposed rule change filed by the <u>Philadelphia Stock Exchange</u> relating to mandatory trading floor training requirements (SR-Phlx-99-29) has become effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Publication of the proposal is expected in the <u>Federal Register</u> during the week of September 6. (Rel. 34-41788)
