ENFORCEMENT PROCEEDINGS

THE CRONOS GROUP CONSENTS TO A CEASE AND DESIST ORDER FOR VIOLATIONS OF ANTIFRAUD, REPORTING, BOOKS AND RECORDS, AND INTERNAL CONTROL PROVISIONS

On November 15, the Commission issued a settled Order Instituting Public Administrative Proceedings Pursuant to Section 8A of the Securities Act of 1933 and Section 21C of the Securities Exchange Act of 1934, Making Findings, and Imposing a Cease and Desist Order (Order) against The Cronos Group, a Luxembourg holding company that is one of the ten largest lessors of marine cargo containers. Cronos consented to the Order without admitting or denying the Commission's findings. The Commission found that Cronos violated antifraud provisions of the Securities Act of 1933 (Securities Act) and the Securities Exchange Act of 1934 (Exchange Act), and reporting, books and records and internal control provisions of the Exchange Act, and certain Exchange Act Rules.

The Commission found that Cronos failed to disclose and to properly account for numerous related party transactions with Stefan M. Palatin, its former chairman and chief executive officer, resulting in material misstatements and omissions in Cronos' registration statement, in public statements to shareholders, and in annual and other periodic reports filed with the Commission. The company made the false statements and omissions between 1995 and 1998. Commission found that Cronos failed to disclose, among other facts, that Palatin intercepted payments between Cronos and one of its major customers (which Palatin also controlled) which gave rise to a contingent liability for Cronos; Cronos paid Palatin millions of dollars in the year before its initial public offering and recorded the payments as a loan to a third party; and Palatin, through another entity that he controlled, sold shares in the IPO. Commission also found that, following the IPO, Cronos failed to disclose that it paid additional funds to Palatin immediately after the offering and that it made misstatements concerning the nature and purpose of other payments made to Palatin as well as the extent to which an obligation Palatin owed to Cronos was secured by The Commission found that Palatin controlled the collateral. company's disclosures and was the beneficiary of the transactions which the company misrepresented in its filings and public statements. The Commission further found that Cronos systematically

fired or demoted employees and directors who challenged or questioned the transactions or disclosure at issue.

The Commission found that these multiple misstatements and omissions violated the antifraud provisions of the Securities Act and Exchange Act, reporting provisions of the Exchange Act and Exchange Act Rules. The Commission also found that Cronos failed to make and keep books, records, and accounts, which, in reasonable detail, accurately and fairly reflected its transactions and dispositions of assets and further failed to devise and maintain a system of internal accounting controls sufficient to provide reasonable assurances that transactions were recorded as necessary to permit preparation of financial statements in conformity with generally accepted accounting principles.

The Commission ordered Cronos to cease and desist from committing or causing any violations and any future violations of Section 17(a) of the Securities Act, Section 10(b), 13(a), 13(b)(2)(A), and 13(b)(2)(B) of the Exchange Act, and Exchange Act Rules 10b-5, 12b-20, 13a-1, 13a-16, and 13b2-1.

STI CLASSIC FUNDS AND SUNTRUST BANKS, INC.

A notice has been issued giving interested persons until December 8, 1999, to request a hearing on an application filed by STI Classic Funds (STI Funds) and SunTrust Banks, Inc. for an order under Section 17(b) of the Investment Company Act. The exemption would permit two series of STI Funds to acquire all of the assets and certain stated liabilities of two other series of STI Funds. Because of certain affiliations, applicants may not rely on Rule 17a-8 under the Act. (Rel. IC-24132 - November 15)

HOLDING COMPANY ACT RELEASES

MONONGAHELA POWER COMPANY

A notice has been issued giving interested persons until December 6, 1999, to request a hearing on a proposal by Monongahela Power Company (Monongahela Power), a public utility subsidiary of Allegheny Energy, Inc., a registered public utility holding company. Monongahela Power proposes to acquire all of the assets and properties owned by UtiliCorp United Inc. in its West Virginia Power combination gas and electric division. (Rel. 35-27100)

ENTERGY CORPORATION

A notice has been issued giving interested persons until December 6, 1999, to request a hearing on a proposal by Entergy Corporation, a registered holding company, to increase the interest rates payable on certain outstanding debt. (Rel. 35-27100)

A notice has been issued giving interested persons until December 6, 1999, to request a hearing on a proposal by The Southern Company, a registered holding company, to extend until September 30, 2004, the time in which it may issue and sell up to 25 million shares of its common stock. An order has been issued authorizing a proposal by Allegheny Energy, Inc. West Penn and/or Allegheny have been authorized to: (1) form and capitalize a single member limited liability corporation (Energy Subsidiary) and a second subsidiary for the purpose of holding generating assets, rights, interests and related obligations (GENCO); (2) transfer utility generating assets and other rights and obligations to Energy Subsidiary and subsequently to GENCO; (3) issue notes; (4) engage in the brokering, trading and marketing activities around its own assets; (5) issue commercial paper in an amount not to exceed \$200 million through July 31, 2005; (6) make loans in an amount not to exceed \$100 million; (7) issue guarantees in an amount not to exceed \$480 million; (8) enter into leaseback agreements; and (9) enter into service agreements. Energy has also been authorized to transfer utility assets and obligations to GENCO. (Rel. 35-27101)
