ENFORCEMENT PROCEEDINGS

INITIAL DECISION IN PROCEEDING AGAINST VIRGINIA HORLER DECLARED FINAL

The Commission has given notice that the initial decision in the administrative proceeding against Virginia Horler is final. Horler acted as a financial advisor responsible for preparing official statements in connection with a 1990 municipal bond offering by the County of Nevada, California. The law judge found that, as a result of Horler's misconduct, the official statements contained material misstatements and omitted material information. The law judge concluded that Horler violated Securities Act Section 17(a), Exchange Act Section 10(b), and Exchange Rule 10b-5.

The law judge concluded that an order requiring that Horler cease and desist from further violations was not necessary. She noted that Horler had no prior disciplinary history and that the misconduct occurred nine years ago in connection with a single offering. The law judge therefore dismissed the proceeding. INVESTMENT COMPANY ACT RELEASES

J.P. MORGAN & CO. INCORPORATED

An order has been issued on an application filed by J.P. Morgan & Co. Incorporated (J.P. Morgan) under Section 6(c) of the Investment Company Act exempting certain entities that finance the operations of J.P. Morgan and certain of its subsidiaries from all provisions of the Act. The order amends an existing order to permit additional entities to rely on the existing order. (Rel. IC-24180 -December 1)

SALOMON BROTHERS ASSET MANAGEMENT INC., ET AL.

A notice has been issued giving interested persons until December 27 to request a hearing on an application filed by Salomon Brothers Asset Management Inc. (SBAM), et al. for an order granting an exemption from Section 17(a) of the Investment Company Act and permitting certain joint transactions under Section 17(d) of the Act

and Rule 17d-1 under the Act. The order would permit certain registered closed-end management investment companies advised by SBAM to enter into secured loan transactions with a facility administered by Citicorp North America, Inc., an affiliated person of SBAM. (Rel. IC-24181 - December 1)

SELF-REGULATORY ORGANIZATIONS

PROPOSED RULE CHANGES

The National Association of Securities Dealers filed a proposed rule change (SR-NASD-99-53) relating to the establishment of the Nasdaq Order Display Facility and to modifications of the Nasdaq Trading Platform. Publication of the proposal is expected in the Federal Register during the week of November 29. (Rel. 34-42166)

The Pacific Exchange filed a proposed rule change (SR-PCX-99-39) to create PCX Equities, Inc. Publication of the notice in the Federal Register is expected during the week of November 29. (Rel. 34-42178)

The National Association of Securities Dealers filed a proposed rule change (SR-NASD-99-54) creating a voluntary single arbitrator pilot program for claims between \$50,000.01 and \$200,000. Publication of the proposal is expected in the Federal Register during the week of December 6. (Rel. 34-42185)

The Chicago Board Options Exchange filed a proposed change (SR-CBOE-99-27) relating to customer communications. Publication of the proposal is expected in the Federal Register during the week of December 6. (Rel. 34-42186)

The Pacific Exchange filed a proposed rule change (SR-PCX-99-17) to permit floor brokers to immediately represent intra-floor telephonic orders in the trading crowd, with a written order ticket immediately to follow. Publication of the proposal is expected in the Federal Register during the week of December 6. (Rel. 34-42188)

The Options Clearing Corporation filed a proposed rule change (SR-OCC-99-09) to revise OCC's By-Laws and Rules to merge the currently separated equity and non-equity elements of the OCC's clearing fund into one combined clearing fund based on total margin requirements. The minimum contribution will be \$150,000. Publication of the proposal is expected in the Federal Register during the week of December 6. (Rel. 34-42195)

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGES

The Government Securities Clearing Corporation filed a proposed rule change (SR-GSCC-99-04), which became effective upon filing, to lower GSCC's fee for clearance that it charges to its netting members.

Publication of the proposal is expected in the Federal Register during the week of December 6. (Rel. 34-42183)

A proposed rule change (SR-CBOE-99-58) filed by the Chicago Board Options Exchange to adopt a stated policy that clarifies the maintenance rules governing the replacement of component stocks in the Dow Jones High Yield Select Ten Index has become immediately effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Publication of the notice is expected in the Federal Register during the week of December 6. (Rel. 34-42187)

APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change submitted by the Chicago Stock Exchange (SR-CHX-99-12) amending the recommended fine schedule for the submission of late financial and operational reports. Publication of the proposal is expected in the Federal Register during the week of December 6. (Rel. 34-42189)

The Commission approved a proposed rule change filed by the Chicago Board Options Exchange (SR-CBOE-99-32) to change the participation entitlement of designated primary market makers. (Rel. 34-42190)

The Commission approved a proposed rule change (SR-NASD-99-02), and granted accelerated approval to Amendment No. 2 to that proposed rule change, filed by the National Association of Securities Dealers to clarify the way that various NASD rules relating to "public offerings" apply to offerings of securities under Rule 504 of Regulation D, and to clarify other aspects of NASD rules relating to "public offerings." Publication of the proposal is expected in the Federal Register during the week of December 6. (Rel. 34-42191)
