#### INVESTMENT COMPANY ACT RELEASES

# CONNECTICUT GENERAL LIFE INSURANCE COMPANY, ET AL.

An order has been issued pursuant to Section 6(c) of the Investment Company Act exempting Connecticut General Life Insurance Company (CG Life), CG Variable Life Insurance Separate Account A (Separate Account), and CIGNA Financial Advisors, Inc. from Section 27(c)(2) of the Act and Rule 6e-3(T)(c)(4)(v) thereunder to the extent necessary to permit the Separate Account and any separate accounts established in the future by CG Life to support certain group variable universal life insurance contracts to deduct from premium payments received an amount that is reasonably related to the increased federal tax burden of CG Life resulting from the application of Section 848 of the Internal Revenue Code of 1986, as amended. # SOUTHLAND LIFE INSURANCE COMPANY, ET AL.

An order has been issued pursuant to Section 6(c) of the Investment Company Act exempting Southland Life Insurance Company, (Southland), Southland Separate Account A1 (Account), and ING America Equities, Inc. from the provisions of Sections 26(a)(2)(C) and 27(c)(2) of the Act to the extent necessary to permit the deduction of a mortality and expense risk charge from the assets of the Account and of any other separate account established in the future by Southland, in connection with the issuance and sale of certain variable annuity contracts. (Rel. IC-21634 - December 28)

## EAI SELECT MANAGERS EQUITY FUND, ET AL.

An order has been issued under Section 17(b) of the Investment Company Act exempting applicants from Section 17(a) of the Act, and pursuant to Section 17(d) of the Act and Rule 17d-1 thereunder. The

order permits a collective investment account sponsored by EAI Partners, L.P. (EAI) to transfer its securities to an open-end management investment company advised by a subsidiary of EAI. (Rel. IC-21640 - December 29)

# WORLDWIDE SHORT-TERM TRUST

A notice has been issued giving interested persons until January 29 to request a hearing on an application filed by Worldwide Short-Term Trust for an order under Section 8(f) of the Investment Company Act declaring that it has ceased to be an investment company. (Rel. IC-21644 - January 2)

#### HOLDING COMPANY ACT RELEASES

#### THE SOUTHERN COMPANY, ET AL.

A supplemental order has been issued releasing jurisdiction over a proposal by The Southern Company, a registered holding company, and its nonutility subsidiary companies, Southern Electric International, Inc. and Mobile Energy Services Holdings, Inc. (Mobile Energy) (collectively, Applicants). Applicants request that jurisdiction be released over Mobile Energy's proposal to make cash distributions consisting, in part, of a return of capital to the extent permitted under Alabama law. ## YANKEE ATOMIC ELECTRIC COMPANY

An order has been issued authorizing a proposal by Yankee Atomic Electric Company (Yankee Atomic), a subsidiary of both New England Electric System and Northeast Utilities, both registered holding companies. Yankee Atomic proposes, from January 1, 1996 through December 31, 1997, to borrow money from one or more banks up to a maximum aggregate amount outstanding at one time of \$10 million. ## AMERICAN ELECTRIC POWER COMPANY, INC., ET AL.

An order has been issued on a proposal by American Electric Power Company, Inc. (AEP), a registered holding company, and its nonutility subsidiary company, AEP Energy Services, Inc. (AEPES). AEP has been authorized to guarantee \$51 million of debt owed by AEPES to third parties through December 31, 1998. Jurisdiction has

been reserved over proposals by AEPES to make contributions to nonassociates to support the development of intellectual property; amend the terms upon which it pays an AEP affiliate for intellectual property developed by that affiliate for its own use; and provide or broker financing to customers in connection with the sale of goods or provision of services to such customers. # NATIONAL FUEL GAS COMPANY, ET AL.

An order has been issued authorizing National Fuel Gas Company (National), a registered holding company, and its wholly-owned subsidiary companies: National Fuel Gas Distribution Corporation, National Fuel Gas Supply Corporation, Seneca Resources Corporation, Highland Land & Minerals, Inc., Leidy Hub, Inc., Horizon Energy Development, Inc., Data-Track Account Services, Inc., National Fuel Resources, Inc., and Utility Constructors, Inc. (UCI) (collectively, Subsidiary Companies) to incur short-term borrowings and participate in the National system money pool; and issue and sell up to (a) \$300 million of commercial paper, and/or (b) \$600 million of short-term unsecured notes under credit facilities with banks and financial institutions, through December 31, 2000. In addition, National seeks authorization to allocate expenses associated with interest rate and currency exchange agreements among the Subsidiary Companies. (Rel. 35-26443)

## NEW ENGLAND ENERGY INCORPORATED

A supplemental order has been issued authorizing New England Energy Incorporated, a fuel supply subsidiary of New England Electric System, a registered holding company, to extend its existing authority, through December 31, 1998, to enter into interest rate protection agreements in respect to the lesser of \$175 million of outstanding debt or available amounts under its existing credit facility. # PUBLIC SERVICE COMPANY OF OKLAHOMA

An order has been issued authorizing Public Service Company of Oklahoma, a wholly-owned public-utility subsidiary company of Central and South West Corporation, a registered holding company, to make equity and debt investments totaling \$3,500,000 in four companies engaged in the development and commercialization of computer automation technology for the electric power industry.
