NOTICE TO READERS:

PAPER COPY DISSEMINATION OF SEC NEWS DIGEST TO BE DISCONTINUED

By the end of March, the Office of Public Affairs will complete its transition to electronic publication of the SEC News Digest. As a result, after March 29, 1996 paper copies of the Digest will no longer be mailed or made available at Headquarters for messenger pick-up. Instead, we will be publishing the Digest on the Commission's World Wide Web site and the FedWorld electronic bulletin board. On the Commission's Internet site, readers will also be able to access most litigation releases, administrative proceeding orders, rule proposals, final rules, Congressional testimony, speeches, press releases, special reports, the EDGAR database of corporate filings and other materials.

This change will provide current subscribers and the public at large with same-day access to the Digest and a broad range of documents and information. It will also enable us to devote more of our resources to expanding and improving the scope of our electronic information dissemination services. Overall we will be able to provide an increased volume of information on a more timely basis in a more accessible and useful form.

INVESTMENT COMPANY ACT RELEASES

DREYFUS MASSACHUSETTS MUNICIPAL MONEY MARKET FUND, ET AL.

A notice has been issued giving interested persons until April 15 to request a hearing on an application filed by Dreyfus Massachusetts Municipal Money Market Fund, et al. for an order under Section 6(c) of the Investment Company Act that would exempt applicants from Section 12(d)(1) of the Act, under Section 17(b) of the Act for an exemption from Section 17(a) of the Act, and under Section 17(d) of the Act and Rule 17d-1 thereunder permitting certain joint transactions. The order would permit the combination of one class of the Dreyfus/Laurel Massachusetts Tax-Free Money Fund (Transferring Fund) and the existing single class of the Dreyfus Massachusetts Municipal Money Market Fund (Acquiring Fund). The Transferring Fund thereafter would operate as a single class fund offering its other existing class of shares. (Rel. IC-21839 - March 21)

GNA VARIABLE INVESTMENT ACCOUNT, ET AL.

A notice has been issued giving interested persons until April 16 to request a hearing on an application filed by GNA Variable Investment Account (Account), and Great Northern Insured Annuity Corporation (GNA). Applicants seek an order pursuant to Section 26(b) of the Investment Company Act approving the substitution of certain securities held by the Account to fund variable annuity contracts issued by GNA. WITHDRAWAL SOUGHT

A notice has been issued giving interested persons until April 12 to comment on the application of Air-Cure Technologies, Inc. to withdraw from listing and registration on the <u>American Stock Exchange</u> its Common Stock, \$0.001 Par Value. (Rel. 34-37012)

PROPOSED RULE CHANGES

The Chicago Board Options Exchange filed a proposed rule change (SR-CBOE-96-10) to amend CBOE Rule 6.55, "Multiple Orders Prohibited," to provide that, except in accordance with procedures established by the appropriate Floor Procedure Committee, or with such Floor Procedure Committee's permission in individual cases, no market maker shall enter or be present in a trading crowd while a floor broker present in the trading crowd is holding an order on behalf of the market maker's individual account or an order initiated by the market maker for an account in which the market maker has an interest. Publication of the notice is expected in the Federal Register during the week of March 25. (Rel. 34-36996)

The <u>Philadelphia Stock Exchange</u> filed a proposed rule change (SR-Phlx-96-02) relating to the adoption of listing and listing maintenance standards for unit investment trusts. Publication of the proposal is expected in the <u>Federal Register</u> during the week of March 25. (Rel. 34-37002)

APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change filed by the <u>Philadelphia Stock Exchange</u> (SR-Phlx-95-77) and notice of filing and order granting accelerated approval to Amendment Nos. 1 and 2 to the proposed rule change relating to the rules of the Allocation, Evaluation and Securities Committee. (Rel. 34-36998)

The Commission has approved a proposed rule change (SR-PHLX-95-68) filed by the Philadelphia Stock Exchange which amends PHLX Rule 1101A, "Terms of Option Contracts," to incorporate new strike (exercise) prices for index options. Under the proposal, the exercise price interval for near-term index options generally will be \$5, except: (1) where the exercise price exceeds \$500, the exercise price interval may be \$10; and (2) where the exercise price exceeds \$1,000, the exercise price interval may be \$20. For out-of-the-money, far-term (fifth month), or long-term index option series, the proposal provides that the exercise price interval generally will be \$25, except: (1) where the exercise price exceeds \$500, the strike price interval may be \$50; and (2) where the exercise price exceeds \$1,000, the strike price interval may be \$100. Publication of the approval order is expected in the Federal Register during the week of March 25. (Rel. 34-37003)

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

The <u>National Association of Securities Dealers</u> filed a notice of filing and immediate effectiveness of a proposed rule change (SR-NASD-96-10) that would increase the position charge applied to be a broker-dealer that displays quotations or trading interest in the OTC Bulletin Board® Service. Publication of the notice of the proposed rule change in the <u>Federal Register</u> is expected March 25. (Rel. 34-37006)
