COMMISSION ANNOUNCEMENTS

PUBLIC COMMENT SOUGHT ON THE NEED FOR GREATER PROTECTION FOR SENIOR CITIZENS AND QUALIFIED RETIREMENT PLANS FROM SECURITIES FRAUD AND FRIVOLOUS LITIGATION

The Commission announced that it was seeking public comment to determine whether investors that are senior citizens or qualified retirement plans require greater protection against securities fraud than is currently provided under the federal securities laws; and whether investors that are senior citizens or qualified retirement plans have been adversely impacted by abusive or unnecessary securities fraud litigation, and whether the current provisions of the federal securities laws are sufficient to protect them from such litigation. The Commission is also soliciting comment on the more general question of the role of senior citizens and qualified retirement plans in our securities markets.

The request for comments is made in connection with the requirements of Section 106 on the Private Securities Litigation Reform Act of 1995, which directs the Commission to make these determinations and, if it determines that greater protections are necessary, submit a report to the Congress containing its recommendations by June 19, 1996.

ENFORCEMENT PROCEEDINGS

ADMINISTRATIVE PROCEEDINGS AGAINST JOHN AND LINDA DANKOVICH

The Commission today announced the entry of an Order Instituting Proceedings, Making Findings and Imposing Remedial Sanctions Pursuant to Section 15(b) of the Securities Exchange Act of 1934 (Order) against John and Linda Dankovich. Simultaneously with the institution of these proceedings, the Commission accepted the Dankoviches' Offers of Settlement, in which they consented, without admitting or denying the Commission's findings, to the issuance of the Order which bars them from association with any broker, dealer, investment company, investment adviser, or municipal securities dealer. The Order finds that from July 1994 through April 1995 the Dankoviches acted as broker-dealers within the meaning of Section 15(b) of the Securities Exchange Act of 1934, and that on March 22, 1996, the United States District Court for the District of Columbia entered a Final Judgment which permanently enjoined both Dankoviches from future violations of Section 17(a) of the Securities Act of 1933 and Sections 10(b), 15(a) and 15(c) of the Securities Exchange Act of 1934, and Rules 10b-5, 15b1-1 and 15c1-2 thereunder; and permanently enjoined John Dankovich from future violations of Sections 7(f) of the Exchange Act and Regulation X promulgated by the Board of Governors of the Federal Reserve System. The Final Judgment issued by the District Court also required the Dankoviches to jointly and severally disgorge \$51,653, representing \$47,841 in funds the Commission alleged in its Complaint were fraudulently obtained from investors by the Dankoviches, together with \$3,812 in prejudgment interest thereon. HOLDING COMPANY ACT RELEASES

SAVANNAH ELECTRIC AND POWER COMPANY

An order has been issued authorizing a proposal by Savannah Electric and Power Company (Savannah), an electric utility subsidiary of The Southern Company, a registered holding company. Savannah proposes to enter into arrangements with the Savannah Economic Development Authority for the issuance and sale its industrial development revenue bonds (Revenue Bonds) in an aggregate principal amount not exceeding \$7 million for payment of the costs of acquiring, constructing, installing and equipping facilities for off-loading coal from barges or ships for delivery to Savannah's Plant Kraft in Chatham County, Georgia. The Revenue Bonds will be issued and sold, and the related transactions will be consummated, no later than June 30, 1996. (Rel. 35-26499)

CONSOLIDATED NATURAL GAS COMPANY, ET AL.

An order has been issued authorizing Consolidated Natural Gas Company and its subsidiaries to engage in a five-year financing program. The program, which would extend through March, 31, 2001, would include external financing and interest rate swaps by financing and guarantees intrasystem Consolidated; Consolidated and its subsidiaries and between certain subsidiaries and their subsidiaries; proposed charter amendments by Consolidated and its subsidiaries to increase authorized capital, change the par value of common stock and/or create a new class of preferred stock; related proxy solicitation by Consolidated; acquisition of outstanding securities; and creation of financing subsidiaries by Consolidated and certain subsidiaries to facilitate issuance of securities. Jurisdiction was reserved over issuance of new types of securities by Consolidated and certain subsidiaries, equity swaps, and acquisition of securities by three utility subsidiaries of Consolidated.
