# TENTH EDGAR CONFERENCE SCHEDULED

An EDGAR Filer Conference has been scheduled for Monday, April 15, 1996. The conference will be held in the Jefferson Auditorium at the Department of Agriculture South Building at 14th Street and Independence Avenue S.W., in Washington D.C. At the conference, the SEC will present the status of EDGAR, a discussion of the EDGAR Rules, and a demonstration of the EDGARLink software. Although the Jefferson Auditorium can accommodate more people than the Commission Meeting Room used in previous conferences, space is limited to the number of seats in the facility (500). To reserve space, please register for the conference by calling (202) 942-8800 or leave a message on our request line (202) 942-8600. When you register, please give your name, your company, and your telephone number.

The conference will begin at 9:00 a.m. and is expected to end at about 5:00 p.m. Enter the facility by the Wing 4 entrance, which is in the middle of the Independence Avenue side of the building. The Wing 1 entrance is handicapped accessible. The guards will have the list of registered attendees, which will streamline the process of admitting you to this Government facility. You will need to bring a picture ID that was issued by a federal or state agency, such as a driver's license, to be admitted. Work IDs will not be accepted. You will be able to enter the Jefferson Auditorium, located approximately 100 yards to the right of the Wing 4 entrance guard's desk, at 8:00 a.m. For those conference attendees who arrive earlier than that time, the Department of Agriculture Cafeteria, located in Wing 3 of the facility, will be open.

It is recommended that you do not bring computer equipment, tape recorders, or portable telephones with you to the conference. If you do, you MUST register this equipment when you enter the Department of Agriculture Building by giving the guards the serial number, make, and model of the equipment and your name, business, and social security number. ### ENFORCEMENT PROCEEDINGS

COMPLAINT FILED AGAINST THE WINDGATE FUND, LLP, CM CAPITAL ASSOCIATES, INC., ROBERT MOSES AND DONALD MEYERS

The Commission announced the filing of a complaint in the United States District Court for the Southern District of New York against The Windgate Fund, LLC, CM Capital Management Associates, Inc., Robert Moses and Donald Meyers.

Jetlease/Finance Corporation (Jetlease). Jetlease is a Florida corporation, with its principal office in Fort Lauderdale, that is primarily involved in the business of leasing, and financing the sale of, used aircraft in the small and medium size range to corporations and individuals. Jetlease represented that money raised through the sale of promissory notes (Notes) was to provide the financial base from which borrowers could finance aircraft lease and purchases. Jetlease consented to the entry of the permanent injunction without admitting or denying the Commission's allegations.

The complaint alleges that from September 1992 until February 1996, Jetlease offered and sold the Notes to investors nationwide through newspaper advertisements and a network of contracting sales agents. According to the complaint, Jetlease fraudulently raised at least \$19 million through the sale of the Notes to at least 460 investors The Commission alleges that, among other in numerous states. things, Jetlease falsely represented in the offering materials that the funds of each investor were to be fully collateralized and secured by first liens on aircraft filed and recorded with the Federal Aviation Administration. In fact, however, only approximately \$3 million of the \$19 million in outstanding Notes were so secured. The remaining investor notes are unsecured. complaint also alleges that Jetlease violated the registration provisions of the federal securities laws in connection with this offering. [SEC v. # HARCOURT WILTSHIRE CHARGED WITH FRAUD

The Commission, the United States Attorney for the Southern District of Florida, the U.S. Postal Inspection Service, the Federal Bureau of Investigation, and the Internal Revenue Service Criminal Investigation Division announced that an Information was filed on March 25, 1996, charging Harcourt Wiltshire (Wiltshire) with conspiring to commit securities fraud; mail fraud; and wire fraud.

The Information alleges that during the period July 1993 to February 1995, Wiltshire was employed by an individual who held himself out to be a stock promoter, who maintained offices in Boca Raton and Pompano Beach, Florida. The promoter was retained by numerous public companies, with shares traded on NASDAQ and/or the OTC Bulletin Board, to assist them in promoting their stocks. The Information further alleges that Wiltshire and the stock promoter made agreements with register representatives whereby the representatives, in exchange for monetary payoffs from Wiltshire and the promoter, agreed to induce their clients to buy the promoted stocks.

Wiltshire is scheduled to plead guilty on April 5, 1996. [U.S. v. Wiltshire, Case No. 96-6041-CR-ROETTGER, SD Fla.] (LR-14868)

# INVESTMENT COMPANY ACT RELEASES

TWENTIETH CENTURY BLENDED PORTFOLIOS, INC., ET AL.

An order has been issued under Sections 6(c) and 17(b) of the Investment Company Act exempting Twentieth Century Blended Portfolios et al. from Section 12(d)(1) and 17(a) of the Act. The order permits Blended Portfolios to implement a "fund of funds" arrangement and acquire up to 100% of the voting shares of any Twentieth Century fund. (Rel. IC-21875 - April 8)
