COMMISSION ANNOUNCEMENTS

EDGAR PHASE-IN COMPLETE MAY 6, 1996

The Division of Corporation' Finance wishes to remind all domestic registrants whose filings are subject to its review that the phase-in to mandated electronic filing on the Commission's Electronic Data Gathering, Analysis, and Retrieval (EDGAR) system is complete today, May 6, 1996. Beginning today, all domestic registrants not previously phased in, and third parties filing with respect to such registrants, become subject to mandated electronic filing requirements, as outlined in Regulation S-T (17 CFR Part 232). This applies to companies assigned to Group CF-10, as well as to those that previously have not been assigned a phase-in group. Beginning today, registration statements for initial public offerings filed at the Commission's headquarters also must be filed electronically. (All filings made at one of the Commission's regional offices will continue to be made in paper.)

Once a company is a mandated electronic filer, all filings made with respect to it by third parties (for example, Schedules 13D and 13G) must be made electronically. Persons filing Forms 3, 4 and 5 pursuant to Section 16 of the Securities Exchange Act of 1934, and those filing Forms 144 pursuant to Rule 144 of the Securities Act of 1933, may file these documents in paper or electronic format, since electronic filing of these forms will continue to be optional after today.

Foreign private issuers and foreign governments will not be required to file electronically (unless acting as a third party filer with respect to an electronic domestic company or engaging in a business transaction with a phased-in domestic company), but they may choose to do so. Such entities can gain access to the EDGAR system by filing a Form ID to receive EDGAR access and identification codes. EDGAR currently recognizes many of the types of forms that may be filed by foreign registrants, but some form types, such as those associated with the multijurisdictional disclosure system, are not yet available; as a consequence, filings not supported by EDGAR must be made in paper. The EDGAR system will be enhanced in the future to allow electronic filing of these documents.

As is true with all rules promulgated by the Commission, persons making filings with the Commission are responsible for apprising themselves of their new obligations associated with filing on the EDGAR system. While the Commission has attempted to contact registrants in this last phase-in group by furnishing a copy of the current version of the EDGAR Filer Manual and EDGARLink software (with mailing having taken place the week of March 11), registrants will not be relieved of their electronic filing obligations in the absence of such notification. ENFORCEMENT PROCEEDINGS

TRADING SUSPENDED IN THE SECURITIES OF LANSTAR SEMICONDUCTOR, INC.

The Commission announced the single ten-day suspension of over-thecounter trading in the securities of Lanstar Semiconductor, Inc. for the period beginning at 9:30 a.m. (EDT) on May 6, 1996 and terminating at 11:59 p.m. (EDT) on May 17, 1996.

The Commission suspended trading in Lanstar Semiconductor, Inc. securities because of questions concerning, among other things, unusual market activity and the tradeability of shares. (Rel. 34-37166)

ADMINISTRATIVE PROCEEDINGS INSTITUTED, FINDINGS MADE AND SANCTIONS IMPOSED AGAINST STEPHEN KNEPP AND LAWRENCE HARTZ

The Commission has issued an Order Instituting Public Administrative Proceedings Pursuant to Sections 15(b) and 19(h) of the Securities Exchange Act of 1934 (Exchange Act), Making Findings and Imposing Remedial Sanctions (Order) against Stephen S. Knepp (Knepp) of Pottstown, Pennsylvania and Lawrence R. Hartz (Hartz) of St. Petersburg, Florida. Knepp was associated as a registered representative with Chubb Securities Corp., a registered brokerdealer, and as an area vice-president and sales agent with Premier

Financial Services, Inc. (Premier Financial), an unregistered broker-dealer. Hartz was associated as a regional vice-president and sales agent with Premier Financial. The Respondents submitted, and the Commission accepted, Offers of Settlement whereby they consented, without admitting or denying, to the entry of this Order. The Order finds that from March 1993 through June 1993, Knepp willfully violated the registration and antifraud provisions, in that, in connection with the unregistered offer and sale to the public of certificates issued by Premier Benefit Capital Trust (PBCT), Knepp misrepresented and omitted material facts regarding PBCT, its operations, and the risks involved in the investment. The Order also finds that on October 17, 1995, a final judgment of permanent injunction was entered against Hartz in the U.S. District Court for the Middle District of Florida, permanently enjoining him from further violations of the registration and antifraud provisions. The Commission, based upon the findings and the Respondents' consents, permanently barred Knepp and barred Hartz with a right to re-apply after three years, from association with any broker, dealer, municipal securities dealer, investment company or investment adviser. COMPLAINT FILED AGAINST SEVEN DEFENDANTS IN ANGEION CORPORATION MARKET MANIPULATION

On May 2nd, the Commission filed a Complaint for Permanent Injunction and Other Equitable Relief (complaint) in the United States District Court for the District of Minnesota against (McMichael), Robert Defendants Steven McMichael J. Maietta (Maietta), Edward C. Farni (Farni), Arthur J. Petrie (Petrie), Douglas C. Selander (Selander), Dale E. Barlage (Barlage) and The complaint alleges that the Stephen D. Gellas (Gellas). Defendants violated Section 17(a) of the Securities Act of 1933 (Securities Act), Section 10(b) of the Securities Exchange Act of 1934 (Exchange Act) and Rule 10b-5 promulgated thereunder. In addition, the complaint alleges that Maietta, Petrie, Selander and Gellas violated Section 7(f) of the Exchange Act and Section 3(b) of Regulation X promulgated by the Board of Governors of the Federal Reserve System.

In its complaint, the Commission alleges that from about 1989 until June 1991, the Defendants engaged in a fraudulent scheme involving the common stock of Angeion Corporation (Angeion) which was designed to create the appearance of activity in Angeion stock. To do so, the Defendants employed various manipulative devices, including matched trades, wash trades and stock parking. As the scheme began to unravel, several Defendants also engaged in free-riding. After the manipulative activities ceased, the stock price of Angeion fell from a high of \$10 3/8 in March 1991, to a low of \$2 3/4 in July 1991. Direct further inquiries to Jane E. INVESTMENT COMPANY ACT RELEASES

INDIGO GROUP, LTD., ET AL.

A notice has been issued giving interested persons until May 28 to request a hearing on an application filed by Indigo Group, Ltd., et al. for an order under Section 17(b) of the Investment Company Act for an exemption from Section 17(a)(2) of the Act. The order would permit an affiliated person of an affiliated person of Baker, Fentress & Company (Baker Fentress), a closed-end investment company, to purchase a strip shopping center from a company controlled by Baker Fentress. PIERRE FUNDING CORPORATION

A notice has been issued giving interested persons until May 27 to request a hearing on an application filed by Pierre Funding Corporation for an order under Section 8(f) of the Investment Company Act declaring that applicant has ceased to be an investment company. (Rel. IC-21936 - May 2)

SELF-REGULATORY ORGANIZATIONS

PROPOSED RULE CHANGE

The <u>American Stock Exchange</u> filed a proposed rule change (SR-Amex-96-10) to amend Amex Rules 60 and 220 and to adopt a policy regarding the use of wireless data communications devices at the Exchange. Publication of the proposal is expected in the <u>Federal</u> <u>Register</u> during the week of May 6. (Rel. 34-37161)

APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change filed by the <u>National</u> <u>Securities Clearing Corporation</u> (SR-NSCC-96-01). The rule change amends NSCC rules to establish systemized, standard default prices for assets that are not eligible for the Continuous Net Settlement system submitted by a member for transfer through the Automated Customer Account Transfer Service. (Rel. 34-37162)

The Commission approved a proposed rule change filed by the <u>National</u> <u>Association of Securities Dealers</u> (SR-NASD-96-09). The rule change amends Part II of Schedule D to the NASD By-Laws to recommend that Nasdaq issuers distribute interim reports to all beneficial shareholders if they send such reports to any registered shareholders and to encourage Nasdaq issuers to consider additional technological methods to communicate such information to shareholders in a timely and less costly manner as such technology becomes available.
