#### INVESTMENT COMPANY ACT RELEASES

## NATIONAL EQUITY TRUST

An order has been issued on an application filed by National Equity Trust under Section 6(c) of the Investment Company Act for an exemption from Section 12(d)(3) of the Act. The order permits any series of applicant to invest up to 10% of its assets in securities of an issuer that derives more than 15% of its gross revenues in its most recent fiscal year from securities related activities. (Rel. IC-22019 - June 17)

#### FIRST FUNDS AND FIRST TENNESSEE BANK NATIONAL ASSOCIATION

A notice has been issued giving interested persons until July 12 to request a hearing on an application filed by FIRST FUNDS and First Tennessee Bank National Association for an order under Sections 6(c), 10(f) and 17(b) of the Investment Company Act from the provisions of Sections 10(f) and 17(a) of the Act. The order would permit certain portfolios of FIRST FUNDS to purchase Tennessee taxexempt securities from the Bond Division of First Tennessee Bank National Association when such securities are underwritten solely by the Bond Division or when the Bond Division is a member of an underwriting syndicate, and from a syndicate manager when such securities are designated as group sales. The order also would permit the portfolios to purchase Tennessee tax-exempt securities under Rule 10f-3 in amounts up to the greater of 10% or \$1,000,000, but in no event more than 15%, of a class of an issue, and from an underwriting syndicate of which the Bond Division is a member without limiting the consideration paid by a Portfolio in any one offering. # GEORGE K. BAUM EMPLOYEE EQUITY FUND, L.P.

A notice has been issued giving interested persons until July 12 to request a hearing on an application filed by George K. Baum Employee Equity Fund, L.P. for an order under Sections 6(b) and 6(e) of the Investment Company Act to exempt the Fund from all provisions of the Act and the rules and regulations thereunder except Section 9, certain provisions of Sections 17 and 30, and Sections 36 through 53. The Fund is an employees' securities company within the meaning of Section 2(a)(13) of the Act. (Rel. IC-22021 - June 17)

## FRANKLIN TEMPLETON FUND MANAGER, ET AL.

An order has been issued on an application filed by Franklin Templeton Fund Manager, et al. under Section 6(c) of the Investment Company Act exempting applicants from Section 12(d)(1) of the Act, and under Sections 6(c) and 17(b) of the Act exempting applicants from Section 17(a) of the Act. The order permits series of the Franklin Templeton Fund Manager, which will be registered under the Act as an open-end management investment company, to invest substantially all of their assets in a combination of Franklin Funds and Templeton Funds in excess of the percentage limitations of Section 12(d)(1).
