COMMISSION ANNOUNCEMENTS

CHANGE IN MEETINGS: CANCELLATIONS

The open meeting scheduled for Wednesday, May 29, 1996, at 3:00 p.m., and the closed meeting scheduled for Tuesday, July 2, 1996, at 10:00 a.m., were cancelled.

ENFORCEMENT PROCEEDINGS

COMPLAINT FILED AGAINST MOBILE SERVICES INTERNATIONAL CORP., AND ITS FORMER OFFICERS AND DIRECTORS

The Commission announced that on July 3 it filed a complaint seeking injunctive relief against Mobile Services International, Corp. (now known as International Communications & Technologies, Corp.)(Mobile Services) and injunctive relief as well as civil penalties against James C. Cobban (Cobban), its former chairman and president, James M. Robinson (Robinson) its former chief executive officer, secretary and director, and Jonathan D. Bennett (Bennett), its former vicepresident of marketing and director.

The complaint alleges that Mobile Services made false filings with the Commission during its fiscal years 1993 and 1994. Specifically, the complaint alleges that Mobile Services valued certain franchise rights as exceeding \$4 million, when, in truth, these franchise rights were worthless. The allegedly overvalued assets represented over 80 percent of Mobile Services' assets. The complaint alleges that Cobban, Robinson and Bennett knew that the franchisor was defunct, with the result that the franchise rights were materially impaired when the filings were made.

Based on the above, the Commission alleges violations by Mobile Services of Sections 10(b), 13(a) and 13(b)(2)(A) of the Securities Exchange Act of 1934 (Exchange Act) and Rules 10b-5, 12b-20, 13a-1 and 13a-13, thereunder, violations by Cobban and Robinson of Section 10(b) of the Exchange Act and Rules 10b-5 and 13b2-2 thereunder, and violations by Bennett of Section 10(b) of the Exchange Act and Rule 10b-5, thereunder. CIVIL ACTION AGAINST HARVEY TABB

The Commission today announced the filing of a motion in the above action seeking an order adjudging all five defendants in the action in civil contempt. The Commission's Motion alleges that defendants are continuing to offer and sell unregistered securities in violation of the registration provisions of the federal securities laws. Defendants' conduct violates the Court's Order of Permanent Injunction, entered on October 4, 1995, which permanently enjoined the defendants from future violations of the registration and antifraud provisions of the federal securities laws. The Commission's motion seeks the imposition of daily fines until the five defendants have demonstrated that they are in full compliance with the Order of Permanent Injunction.

As discussed in Litigation Release No. 14671, October 2, 1995, this action involves the alleged fraudulent offer and sale of a series of unregistered limited and general partnership interests by the defendants. In its Complaint, the Commission sought a permanent injunction against the defendants, accountings, disgorgement plus prejudgment interest and civil penalties. [SEC v. Harvey P. SHIMON GIBORI PERMANENTLY BARRED

The Commission announced that the U.S. District Court for the District of Columbia has entered a final judgment against Shimon Gibori enjoining him from violating the federal securities laws and permanently prohibiting him from serving as an officer or director of any publicly held company. In its amended complaint, the Commission alleged that from 1988 to 1990, Gibori, the founder and former chief executive officer and president of the now-defunct Gil-Med Industries, Inc., created and sold, without registration, approximately 2,000,000 shares of counterfeit common stock of Gil-Med and, in many cases, recorded the proceeds from the sales of those securities as revenues from the company's operations. As a result, the Commission alleged that Gibori violated the antifraud provisions of the federal securities laws. The amended complaint also alleged that Gibori created false documents to account for the issuance and sales of that stock. Gil-Med, a small Illinois-based manufacturer and distributor of plastic medical products, collapsed in early 1991. [SEC v. INJUNCTIVE ACTION FILED AGAINST FENCHURCH CAPITAL MANAGEMENT, LTD.

The Commission today announced the filing of a complaint in U.S. District Court for the Northern District of Illinois against Fenchurch Capital Management, Ltd., a commodity trading advisor and

pool operator. The complaint alleged that Fenchurch deliberately misled counterparties in repo transactions to believe that it held a short position in the June 1993 10-year U.S. Treasury note futures contract (June contract) in order to secure agreements from them not to relend to the repo market the cheapest-to-deliver U.S. Treasury security under that contract. According to the complaint, Fenchurch in fact held a substantial long position in the June contract. Through the activities alleged in the complaint, Fenchurch removed from the market a significant quantity of the cheapest-to-deliver security and profited by receiving a more valuable security in satisfaction of delivery obligations under the June contract.

Without admitting or denying the allegations of the complaint, Fenchurch consented to the entry of a final judgment enjoining it from violating the antifraud provisions of the Exchange Act and ordering it to pay \$600,000, representing disgorgement, prejudgment interest and a civil penalty. The same \$600,000 also satisfies Fenchurch's payment obligation under a settled order issued today by the CFTC. [SEC v. Fenchurch Capital Management, Ltd., N.D. INVESTMENT COMPANY ACT RELEASES

NORWEST BANK MINNESOTA, N.A., ET AL.

A notice has been issued giving interested persons until August 5 to request a hearing on an application filed by Norwest Bank Minnesota, N.A., et al. for an order under Section 6(c) of the Investment Company Act for an exemption from Section 12(d)(1) of the Act, and under Sections 6(c) and 17(b) of the Act for an exemption from Section 17(a) of the Act. The order would supersede a prior order and would permit Norwest Advantage Funds to invest any percentage of their assets in an underlying Core Trust (Delaware) portfolio or in direct investments. It also would remove certain restrictions currently imposed on the Core Trust (Delaware) portfolios to permit them to accept investments from persons other than Norwest Advantage Funds. (Rel.
