COMMISSION ANNOUNCEMENTS

TEMPORARY CHANGE IN OFFICE HOURS FOR ATLANTA DISTRICT OFFICE

Effective Friday, July 12, 1996, through Friday, August 9, 1996, the official business hours for the Atlanta District Office will be changed from 9:00 a.m. - 5:30 p.m. to 7:30 a.m. - 4:00 p.m. (EST). This temporary change is made in cooperation with the City of Atlanta to minimize transportation difficulties for the staff during the period surrounding the Summer Olympic Games.

On Monday, August 12, 1996, official business hours for the Atlanta District Office will return to 9:00 a.m. - 5:30 p.m. (EST).

SEC TO HOST ANNUAL GOVERNMENT BUSINESS FORUM

The Commission today announced that the Fifteenth Annual Government Business Forum on Small Business Capital Formation will be held on Thursday, September 26, and Friday, September 27, 1996 in Washington, D.C. at the Hyatt Regency Washington on Capitol Hill.

This year's Forum will focus on taxation, credit and securities regulations. The sessions will be comprised of two parts, following a basic format which has been utilized in recent years. The morning sessions will offer a variety of round-table discussions, each devoted to one of the three targeted topics. The remainder of each morning and the afternoon sessions will be devoted to discussion in small interactive break-out groups in order to permit Forum participants sufficient time to develop thoughtful recommendations.

RULES AND RELATED MATTERS

AMENDMENTS TO FORM BD ADOPTED AND AMENDMENTS TO FORM BDW PROPOSED

On July 12, the Commission adopted amendments to Form BD, the uniform broker-dealer registration form under the Securities The primary purpose of the Exchange Act of 1934 (Exchange Act). amendments to Form BD is to implement recommended changes to the Central Registration Depository (CRD), a computer system operated by the National Association of Securities Dealers, Inc. that maintains registration information regarding broker-dealers and registered personnel. Specifically, the amendments are intended to facilitate retrieval of broker-dealer registration and disciplinary information through the redesigned CRD system by eliciting more precise disclosure and by reorganizing disciplinary items into related categories. The amendments to Form BD also include certain clarifying amendments, including instructions for filing Form BD electronically with the CRD.

In a related action, the Commission is proposing for comment amendments to Form BDW, the uniform request for withdrawal from broker-dealer registration under the Exchange Act. These proposed amendments also are intended to implement recommended changes to the CRD system and contain certain clarifying amendments to Form BD and its filing requirements. Together with proposed amendments to Form BDW, the Commission is publishing for comment proposed amendments to rules governing the withdrawal from broker-dealer registration under the Exchange Act. These proposed amendments would permit brokerdealers that are withdrawing from registration to consent to an extension of the effective date of their withdrawal, and would permit the Commission to extend the effective date for such period as the Commission by order may determine. The Commission also is publishing for comment proposed revisions to Exchange Act rules governing the filing of Form BD and Form BDW to provide for electronic filing of these forms and to accommodate the conversion of existing registration information to the redesigned CRD system. ENFORCEMENT PROCEEDINGS

CIVIL INJUNCTIVE ACTION FILED AND SIMULTANEOUSLY SETTLED AGAINST RICHARD JENKINS

On July 10, the Commission filed a complaint against Richard Jenkins of San Diego, California, alleging that Jenkins misrepresented or failed to disclose to investors that Marada had exclusive agreements with Caribbean nations to develop an airline, casinos and hotels when it had no such agreements; that Marada stock was being sold by Marada "vice presidents" who were, in reality, telemarketers earning

40% commissions; that Marada would apply for listing on NASDAQ when it was practically impossible for Marada to obtain such a listing; the cumulative disciplinary history of key Marada personnel; and, that the only substantial Marada "asset" was not owned free-and-clear. According to the complaint, from at least August 1993 through September 1994, over 200 investors nationwide were defrauded of nearly \$2 million.

The Commission seeks to enjoin Jenkins from future violations of Sections 5(a), 5(c) and 17(a) of the Securities Act of 1933, Sections 10(b), 15(a)(1) and 15(g) of the Exchange Act, and Rules 10b-5, 15g-2, 15g-4, 15g-5 and 15g-9, and also seeks disgorgement, civil money penalties and other ancillary relief. Prior to the filing of the complaint, Jenkins consented to a permanent injunction. [SEC v. Richard Jenkins, Case No. 96-1347-CIV-T-23C, M.D. Fla.] (LR-14980)

GOLDEN AMERICAN LIFE INSURANCE COMPANY, ET AL.

A notice has been issued giving interested persons until August 5 to request a hearing on an application filed by Golden American Life Insurance Company, Separate Account B of Golden American Life Insurance Company, Separate Account D of Golden American Life Insurance Company, The GCG Trust, and Directed Services, Inc. (collectively, Applicants). Applicants request an order under Sections 6(c) and 17(b) of the Investment Company Act, exempting them from Section 17(a) of Act, and under Sections 6(c) and 17(d) of the Act, and Rule 17d-1 thereunder, permitting certain transactions related to a reorganization. THE MINNESOTA MUTUAL LIFE INSURANCE COMPANY, ET AL.

A notice has been issued giving interested persons until August 5 to request a hearing on an application filed by The Minnesota Mutual Life Insurance Company (Minnesota Mutual), Minnesota Mutual Variable Life Separate Account (Account) and MIMLIC Sales Corporation (MIMLIC Sales) (collectively, Applicants). Applicants seek an order pursuant to Section 6(c) of the Investment Company Act, granting exemptions from Sections 2(a)(35), 22(c), 22(d), 22(e), 26(a), 27(a), 27(c), 27(d) and 27(f) of the Act and from Rules 6e-2(b)(1), (b) (12) (i), (b) (13) (i), (b) (13) (ii), (b) (13) (iii), (b) (13) (viii), (c) (1) and (c) (4), 22c-1 and 27f-1 thereunder. order would permit the offer and sale of certain scheduled premium variable life insurance policies (Policies) that provide for a cash option death benefit; a scheduled decrease in the initial face amount and the subsequent adjustment of Policies to a face amount less than the initial face amount; deduction of cost of insurance exceed the charges derived from the to Commissioners Standard Ordinary Mortality Table for purposes of calculating sales load; deduction of a federal tax charge; the

anticipated joint life expectancy of the insureds to be determined on the basis of the 1980 Commissioners Standard Ordinary Mortality Table for purposes of calculating the period over which sales load may not exceed 9 percent; assessment of a new first year sales load upon a policy adjustment involving an increase in base premium, which sales load may be in addition to a first year sales load being taken at the time the adjustment is made; increases in the proportionate amount of sales load deducted from premiums following certain policy adjustments or the payment of nonrepeating premiums; deduction from Account assets of the proposed charges for the cost of insurance and the face amount guarantee; a right to convert to a fixed benefit adjustable life insurance policy with a death benefit equal to the policy;s then current face amount and with a plan of insurance which may be less than for the whole of life; and, personal delivery to policy owners of free-look right notices which contain information comparable to that required by Form N-27I-2. The requested relief also would, pursuant to Section 11 of the Act; approve an exchange offer. The relief requested would extend to any variable life insurance policies that may be offered in the future that are substantially similar in all material respects to the Policies (Future Policies) that are funded by the Account or any other separate accounts established in the future by Minnesota Mutual and that may be offered by MIMLIC Sales or any other members of the National Association of Securities Dealers, Inc. that may in the future serve as principal underwriters of the Policies or Future Policies. GREAT-WEST LIFE & ANNUITY INSURANCE COMPANY, ET AL.

A notice has been issued giving interested persons until August 5 to request a hearing on an application filed by Great-West Life & Annuity Insurance Company (Great West), Variable Annuity-1 Series Account (Separate Account), and Charles Schwab & Company, Inc. (Applicants). Applicants seek an order pursuant to Section 6(c) of the Investment Company Act granting exemptions from the provisions of Sections 26(a)(2)(C) and 27(c)(2) of the Act to the extent necessary to permit the deduction of a mortality and expense risk charge from the assets of the Separate Account in connection with the issuance and sale of certain variable annuity contracts (Contracts). Exemptive relief also is requested to the extent necessary to permit the deduction of a mortality and expense risk charge from the assets of any other separate account established in of variable annuity contracts that are substantially similar in all material respects to the Contracts. SELF-REGULATORY ORGANIZATIONS

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change (SR-CBOE-96-02) filed by the <u>Chicago Board Options Exchange</u> to limit the liability of the Exchange and its directors, officers, employees, and agents, to preclude certain types of legal actions by members against such persons, and to require members to pay the Exchange's costs of litigation under specified circumstances. The Commission is granting accelerated approval to a proposed rule change (SR-NASD-96-20) filed by the <u>National Association of Securities Dealers</u> for a period of 120 days. The rule change amends the NASD's By-Laws. (Rel. 34-37424)
