ENFORCEMENT PROCEEDINGS

FORMER SCHNEIDER SECURITIES, INC. REGISTERED REPRESENTATIVE AND STAT-TECH INTERNATIONAL CONSULTANT SETTLES SECTION 5 CHARGES

The Commission announced that it has accepted an Offer to settle administrative proceedings against Rodger E. Thornton. The Commission made findings that Thornton, a resident of Colorado Springs, Colorado, was a registered representative for Schneider Securities, Inc. from about 1988 to about October 1991. Thornton was employed as a consultant by Stat-Tech International Corp. during about November and December 1991. From in or about October 1991 through November 1991, Thornton willfully violated Sections 5(a) and 5(c) of the Securities Act by selling common stock of Stat-Tech when no registration statement was filed or in effect as to those The Commission has ordered that Thornton be suspended securities. from associating with any broker, dealer, municipal securities dealer, investment company or investment adviser for a period of six months and cease and desist from committing or causing any violations or future violations of Sections 5(a) and 5(c) of the Securities Act. COMMISSION GRANTED PERMANENT INJUNCTION, DISGORGEMENT, PREJUDGMENT INTEREST AND A TRIPLE PENALTY ON ITS PARTIAL SUMMARY JUDGMENT MOTION AGAINST MICHAEL LEVINE

The Commission announced that on July 30 a federal judge awarded a \$221,172.63 penalty, the maximum available under the Insider Trading and Securities Fraud Enforcement Act of 1988, against defendant Michael Levine (Levine). The court found that Levine, 48, purchased (DeSoto) stock in violation of the tender offer DeSoto, Inc. antifraud provisions of the federal securities laws. Levine purchased this stock on November 9, 1989, the day that Sutton Holding Corp. announced its intention to commence a tender offer for granted the DeSoto. Besides the penalty, the court also Commission's request that Levine be permanently enjoined from violating Section 14(e) of the Securities Exchange Act of 1934 and Rule 14e-3 and be ordered to disgorge his illegal trading profits of \$73,724.21 plus prejudgment interest. The court granted this relief following the Commission's motion for partial summary judgment.

The court, finding that genuine issues of material fact exist, declined to grant summary judgment on the Commission's claims that Levine also violated Section 14(e) of the Exchange Act and Rule 14e-3 when he purchased DeSoto stock in October 1989, and when he communicated material, nonpublic information to David P. Schwartz (Schwartz) on November 8 or 9, 1989, under circumstances in which it was reasonably foreseeable that Schwartz would communicate that information to Edward A. Cantor (Cantor), who then purchased DeSoto stock. These claims remain for trial, as does the Commission's claim that Levine violated Section 10(b) of the Exchange Act and Rule 10b-5 by purchasing DeSoto stock in October and November 1989.

Cantor and Schwartz previously settled the action against them. For further information see Litigation Release Nos. 14329, 14678, and 14769. [SEC v. Cantor, 94 Civ. 8079, JGK, SDNY] (LR-14997)

PRIME BANK INSTRUMENT FRAUD CONVICTIONS

The Commission and the U.S. Attorney's Office for the Northern District of Illinois announced that on July 26 Joseph Polichemi, Lyle Neal, Oscar Olson and Charles Padilla were convicted for their involvement in "Prime Bank Instrument" frauds, including the Konex Roll Program, the subject of an action previously brought by the Commission against Polichemi, Neal, Olson and others for violations the antifraud provisions of the federal securities laws. of Specifically, Polichemi and Neal were convicted of wire fraud, conspiracy and money laundering, Padilla was convicted of wire fraud and Olson was convicted of money laundering. In addition, Neal and Padilla were convicted of perjury in connection with the Commission's investigation concerning the Konex Roll Program. Larry Oesterman and Edward Russey earlier pleaded guilty to charges relating to this scheme. John DeVincens was acquitted of all charges against him.

The Commission's complaint alleged that from January 1993 to June 1994 Neal's company raised at least \$12.5 million through the offer and sale of investments in the Konex Roll Program. In connection with that offering, Polichemi, Neal, Olson and others made false and misleading statements concerning the use of investor proceeds and the risks and returns associated with the investment. APPROVAL OF PROPOSED RULE CHANGE

The <u>Chicago Board Options Exchange</u> filed with the Commission Amendment No. 2 to a proposed rule change (SR-CBOE-96-01) which will increase the SPX position and exercise limits, increase the SPX firm facilitation, index hedge, and money managers exemptions, and extend the broad-based index hedge exemption to broker-dealers. Publication of the notice is expected in the <u>Federal Register</u> during the week of August 5. (Rel. 34-37504)

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission is approving, on an accelerated basis, a proposed rule change (SR-CBOE-96-53) filed by the <u>Chicago Board Options</u> <u>Exchange</u> to extend for an additional 15-day period a pilot test of a system that monitors news announcements pertaining to underlying securities after the close of trading in the primary market for the underlying securities, and automatically suspends the Exchange's automatic execution system in respect of options on those securities that are the subject of such announcements. Publication of the notice is expected in the <u>Federal Register</u> during the week of August 5. (Rel. 34-37505)

The <u>New York Stock Exchange</u> filed and requested accelerated approval of a proposed rule change (SR-NYSE-96-18) that would extend its pilot for the entry of LOC orders until July 31, 1997. Publication of the proposal is expected in the <u>Federal Register</u> during the week of August 5. (Rel. 34-37507)
