### **ENFORCEMENT PROCEEDINGS**

PROCEEDINGS INSTITUTED AGAINST CARMEL EQUITY PARTNERS, RICHARD GOODRICH, LAWRENCE ISEN, PETER KIM, BRUCE MESNEKOFF, JOHN MORRIS AND KELSEY VAN DEVENTER

The Commission announced that it has instituted cease and desist and public administrative proceedings pursuant to Section 8A of the Securities Act of 1933 (Securities Act) and Sections 15(b), 19(h) and 21C of the Securities Exchange Act of 1934 (Exchange Act) against Carmel Equity Partners (Carmel), Richard L. (Goodrich), Lawrence D. Isen (Isen), Peter P. Kim (Kim), Bruce E. Mesnekoff (Mesnekoff), John B. Morris (Morris), and Kelsey Van Deventer (Van Deventer). The Order Instituting Proceedings charges that Isen, Kim, Mesnekoff, Morris (individually and through Carmel) and Van Deventer, while registered representatives of a California branch office of Cohig & Associates, Inc., a broker-dealer firm based in Colorado, received undisclosed compensation to recommend the common stock of Eagle Holdings, Inc. in violation of antifraud provisions of the Securities Act and the Exchange Act. also charges that Goodrich, through accounts in the name of Colton Ventures, Inc., aided and abetted these violations by transferring monies he knew or was reckless in not knowing were undisclosed compensation to the above respondents. A hearing will be scheduled to determine if the staff's allegations are true and, if so, whether cease and desist orders, penalties, disgorgement and remedial sanctions are appropriate against the respondents. NOTICE OF FILING OF PROPOSED PLAN OF DISGORGEMENT IN CONNECTION WITH INVESTMENT ADVISER WHO FAILED TO DISCLOSE UNFAIR ALLOCATION PRACTICES

The Commission has published a Notice that the Division of Enforcement has filed a proposed Disgorgement Plan to distribute \$224,683 in advisory fees and \$35,974 in prejudgment interest paid by McKenzie Walker Investment Management, Inc. (McKenzie Walker), a registered investment adviser, pursuant to a settlement order entered by the Commission on July 16, 1996.

The disgorgement figure represents ill-gotten gains received by McKenzie Walker in connection with its undisclosed practice of favoring clients which paid a fee based on an account's performance (performance-based fee) with profitable equity trades while

disfavoring clients which paid a fee based on assets under management (asset-based fee) and allocating a substantially disproportionate share of lucrative initial public offerings to performance-based fee clients. The proposed Plan would distribute the funds to McKenzie Walker's asset-based fee clients.

## INVESTMENT COMPANY ACT RELEASES

## FIRST TRUST SPECIAL SITUATIONS TRUST AND NIKE SECURITIES L.P.

An order has been issued on an application filed by First Trust Special Situations Trust and Nike Securities L.P. under Section 6(c) of the Investment Company Act for an exemption from Section 12(d)(1)(F)(ii) of the Act. An order has been issued on an application filed by Van Kampen American Capital Equity Opportunity Trust (Trust), et al., under Section 6(c) of the Investment Company Act for an exemption from Section 12(d)(1)(F)(ii) of the Act. #### JOHN HANCOCK TAX-EXEMPT INCOME FUND

# FREMONT MUTUAL FUNDS, INC., ET AL.

A notice has been issued giving interested persons until December 13 to request a hearing on an application filed by Fremont Mutual Funds, Inc. (Company) and Fremont Investment Advisors, Inc. for an order under Section 6(c) of the Investment Company Act to exempt applicants from Section 15(a) of the Act and Rule 18f-2 thereunder. The order would permit subadvisers approved by the Company's board of directors to serve as portfolio managers (Managers) for the Company's series of shares without obtaining shareholder approval of the agreements with the Managers.
