ENFORCEMENT PROCEEDINGS

SEC v. JOSEPH BREMONT, JIMMY SANCHEZ, COMCAR INTERNATIONAL, LTD., COMMERCIAL CAPITAL RESOURCES, INC., LOOMIS LTD., MICHAEL SPECTOR AND R.P.S. FINANCIAL GROUP, INC.

On November 21, the Commission filed an action against Joseph A. Bremont, a resident of Ocala, Florida; Comcar International, Ltd., a Bahamian company; Commercial Capital Resources, Inc., a Florida corporation; and Jimmy B. Sanchez, a resident of Texas, in the United States District Court for the Southern District of New York. The Commission alleges that since 1993, Bremont, Sanchez, Comcar and Commercial Capital defrauded investors of over \$2.1 million through a fraudulent "prime bank" securities scheme. The investor losses alleged by the Commission include: the loss in May 1994 of \$250,000 pooled by a group of twenty West Point cadets; the loss in July 1993 of \$150,000 pooled by investors through an entity called Pegasus Enterprises, Inc.; the loss during 1994 of a total of \$1,375 million by various investors who dealt with the proposed defendants through a company named Call Indiana of Delaware, Inc.; and the loss in June 1995 of \$350,000 paid by a company called Pro Vantage One International, LLC.

According to the Commission's complaint, the defendants promised investors returns of up to 2000% on investments of \$100,000 to \$400,000. Defendants claimed that the money would be used to facilitate transactions "prime bank" securities -- purported guarantees or standby letters of credit issued by major banks at a discount from their face value -- and that investors would then be paid a percentage of the face value of such securities. The prime banks securities were purported to have face values of up to \$100 million. The Commission alleges that the prime bank securities described by the defendants simply do not exist, and that the defendants used forged documents and fabricated defaults by investors to misappropriate their money.

In its complaint, the Commission alleges that the defendants violated the antifraud provisions of the federal securities laws, Section 17(a) of the Securities Act of 1933 and Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder. The Commission seeks permanent injunctions against future violations of the antifraud provisions, disgorgement of defendants' ill-gotten gains plus prejudgment interest, and civil penalties. In addition,

the Commission is seeking an accounting and an immediate asset freeze. The complaint also names Michael J. Spector, R.P.S Financial Group, Inc., a New Hampshire corporation, and Loomis Ltd. as relief defendants and seeks to have them disgorge investor funds paid to them. [SEC v. Joseph A. INVESTMENT COMPANY ACT RELEASES

BAIRD CAPITAL DEVELOPMENT FUND, INC.

An order has been issued under Section 8(f) of the Investment Company Act declaring that Baird Capital Development Fund, Inc. has ceased to be an investment company. (Rel. IC-22343 - November 20)

THE GANNETT WELSH & KOTLER FUNDS, ET AL.

An order has been issued on an application filed by The Gannett Welsh & Kotler Funds (Trust), et al. under Section 17(b) of the Investment Company Act for an exemption from Section 17(a) of the Act. The order permits the exchange of shares of a series of the Trust for portfolio securities of affiliated partnership. Thereafter, the partnership will dissolve and distribute the shares it received in the exchange pro rata to its partners. (Rel. IC-22344 - November 20)

CALVERT SOCIAL INVESTMENT FUND, ET AL.

A notice has been issued giving interested persons until December 16 to request a hearing on an application filed by Calvert Social Investment Fund, et al. for an order under Section 6(c) of the Investment Company Act to permit applicants to enter into and materially amend contracts with certain funds' subadvisers without shareholder approval. DEUTSCHE BANK AG

An order has been issued on an application filed by Deutsche Bank AG for an order granting conditional exemptive relief from Section 17(f) of the Act. The order allows certain foreign subsidiaries of applicant to maintain assets of registered investment companies in custody, in accordance with an agreement among applicant, the investment company (or its custodian), and the foreign subsidiary. The order also allows these foreign subsidiaries to maintain such assets pursuant to a custody agreement between applicant and the investment company (or its custodian) and a separate subcustodian agreement between applicant and the foreign subsidiary. HOLDING COMPANY ACT RELEASES

SEI BIRCHWOOD, INC., ET AL.

An order has been issued authorizing a proposal by SEI Birchwood, Inc. (SEI Birchwood), a direct nonutility subsidiary of SEI Holdings, Inc., a direct nonutility subsidiary of The Southern Company, a registered holding company, and Birchwood Power Partners, L.P. (BPP), a subsidiary of SEI Birchwood, whereby SEI Birchwood will acquire 50%, or BPP 100%, of the common shares of the company that owns the host facility associated with BPP's generating facility, which has been certified as a "qualifying facility" under the Public Utility Regulatory Policies Act of 1978, as amended. NORTHEAST UTILITIES, ET AL.

An order has been issued authorizing Northeast Utilities (NU), a registered holding company, and its subsidiary companies, Holyoke Water Power Company (Holyoke), Western Massachusetts Electric Company (WMECO), Public Service Company of New Hampshire (PSNH), North Atlantic Energy Corporation (NAEC) and The Connecticut Light & Power Company (CL&P) (collectively, Applicants) to engage in financing and related transactions. Specifically, Applicants propose to make short-term borrowings through December 31, 2000, evidenced in the case of Northeast, CL&P, WMECO, and PSNH, by notes and in the case of CL&P, WMECO and NU, by commercial paper; continue to use, through December 31, 2000, the Northeast Utilities System Money Pool (Money Pool); and allow NU, under the terms of the Money Pool, to borrow funds to, in turn, lend those funds through the Money Pool to its subsidiaries. Borrowings shall not exceed the following amounts: Northeast--\$200 million, CL&P--\$375 million; WMECO--\$150 million; PSNH--\$225 million; Holyoke--\$5 million; and NAEC--\$50 million. PROPOSED RULE CHANGE

The Commission received a proposal (SR-Amex-96-43) by the <u>American Stock Exchange</u> to extend its trading hours to permit the execution of matched orders for Exchange-listed securities which are part of a basket trade being done in large part on the New York Stock Exchange's Crossing Session II. Publication of the notice is expected in the <u>Federal Register</u> during the week of November 25. (Rel. 34-37965)
