#### INVESTMENT COMPANY ACT RELEASES

STRONG ADVANTAGE FUND, INC., ET AL.

An order has been issued on an application filed by Strong Advantage Fund, Inc., et al., under Section 6(c) for an exemption from Section 12(d)(1), under Sections 6(c) and 17(b) for an exemption from Section 17(a), and under Section 17(d) and Rule 17d-1 thereunder. The order permits certain investment companies to purchase shares of affiliated money market funds in excess of the limits prescribed in Section 12(d)(1) for cash management purposes. (Rel. #### HOLDING COMPANY ACT RELEASES

CENTRAL AND SOUTH WEST CORPORATION, ET AL.

A supplemental order has been issued authorizing a proposal by Central and South West Corporation (CSW), a registered holding company, CSW Energy, Inc., a wholly owned non-utility subsidiary company of CSW, and five special-purpose, wholly owned subsidiary companies of CSW Energy, CSW Sweeny GP, Inc., CSW Sweeny GP II, Inc., CSW Sweeny LP, Inc., CSW Sweeny LP II, Inc., and Sweeny Cogeneration L.P., to provide up to \$250 million in equity support to the Sweeny Cogeneration Project (Project) in the form of an equity support agreement, guarantee or letter of credit to the interest that will purchase electric power and thermal energy from the Project. CINERGY CORP., ET AL.

A notice has been issued giving interested persons until December 23 to request a hearing on a proposal by Cinergy Corp. (Cinergy), a registered holding company, Cinergy Investments, Inc. (Investments), Cinergy's nonutility subsidiary, and Cinergy's wholly-owned service company subsidiary, Cinergy Services, Inc. (Cinergy Services) to market a wide variety of energy-related products and services exclusively to nonassociate commercial/industrial customers. Specifically, Cinergy and Investments propose to form a wholly-owned nonutility subsidiary company, Cinergy Solutions, Inc. (Solutions);

and for Solutions to form subsidiaries, acquire, directly or indirectly through subsidiaries, securities or assets of nonassociate companies. Cinergy Services proposes to provide an expanded range of support services to Solutions (including any subsidiary thereof) and other system nonutility companies pursuant to an amendment to the existing Cinergy system nonutility service agreement. #### CENTRAL AND SOUTH WEST CORPORATION

A supplemental order has been issued authorizing Central and South West Corporation (CSW), a registered holding company, to extend its period of authorization, through December 31, 2001, to issue, sell and acquire its common stock pursuant to its Dividend Reinvestment and Stock Purchase Plan. #### ENTERGY CORP., ET AL.

An order has been issued authorizing Entergy Arkansas, Inc. (Arkansas), Entergy Gulf States, Inc. (Gulf States), Entergy Louisiana, Inc. (Louisiana), Entergy Mississippi, Inc. (Mississippi), Entergy New Orleans, Inc. (New Orleans), and System Energy Resources, Inc. (System Energy), all public utility subsidiary companies of Entergy Corp. (Entergy), a registered holding company, to finance, through November 30, 2001, their interim capital needs through loans from the Entergy system money pool and through the issuance and sale of unsecured short-term notes and commercial paper. The maximum amount of loans, notes, and commercial paper that each could issue is limited to: Arkansas, \$235 million; Gulf States, \$340 million; Louisiana, \$225 million; Mississippi, \$103 million; New Orleans, \$35 million; and System Energy, \$140 million.

In addition, Entergy Services, Inc., a service company subsidiary, System Fuels, Inc., a fuel supply subsidiary, and Entergy Operations, Inc., a public utility subsidiary, propose to borrow, through November 30, 2001, through the money pool, from Entergy, and/or from commercial banks, up to a maximum principal amount outstanding of \$150 million, \$95 million and \$20 million, respectively, and for Entergy to guarantee the loans from commercial banks. #### ACCELERATED APPROVAL OF PROPOSED RULE CHANGES

The Commission granted permanent approval on an accelerated basis to a proposed rule change (SR-OCC-96-16) filed by <u>The Options Clearing Corporation</u> that permits OCC to use the Theoretical Intermarket Margin System for calculating clearing margin positions in equity options. Publication of the proposal is expected in the <u>Federal</u>

Register during the week of December 2. (Rel. 34-37985)

The Commission granted approval on an accelerated basis to a proposed rule change (SR-CBOE-96-71) filed by The <u>Chicago Board Options Exchange</u> that modifies the closing time for equity and narrow-based index options. Publication of the proposal is expected in the <u>Federal Register</u> during the week of December 2. (Rel. 34-37988)

#### IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

The Options Clearing Corporation filed a proposed rule change (SR-OCC-96-14) that amends OCC's schedule of fees to reflect the replacement of microfiche with CD-ROM as the media for providing subscribing clearing members with a copy of OCC generated reports. Publication of the proposal is expected in the Federal Register during the week of December 2. (Rel. 34-37988)
