### ENFORCEMENT PROCEEDINGS

TEMPORARY RESTRAINING ORDER ISSUED AGAINST THETA GROUP, LLC, SHADOWSTONE PARTNERS I, LLC, SCOTT BELL AND R. SCOT RUBEL

The Commission announced that on December 6 the United States District Court for the Northern District of Illinois issued a Temporary Restraining Order against Theta Group L.L.C., a broker-dealer located in Chicago, Illinois, Shadowstone Partners I, L.L.C., a broker-dealer located in Lawrenceville, New Jersey, Scott S. Bell, an adviser/consultant to Theta and President of Shadowstone, and R. Scot Rubel, the sole manager and trader of Theta. Specifically, the Order restrains and enjoins Theta, Shadowstone, Bell and Rubel from further violations of the antifraud provisions of the federal securities laws and, among other things, freezes the assets of Theta, Shadowstone and Bell.

The Commission's complaint alleges that, between October 1995 and Theta, Bell and Rubel made misrepresentations and omissions of material fact in the offer and sale of \$13.4 million in securities in the form of membership interests in Theta. The complaint further alleges that Theta, Bell and Rubel failed to inform investors that Bell would be receiving \$1.9 million in investor monies; that he represented to investors that Theta had earned returns in 1993 and 1994 even though Theta did not exist; and that he claimed that Theta was earning profits when it was actually losing money. In addition, the complaint alleges that Shadowstone and Bell made additional misrepresentations to one individual who invested \$500,000 in Shadowstone. A hearing on the Commission's request for a preliminary injunction was set for December 16, 1996. [SEC v. Theta Group LLC, Shadowstone Partners I Bell and R. NICHOLAS RUDI AND PUBLIC CAPITAL ADVISORS, INC. SETTLE SEC FRAUD ACTION ARISING OUT OF CAMDEN COUNTY, NEW JERSEY MUNICIPAL SECURITIES KICKBACK SCHEME

The Commission announced today that defendants Nicholas A. Rudi (Rudi) and his financial advisory firm, Public Capital Advisors,

Inc. (formerly known as Consolidated Financial Management, Inc.) (CFM) have agreed to settle the Commission's civil action against them without admitting or denying the Commission's allegations that they committed securities fraud by soliciting and receiving more than \$200,000 in kickbacks from First Fidelity Securities Group in connection with a Camden County Municipal Utilities Authority's February 1990 offering of approximately \$237,500,000 of debt securities. Under the terms of the settlement, which has been submitted to the Court for approval, Rudi and CFM would each be enjoined from committing securities fraud and Rudi would be ordered to pay \$86,331.40, representing disgorgement of \$49,131.63 and prejudgment interest of \$37,199.77.

The disgorgement and prejudgment interest to be paid by Rudi will be held by the Court for the benefit of persons who submit valid claims arising under the federal securities laws by reason of the conduct alleged against defendants in the complaint. Such claims must be filed within one year after the Court approves the settlement.

This past June, Rudi was acquitted in a criminal action of all charges based on the same conduct. [SEC v. Nicholas A. Rudi, Joseph C. Salema, Public Capital Advisors, Inc.
