#### **ENFORCEMENT PROCEEDINGS**

# SEC SUES STOCK PROMOTER AND TWO FORMER OFFICERS OF VIP GLOBAL CAPITAL, INC. FOR SECURITIES FRAUD

The Commission announced that it filed a civil injunctive action alleging that Timothy S Vasko, the former chairman and CEO of VIP Global Capital, Inc , made materially misleading disclosure in VIP's filings with the Commission, particularly with respect to VIP's credit arrangement with its major source of financing; that Vasko and Edward B Williamson, a stock promoter who published an investment newsletter, engaged in a scheme to tout VIP and manipulate the market for VIP's securities; and that Michael J Schuchard, a former senior vice president and member of VIP's board who also worked as a registered representative of a broker-dealer, fraudulently sold securities of VIP to his brokerage customers VIP, a now defunct holding company based in Denver, Colorado, was in the business of acquiring distressed businesses and trying to make them profitable.

The Commission's complaint seeks an order enjoining Vasko from violating Sections 10(b) and 13(b)(5) of the Exchange Act and Rules 10b-5 and 13b2-1 and from aiding and abetting violations of Section 13(a) of the Exchange Act and Rule 13a-1, and imposing civil monetary penalties pursuant to Section 21 (d)(3) of the Exchange Act

Williamson, without admitting or denying the allegations of the complaint, has agreed to a settlement whereby he would be permanently enjoined from violating Sections 17(a) and 17(b) of the Securities Act, Section 10(b) of the Exchange Act, and Rule 10b-5, and would pay a \$10,000 civil penalty. Schuchard, without admitting or denying the allegations of the complaint, has agreed to a settlement whereby he would be permanently enjoined from violating Section 17(a) of the Securities Act. Section 10(b) of the Exchange Act, and Rule 10b-5, and from aiding and abetting violations of Section

13(a) of the Exchange Act and Rule 13a-1. Schuchard has consented to pay \$11,558 in disgorgement, representing illegal profits arising from his conduct, plus \$4,784.58 in prejudgment interest Schuchard also has agreed, upon entry of the final judgment in this action, to the issuance of a Commission order pursuant to Sections 15(b)(6) and 19(h) of the Exchange Act that would bar him from association with any broker or dealer [SEC v. Timothy S Vasko, Edward B Williamson, and Michael J Schuchard, U.S. District Court for the District of Colorado, C.A No 00-M-2592, December 29, 2000] (LR-16855)

# NATIONAL GRID USA SERVICE COMPANY, INC.

An order has been issued authorizing a proposal by National Grid USA Service Company, Inc. (Service Company) (formerly, New England Power Service Company), a direct wholly owned nonutility service company subsidiary of National Grid USA (collectively, Applicants), and an indirect wholly owned subsidiary of The National Grid Group PLC, a registered public utility holding company, to. (l) restructure Service Company's capitalization to reduce its equity capital, and (2) change Service Company's formula for its return on equity. Applicants request Commission authorization for the changes in Service Company's return on equity formula through December 31, 2004 (Rel 35-27333)

# **ENTERGY CORP.**

An order has been issued authorizing Entergy Corporation (Entergy), a registered holding company, to acquire, directly or indirectly, through December 31, 2005, up to \$1.2 billion in energy-related, nonutility assets that are incidental to energy marketing and brokering, or the equity securities of companies substantially all of whose physical assets consist of those assets, and to engage in related transactions, all in connection with establishment and operation of a new subsidiary to be owned jointly by Entergy and a third party, Koch Energy, Inc (Rel 35-27333)

# ACCELERATED APPROVAL OF A PROPOSED RULE CHANGE

The Commission published notice and granted accelerated approval of a proposed rule change (SR-EMCC-00-07) filed by the Emerging Markets Clearing Corporation under Section 19(b)(1) of the Exchange Act The proposed rule change allows EMCC to remove a security from its list of EMCC eligible instruments and to exit open

transactions in that security from its clearance system Publication of the proposal is expected in the Federal Register during the week of January 8 (Rel 34-43810)

#### PROPOSED RULE CHANGES

The Government Securities Clearing Corporation filed a proposed rule change (SR-GSCC-00-08) under Section 19(b)(1) of the Securities Exchange Act that would enable GSCC to provide offsets in the clearing fund calculation for category 2 levels of membership for dealers and futures commission merchants that meet all of GSCC's requirements for participating in the nefting system but have less net worth than GSCC's category I dealers and FCMs Publication of the proposal is expected in the Federal Register during the week of January 8. (Rel. 34-43793)

The Government Securities Clearing Corporation filed a proposed rule change (SR-GSCC-00-10) under Section 19(b)(1) of the Exchange Act. The proposed rule change will amend GSCC's rules relating to the submission of repo collateral substitutions. Publication of the proposal is expected in the Federal Register during the week of January 8 (Rel 34-43794)

The Emerging Markets Clearing Corporation filed a proposed rule change (SR-EMCC-00-08) under Section 19(b)(1) of the Exchange Act. The proposed rule change would permit members to satisfy clearing fund obligations with either immediately available funds or eligible treasury securities. Publication of the proposal is expected in the Federal Register during the week of January 8. (Rel 34-43808)
