#### **ENFORCEMENT PROCEEDINGS**

### COMMISSION SUSTAINS NASD ACTION AGAINST STEVEN GOODMAN

The Commission has sustained NASD disciplinary action against Steven D Goodman of Allison Park, Pennsylvania Goodman was a registered representative in the Pittsburgh office of Hibbard Brown & Co., Inc., a former NASD member firm The NASD barred Goodman from association with any NASD member firm in any capacity, and fined him \$75,000.

The Commission found that, in 1993, Goodman defrauded three customers in connection with his sales of various speculative securities. The Commission stated that Goodman not only made wholly irresponsible statements and predictions, but also withheld material information from investors. In addition, he used high pressure tactics to induce sales, and increased customer losses by dissuading customers from selling and failing to execute sell orders.

In sustaining the NASD's sanctions, the Commission stated that Goodman had engaged in egregious misconduct in utter disregard of his obligations to investors. It found that the imposition of a bar was appropriate to protect the public from further harm at Goodman's hands, and that the fine was fully warranted (Rel 34-43889, File No 3-10116)

#### REGALD SMITH BARRED FROM ASSOCIATION WITH ANY BROKER-DEALER

The Commission announced today that it simultaneously instituted and settled administrative proceedings pursuant to Sections 15(b) and 19(h) of the Securities Exchange Act of 1934 against Regald B. Smith (Smith) of Pikeville, Kentucky Smith agreed to be barred from association with any broker or dealer Smith, age 55, was a broker in charge of Stifel's Nicolaus & Company, Incorporated's Pikeville, Kentucky office On September 7, 2000, the US District Court for the Eastern District of Kentucky entered an order of permanent injunction against Smith, pursuant to Smith's consent, without admitting or denying the Commission's charges, enjoining Smith from violating the antifraud provisions of the federal securities laws, freezing Smith's assets and ordering him to account for and disgorge his ill-gotten gains and pay civil penalties

In amounts to be determined The order was entered in response to the Commission's Complaint filed September 6th, charging Smith with perpetrating an 18-month scheme in which he stole, through the sale of fictitious securities, more than \$5 million from least 6 investors who were his brokerage clients. On August 28, 2000, Smith confessed to Stifel officials that he had conducted the scheme On October 10, 2000, Smith pled guilty to wire fraud based on his misconduct (Rel 34-43890, File No 3-10411)

# COMMISSION INSTITUTES AND SIMULTANEOUSLY SETTLES PUBLIC ADMINISTRATIVE PROCEEDINGS AGAINST JOHN BLOUNT, III.

The Commission announced that it has instituted and simultaneously settled public administrative proceedings, pursuant to Section 15(b) of the Securities Exchange Act of 1934 (Exchange Act), against John A Blount, III The order instituting the proceedings (Order) bars Blount from association with any broker or dealer

The Commission's Order finds that Blount was associated as an unregistered representative of International Currency Consultants, Inc (ICC), an unregistered broker-dealer The Order further finds that on November 9, 2000, the U S District Court for the Southern District of Florida permanently enjoined Blount, by consent, from further violations of the antifraud and securities and broker-dealer registration provisions of the federal securities laws

The permanent injunction followed a civil action initiated by a complaint filed by the Commission on May 16, 2000, alleging that between May 1998 and May 1999, Blount made material misrepresentations and omissions in connection with the unregistered offer and sale of securities issued by ICC (SEC v. William S Cordo, Mitchell S Davis and John A Blount, No 00-08392-CIV-RYSKAMP, S D Fla ) Blount's misrepresentations concerned, among other things the profits and losses in individual accounts, the anticipated and past returns of ICC's investment program, the risk of the investment and the size of ICC's trading operation. The Commission's Complaint also alleged that Blount acted as an unregistered broker-dealer in the sale of ICC securities and received ill-gotten gains in the form of commission payments from his sale of the ICC securities (Rel 34-43891, File No 3-10412)
