ENFORCEMENT PROCEEDINGS

CEASE AND DESIST ORDER ENTERED AGAINST THERMOTEK INTERNATIONAL, INC. AND HAROLD MASSNER

On March 6, the Commission issued a cease and desist order against Thermotek International, Inc (TTKI), a microcap company headquartered in Burlington, Iowa, and Harold D Massner, its president TTKI claims to have developed technology that takes organic substances from waste and converts them into useable products such as fuel, charcoal, and electricity The Commission found that TTKI and Massner violated the registration provisions of the federal securities laws when it issued stock to Lloyd E Wollmersl suser, the owner of an Internet web site and newsletter service Wollmershauser then used the stock to personally profit in an Internet pump-and-dump manipulation scheme

The Commission found that in March 2000, TTKI sold Wollmershauser 16,000 shares of TTKI stock for \$4,000 in cash, and in June 2000 sold Wollmershauser an additional 2 million shares of TTKI stock for \$800,000 pursuant to a promissory note. The Commission found that Massner expected that Wollmershauser would have to sell TTKI stock when it started trading in the over-the-counter market on June 28, 2000 in order to pay the promissory note, and Wollmershauser did sell TTKI stock on June 28 and June

29, 2000. The Commission further found that no registration statement had been filed with the Commission or had been in effect with respect to the securities sold to Wollmershauser, and the securities were not exempt from registration

TTKI and Massner were ordered to cease and desist from committing or causing any violation and any future violation of Sections 5(a) and 5(c) of the Securities Act of 1933. TTKI and Massner consented to the entry of the Order without admitting or denying its findings (Rel 33-7962; File No. 3-10436)

SELF-REGULATORY ORGANIZATIONS

PROPOSED RULE CHANGE

The <u>National Securities Clearing Corporation</u> filed a proposed rule change (SR-NSCC-00-99) to allow NSCC to process otherwise ineligible securities through NSCC's continuous net settlement, balance order, or other related system. Publication of the proposal is expected in the <u>Federal Register</u> during the week of March 5. (Rel 34-44032)

APPROVAL OF PROPOSED RULE CHANGE

A proposed rule change filed by the <u>National Association of Securities Dealers</u> to amend NASD Rule 6230(b), one of the rules approved in connection with the NASD's Trade Reporting and Comparison Entry Service (TRACE), has been approved pursuant to Section 19(b)(2) of the Securities Exchange Act of 1934. The amendment requires both the buy-side and sell-side to submit transaction reports in member-to-member transactions that are subject to TRACE reporting Publication of the approval order is expected in the <u>Federal Register</u> during the week of March 12 (Rel 34-44039)
