COMMISSION ANNOUNCEMENTS

COMMISSION EXTENDS INITIAL COMPLIANCE DATE OF ORDER EXECUTION QUALITY DISCLOSURE RULE AND PROVIDES WRITTEN GUIDANCE ON IMPLEMENTATION OF RULE

On March 13, the Commission announced that it is extending the initial compliance date for the first phase-in of securities subject to Rule 11Ac1-5, the order execution quality disclosure rule, from April 2, 2001 to May 1, 2001. The subsequent phase-in dates of Rule 11Ac1-5 and the compliance date of Rule 11Ac1-6, the order routing disclosure rule, remain unchanged.

The Division of Market Regulation also has published Staff Legal Bulletin No. 12 responding to questions the staff has received from market participants on the application of Rule 11Ac1-5. The legal bulletin, in the form of a Frequently Asked Questions (FAQ) document, sets forth the views of the Division of Market Regulation. The Commission has neither approved nor disapproved its content.

In addition, the Commission has issued exemptions from the provisions of Rule 11Ac1-5 relating to manually-received orders, orders affected by crossed markets, and orders affected by trading halts. The exemptions are set forth in a letter to the Securities Industry Association.

Separately, the Commission issued a temporary exemption, until July 31, 2001, from the reporting requirement of Rule 11Ac1-5 to smaller Nasdaq market centers. To qualify, the Nasdaq market center must meet two conditions: (1) its reported trade volume in Nasdaq-listed securities for the month of January 2001 was less than 10,000 trades; and (2) it arranges, prior to May 1, 2001, to use Nasdaq's forthcoming voluntary reporting service or any other reporting service to comply with the Rule. The exemption is set forth in a letter to the Nasdaq Stock Market, Inc.

RULES AND RELATED MATTERS

ELECTRONIC RECORDKEEPING BY INVESTMENT COMPANIES AND INVESTMENT ADVISERS

The Commission has issued a release proposing amendments to Rule 31a-2 under the Investment Company Act and Rule 204-2 under the Investment Advisers Act to allow registered investment companies and registered investment advisers to store all required records on electronic storage media. The proposed amendments would expand the ability of registered investment companies and advisers to use electronic storage media to maintain and preserve records, provided specified record maintenance procedures are followed. The Commission is proposing these amendments in response to the passage of the Electronic Signatures in Global and National Commerce Act, which encourages federal agencies to accommodate electronic recordkeeping. ENFORCEMENT PROCEEDINGS

ADMINISTRATIVE PROCEEDINGS SETTLED WITH SHIRLEY MCKINNEY AND MICHAEL MCEVOY

On March 13, the Commission entered an Order Making Findings and Imposing Remedial Sanctions (Order) against Shirley A. McKinney (McKinney) and Michael J. McEvoy (McEvoy). McKinney and McEvoy were barred from association with any broker or dealer.

On September 21, 2000, the Commission entered an Order Instituting Administrative Proceedings (Complaint) against McKinney and McEvoy alleging that each of them pled guilty to one count of an indictment or criminal information charging them with conspiracy to commit securities fraud, mail fraud and wire fraud. The indictment and criminal information alleged that while employed as registered representatives at various registered broker-dealers during various periods between June 1993 and June 1995, McKinney, McEvoy and others accepted undisclosed compensation from a promoter for inducing their clients to purchase securities of certain issuers affiliated with the promoter. Each was sentenced to probation and/or prison and ordered to pay restitution to the extent that their clients suffered losses (*United States v. Paul Mabry*, et al., Case No. 98-8117-CR-

HURLEY, S.D. Fla. 1998, and *United States v. McEvoy*, Case No. 98-8115 CR- HURLEY, S.D. Fla. 1998).

McKinney and McEvoy settled the proceedings by consenting to the entry of the Order without admitting or denying the allegations of the Complaint, except as to jurisdiction and the entry of the convictions set forth above. (Rel. 34-44068; File No. 3-10295)

INVESTMENT COMPANY ACT RELEASES

GFINET, INC. AND MAGNETIC HOLDINGS INTERNATIONAL (DE) LLC

A notice has been issued giving interested persons until March 12 to request a hearing on an application filed by GFInet inc. and Magnetic Holdings International (DE) LLC, for an order under Sections 6(b) and 6(e) of the Investment Company Act. The order would exempt an employees' securities company formed for the benefit of key employees of GFInet inc. from certain provisions of the Act. (Rel. IC-24891 – March 13)

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission granted accelerated approval to a proposed rule change submitted by the <u>Philadelphia Stock Exchange</u> (SR-Phlx-01-16) permitting the Exchange to compensate hearing panelists. Publication of the notice in the <u>Federal Register</u> is expected during the week of March 12. (Rel. 34-44061)

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

A proposed rule change (SR-Amex-01-11) submitted by the <u>American Stock Exchange</u> to increase the maximum permissible contracts executable through the Exchange's Order File System from 250 to 2500 option contracts has been filed and become immediately effective under Rule 19b-4 under the Securities Exchange Act of 1934. APROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change submitted by the <u>Chicago Stock Exchange</u> (SR-CHX-00-31) to amend its rule governing preopening orders. Publication of the proposal is expected in the <u>Federal Register</u> during the week of March 12. (Rel. 34-44062)

The Commission approved a proposed rule change (SR-NASD-01-01) submitted by the National Association of Securities Dealers, through its subsidiary, the Nasdaq Stock Market, Inc. to amend NASD Rule 4330(f) to require a Nasdaq issuer to apply for initial inclusion following a Reverse Merger with a non-Nasdaq entity, and to make conforming changes to IM-4300, Interpretive Material Regarding Future Priced Securities. Publication of the proposal is expected in the <u>Federal Register</u> during the week of March 12. (Rel. 34-44067)
