COMMISSION ANNOUNCEMENTS

EXEMPTIVE ORDER ISSUED GOVERNING EMPLOYEE STOCK OPTION EXCHANGE OFFERS

Today the Securities and Exchange Commission's Division of Corporation Finance announced the issuance of an exemptive order addressing employee stock option exchange offers. The exemptive order permits issuers to make these exchange offers without the need to comply with the rules requiring tender offers to be extended to all security holders of a class at the same price. The order contains conditions designed to assure that this relief is only given in the context of compensatory offers and that adequate disclosure is provided to employees. The Division also issued guidance on disclosure and processing issues relating to these exchange offers in the form of an update to its Current Issues and Rulemaking Projects Outline.

ENFORCEMENT PROCEEDINGS

COMMISSION SANCTIONS MICHAEL MARKOWSKI

On March 20, the Commission barred Michael J. Markowski, who was president, owner, and chief executive officer of Global America, Inc., formerly a registered broker-dealer, from association with any broker or dealer The Commission found that, on August 24, 1995, Markowski had consented to the entry of an order permanently enjoining him from future violations of the antifraud provisions of the federal securities laws. The injunctive action alleged that in 1990 Markowski had manipulated the market prices of the securities of three issuers.

The Commission rejected Markowski's claim that the proceeding was time barred by the five-year statute of limitations contained in 28 U.S.C. § 2462, finding that regardless of when the underlying conduct had occurred, the action was instituted within five years of the entry of the injunction. In issuing the bar, the Commission concluded, among other things, that Markowski's conduct was es regious, and that his failure to recognize the wrongfulness of his conduct presented a significant risk that, given the opportunity, he would commit further misconduct. SEC SETTLES CHARGES AGAINST INVESTMENT ADVISER FOR IMPROPER USE OF DISCRETIONARY AUTHORITY AND NON-DISCLOSURE CONCERNING PURCHASES OF SECURITIES OF AFFILIATE

On March 20, the Commission settled administrative proceedings against Frederick A. Wolf a former president of Valley Forge Barrington, Inc. The Commission ordered Mr. Wolf to cease and desist from committing any violations or any future violations of the antifraud provisions of the investment advisor laws and suspended him from association with any investment adviser for a period of twelve months.

The Commission found that Wolf purchased for or recommended to advisory clients approximately \$2.2 million in high risk, unregistered debentures and stock issued by Barrington's parent company, Valley Folge Capital Holdings, Inc. (VFCH). Wolf failed to disclose the nature of the securities to several of its advisory clients. Wolf procured interest payments for advisory clients who had invested in debentures issued by Continental Capital Financial Group (CCFG, a company controlled by the principal of VFCH. At the time CCFG had ceased making interest payments to investors and Wolf believed that CCFG was near bark ruptcy. The deteriorating financial condition and the fact that the interest payments did not come from CCFG were not disclosed to all clients.

Wolf consented to the Commission's order without either admitting or denying the Commission's findings. The charges against Wolf were brought under Sections 206(1) and 206(2) of the Investment Advisers Act of 1940. (Rel. IA-1933; File No. 3-9734)

TWO OWNERS OF MANHATTAN BROKERAGE FIRM, OTHERS, SENTENCED ON CRIMINAL FRAUD CHARGES

The Commission announced that on March 16 J. P. Gibbons & Co., Inc., a Manhattan brokerage firm formerly known as The Golden Lender Financial Group, Inc. (Golden Lender); Aron O. Bronstein and Tomer M. Yuzary, co-founders and principal owners of Golden Lender; and Roman Sakharovich, a/k/a Roman Sakh, and Iosif Pak, a/k/a Joseph Pak, registered representatives of Golden Lender, were sentenced on criminal charges arising out of a fraudulent offering of Golden Lender stock. United States District Judge Michael B. Mukasey sentenced Bronstein and Yuzary each to three years and ten months in prison, Sakh to three years and five months in prison, and Pak to three years in prison. Judge Mukasey also ordered that Golden Lender be dissolved and that the other defendants liquidate their assets and pay restitution to the victims of the fraud in the amount of \$3,209,000. The individual defendants had previously pleaded guilty to

charges of conspiracy and securities fraud; Golden Lender had previously pleaded guilty to charges of securities fraud. The criminal case was prosecuted by the Office of the United States Attorney for the Southern District of New York.

The Commission previously instituted a civil action against the defendants, based on the same conduct underlying the criminal charges. The Commission's complaint charges that, from January 1998 through November 1999, the defendants raised at least \$5,270,000 in a fraudulent, unregistered offering of Golden Lender stock. The complaint alleges that, acting at Bronstein and Yuzary's direction, Sakh and Pak sold Golden Lender stock to retail customers (including many elderly and infirm customers of modest means) using a high pressure sales pitch that included numerous material misrepresentations and omissions. Among the misrepresentations and omissions allegedly used by the defendants to induce investors to part with their savings are the following:

- False representations that Golden Lender would soon conduct an initial public offering and that investors would reap large profits once the firm went public;
- ° Failure to inform investors of the risks associated with investing in Golden Lender, including Golden Lender's precarious financial condition; and

Concealment of exorbitant payments to Bronstein and Yuzary drawn from investor funds

The complaint further alleges that the defendants recommended and sold Golden Lender stock to numerous investors for whom it was clearly unsuitable, including retirees who invested large portions of their modest retirement funds

The Commission's action, which alleges that the defendants violated Sections 5(a), 5(c), and 17(a) of the Securities Act of 1933 and Section 10(b) and 15(c) of the Securities Exchange Act of 1934 and Rules 10b-3, 10b-5, and 15c1-2 thereunder, Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder, is pending in the United States District Court, Southern District of New York (SEC v. LINDNER INVESTMENTS AND LINDNER ASSET MANAGEMENT, INC.

A notice has been issued giving interested persons until April 16, 2001, to request a hearing on an application filed by Lindner Investments and Lindner Asset Management, Inc. for an order under Section 12(d)(l)(J) of the Investment Company Act for an exemption from Sections 12(d) (l) (A) and (B) of the Act, under Sections 6(c) and 17(b) of the Act for an exemption from Section 17(a) of the Act, and under Section 17(d) of the

Act and Rule 17d-1 under the Act to permit certain joint transactions. The requested order would permit certain registered management investment companies to invest uninvested cash in an affiliated money market fund. (Rel. IC-24895 – March 20)
