ENFORCEMENT PROCEEDINGS

SEC CENSURES AND FINES GUY WYSER-PRATTE AND HIS BROKER-DEALER AND INVESTMENT ADVISER FIRMS FOR FAILURE TO HAVE ADEQUATE POLICIES AND PROCEDURES

On May 9, the Commission instituted and settled administrative proceedings against Guy P. Wyser-Pratte (Wyser-Pratte), Wyser-Pratte and Co., Inc., and Wyser-Pratte Management Co., Inc., for the firms' failure to establish, maintain and enforce policies and procedures reasonably designed to prevent the misuse of material nonpublic information. The firms are located in New York City and are wholly owned by Wyser-Pratte, also of New York City.

The Commission's Order finds that Wyser-Pratte and the firms engage in merger arbitrage and "investment initiatives." In the investment initiatives, Wyser-Pratte has made director nominations and shareholder proposals for companies in which the firms have made a substantial investment. The shareholder proposals are designed to change the companies' governance, such as modifications to "shareholder rights plans" and the like. In carrying out the initiatives, Wyser-Pratte and an employee of the firms often interact with other market participants who possess material nonpublic information concerning the targets of the initiatives. Wyser-Pratte also directs all trading at the firms, including hedging and other trading related to the investment initiatives. The Order finds that Wyser-Pratte's firms, taking into consideration the nature of their businesses, lacked adequate safeguards to prevent the misuse of material nonpublic information that Wyser-Pratte or the employee may be exposed to.

Without admitting or denying the findings, Wyser-Pratte, Wyser-Pratte and Co., Inc. and Wyser-Pratte Management Co., Inc. consented to the entry of a Commission Order finding that Wyser-Pratte and Co., Inc. willfully violated Section 15(f) of the Securities Exchange Act of 1934, Wyser-Pratte Management Co., Inc. willfully violated Section 204A of the Investment Advisers Act, and Wyser-Pratte willfully aided and abetted, and was a cause of the firms' violations. The Order censures the respondents, orders them to cease and desist from such violations, and imposes civil penalties totaling \$450,000 (\$50,000 against Wyser-Pratte, \$200,000 against Wyser-Pratte and Co., Inc., and \$200,000 against Wyser-Pratte Management Co., Inc.). The Order also requires the

respondents to hire an independent consultant to undertake a compliance review of the firms' policies and procedures and to implement any corrective measures that are recommended. (Rel. 34-44283; IA-1943; File No. 3-10479)

PUBLIC ADMINISTRATIVE PROCEEDINGS INSTITUTED AGAINST ROGER MYATT

On May 8, the Commission instituted and simultaneously settled administrative proceedings against Roger Myatt a registered representative associated with Commission-registered broker-dealers. The Commission's order found that a final judgment had been entered against Myatt in a civil action filed by the Commission. According to the Commission's complaint in the civil action, Myatt solicited an investor to invest \$1 million in a prime bank scheme that raised more than \$15 million in 1998. Investors were told that their funds would be used to trade in high-yield European bank instruments with a return of 1000% within 60 days. In reality, the prime bank trading program did not exist. Much of the investment funds were returned to investors as purported profits. However, certain of Myatt's co-defendants misappropriated investment funds for their personal use, including the purchase of a \$1.2 million mansion. Myatt expected to receive sales commissions as compensation for his efforts, although he received no funds from the scheme.

The Commission accepted the offer submitted by Myatt in which he consents, without admitting or denying the Commission's findings, to the entry of an order which bars him from association with any broker or dealer with the right to reapply for association after one year to the appropriate self-regulatory organization, or if there is none, to the Commission. SEC v. PINNFUND USA, INC., ET AL.

The Commission today announced that on May 4 U.S. District Judge Marilyn L. Huff issued a Preliminary Injunction and Order Freezing Assets, for an Accounting, and Prohibiting Destruction of Documents as to relief defendants Kelly Cook (Cook) and Reliance Holdings, LLC (Reliance Holdings). The Court has now preliminarily enjoined all of the defendants to this matter, which concerns the fraudulent misuse of more than \$300 millior in investor proceeds. The Commission's complaint alleges that Defendant James Hillman (Hillman) raised investor proceeds through his control of Peregrine Funding and the sale of unregistered securities in Allied Capital Partners, Grafton Partners and Six Sigma, LLC (collectively with Peregrine Funding, Inc., the Funding Entities), and the defendants misused the proceeds to fund defendant Michael Fanghella's (Fanghella) lavish lifestyle, to pay for PinnFund USA, Inc.'s (PinnFund) operational losses, and to make payments back to investors as part of a Ponzi scheme. The Court previously issued a Preliminary Injunction and Order Freezing Assets, for Repatriation, and Prohibiting Destruction of Documents as to Hillman and the Funding Entities on April 25, 2001 and as to Fanghella and PinnFund on April 2, 2001.

The Commission alleges that since 1993, Fanghella, Hillman, PinnFund, and the Funding Entities raised at least \$330 million from at least 166 investors, purportedly for the purpose of funding PinnFund's business of writing residential home mortgages. However, the Commission alleged in its complaint and in its Motion for Preliminary Injunction that Fanghella and Hillman misappropriated the funds raised by the Funding Entities and used those funds to pay for Fanghella's extravagant personal living expenses (including the use of at least \$10 million in investor funds to buy a \$5 million home, furnishings and other accessories for Cook), to pay undisclosed monthly commissions of up to \$1 million per month to Hillman, to pay a 17% annual rate of return to investors, and to conceal the more than \$95 million in losses incurred by PinnFund since 1997. It is also alleged that Hillman, PinnFund and the Funding Entities circulated altered financial statements of PinnFund and forged auditors' reports, containing numerous fraudulent misrepresentations and omissions, in order to conceal PinnFund's operational losses and the transfer of more than \$107 million to Fanghella for his personal use.

The Commission's complaint does not allege that Cook and Reliance Holdings violated the securities laws but names them as relief defendants for the purpose of obtaining disgorgement of assets that they allegedly received as the result of the fraud perpetrated by Fanghella.

On April 2, the Court appointed Charles LaBella as permanent receiver over PinnFund. Also on April 2, the Funding Entities, as creditors of PinnFund, initiated an involuntary bankruptcy proceeding for PinnFund. Later that same day, the Funding Entities filed a voluntary petition for bankruptcy in the United States District Court for the Northern District of California.

The Court's Orders as to Fanghella, Hillman, PinnFund and the Funding Entities preliminarily enjoin them from violating the antifrauc provisions, Section 17(a) of the Securities Act of 1933 (Securities Act) and Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder. The Orders further preliminarily enjoin Hillman and the Funding Entities from violating the registration provisions, Sections 5(a) and 5(c) of the Securities Act. The Commission seeks a judgment of permanent injunction, disgorgement and civil penalties against Fanghella, Hillman, PinnFund and the Funding Entities, and disgorgement against Cook and Reliance Holdings. A notice has been issued giving interested persons until June 1, 2001, to request a hearing on an application filed by Western-Southern Life Assurance Company, Western-Southern Life Assurance Company Separate Account 1 and 'Vestern-Southern Life Assurance Company Separate Account 2 (the Separate Accounts) for an order, pursuant to Section 26(b) of the Investment Company Act, approving the substitution of shares of the Touchstone Variable Series Trust's (TVST) Touchstone High Yield Portfolio for shares of TVST's Touchstone Income Opportunity Portfolio held by the Separate Accounts to support certain variable annuity contracts. EQUITABLE LIFE ASSURANCE SOCIETY OF THE UNITED STATES, ET AL.

An order has been issued pursuant to Section 26(b) of the Investment Company Act to the Equitable Life Assurance Society of the United States (Equitable), Separate Account A of Equitable (SA A), Separate Account No. 301 of Equitable (SA 301), Separate Account No. 45 of Equitable (SA 45), Separate Account No. 49 of Equitable (SA 49), and Separate Account FP of Equitable (SA FP) approving the substitution of securities. An order also has been issued pursuant to Section 17(b) of the Act to permit Equitable, SA A, SA 301, SA 45, SA 49, SA FP, and Separate Account No. 65 of Equitable to permit certain in-kind redemption and purchase transactions in connection with the substitutions.
