RULES AND RELATED MATTERS

RULE AMENDMENTS ADOPTED RELATING TO ELECTRONIC SIGNATURES ACT

The Commission has issued a release adopting amendments to Rule 31a-2 under the Investment Company Act of 1940 and Rule 204-2 under the Investment Advisers Act of 1940 to allow registered investment companies and registered investment advisers to store all required records on electronic storage media. These amendments were prompted by the recent enactment of the Electronic Signatures in Global and National Commerce Act (Electronic Signatures Act), which is intended to facilitate the use of electronic records and signatures in interstate and foreign commerce. We are also interpreting Rules 31a-2 and 204-2 to be the exclusive means by which funds and advisers can comply with the recordkeeping provisions of the Electronic Signatures Act. ENFORCEMENT PROCEEDINGS

FINAL JUDGMENTS ENTERED AGAINST PACIFIC AIR TRANSPORT AND ROBERT HIRSCH

On May 18, the U.S. District Court for the Central District of California entered Final Judgments of Permanent Injunction against Pacific Air Transport and its former president, Robert B. Hirsch. The final judgments, which were entered with the consent of the defendants, enjoin Pacific Air and Hirsch from future violations of the antifraud and registration provisions of Sections 5(a), 5(c) and 17(a) of the Securities Act of 1933, and Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder. The Court also ordered disgorgement of ill-gotten gains against Pacific Air in the amount of \$1.2 million, plus prejudgment interest of \$164,692, though these amounts were waived due to the fact that Pacific Air is now defunct. The Court assessed a civil penalty against Hirsch in the amount of \$20,000.

The Commission filed a civil action against Pacific Air and Hirsch on May 31, 2000, alleging that the defendants had engaged in a fraudulent securities offering. In its complaint, the Commission alleged that, from November 1998 through September 1999, Pacific Air raised millions of dollars from investors in 22 states from the sale of "secured" promissory notes. Pacific Air primarily marketed the notes, which promised interest rates ranging from 12% to 13%, through a sales network of insurance agents. In addition to promising returns in excess of similar fixed investments, Pacific Air represented that investor funds were guaranteed by an offshore insurance company.

HOLDING COMPANY ACT RELEASES

DTE ENERGY CORPORATION, ET AL.

An order has been issued authorizing DTE Energy Company (DTE), a Michigan public utility holding company that claims exemption under Section 3(a)(1) of the Act by Rule 2 of the Act, to acquire indirectly through its inactive, wholly owned subsidiary, DTE Enterprises, Inc. (Merger Sub), all issued and outstanding stock of MCN Energy Group Inc., a Michigan public utility holding company that claims exemption under Section 3(a)(1) of the Act by Rule 2 under the Act. The order also exempts DTE and Merger Sub from all requirements of the Act, except for Section 9(a)(2), under Section 3(a)(1) of the Act. (Rel. 35-27403)

SELF-REGULATORY ORGANIZATIONS

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

A proposed rule change (SR-CBOE-2001-26) filed by the Chicago Board Options Exchange extending the pilot program that provides for the elimination of position and exercise limits for S&P 100 Index, S&P 500 Index, and Dow Jones Industrial Average index options as well as for FLEX options overlying these indexes has become effective under Section 19(b)(3)(A) of the Exchange Act. The Commission granted accelerated approval to a proposed rule change submitted by the International Securities Exchange (SR-ISE-2001-16) relating to temporary extension

PROPOSED RULE CHANGE

The Commission issued a notice of filing of a proposed rule change and Amendment No. 1 thereto (S. CBOE-2001-16) by the Chicago Board Options Exchange pursuant to Section 19(b)(2) of the Exchange Act. The proposed rule change, as amended, would amend the CBOE's rules to add a new parameter, the order PACER, to CBOE's Order Routing System. Publication of the notice in the Federal Register is expected during the week of May 28. (Rel. 34-44339)
