MARGARET HENRY APPOINTED ATTORNEY-FELLOW IN OFFICE OF MUNICIPAL SECURITIES

The Commission's Division of Market Regulation today announced the selection of Margaret C. (Peg) Henry as an attorney-fellow in the Office of Municipal Securities for a two-year term beginning June 4, 2001. Ms. Henry's broad experience in municipal securities--in the private practice of law, federal and local government, and investment banking -- will be an asset to the Commission. Previously, she headed the public finance group of the international law firm of Torys. Among other positions, she has also been a partner in Mudge Rose Guthrie Alexander & Ferdon, an Attorney-Advisor to the U.S. Department of Treasury, Tax Counsel to the Majority Tax Staff of the Committee on Ways and Means of the U.S. House of Representatives, a Managing Director in the Public Finance Department of Salomon Smith Barney, and Tax Counsel to the Office of Management and Budget of The City of New York.

Martha Mahan Haines, Chief of the Office of Municipal Securities, said, "Peg's extensive experience in a number of capacities with a wide variety of public finance transactions will be a tremendous asset to the Commission as we work with the municipal finance community and provide municipal market expertise to other offices and diaisions within the Commission."

Ms. Henry joins Stephen Weinstein, who also is serving as an attorney-fellow in the Division of Market Regulation's Office of Municipal Securities. (Press Rel. 2001-58)

ENFORCEMENT PROCEEDINGS

APPLICATION FOR SHOW CAUSE ORDER AGAINST STANLEY VAN ETTEN

On May 25, the filed an application for an order to show cause why Stanley H. Van Etten (Van Etten) should not be held in contempt for his violation of the Court's order entered September 17, 1999, requiring him to pay disgorgement.

The Commission's complaint, filed on Ma. h 16, 1998, alleged that beginning in April, 1995, International Heritage, Inc. (IHI), a North Carolina corporation, through Van Etten and others, solicited individuals throughout the United States to invest in a pyramid scheme through misleading promotional materials, meetings, videotapes, internet web pages, and national conference calls to increase investor interest. IHI raised more than \$150 million from over 155,000 investors.

On September 17, 1999, a final judgment of permanent injunction was entered against Van Etten, restraining and enjoining him from further violations of the registration, antifraud and reporting provisions of the federal securities laws. The Court ordered disgorgement against Van Etten in the amount of \$7,630,450, but due to a demonstrated inability to pay, the Court ordered him to pay \$150,000, waived payment of the remaining disgorgement, pre-judgment and post-judgment interest, did not impose a civil penalty, and required him to waive certain claims against the bankruptcy estate of IHI. Van Etten consented to the entry of the judgment without admitting or denying the allegations of the Commission's complaint. Van Etten has failed to pay \$25,000 of the disgorgement. [SEC v. A notice has been issued giving interested persons until June 25 to request a hearing on an application filed by Sun Life Assurance Company of Canada (U.S.) (Sun Life), Sun Life Assurance Company of Canada (U.S.) Variable Account F (Variable Account), and Clarendon Insurance Agency, Inc. The Applicants also seek an order pursuant to Section 6(c) of the Act granting exemptions from the provisions of Sections 2(a)(32), 22(c), and 27(i)(2)(A) of the Act and Rule 22c-1 thereunder, to permit the recapture, from any New Contract returned to Sun Life during the free look period, of a 2% bonus payment credited on amounts transferred to the New Contract under the proposed offer of exchange.
