#### **ENFORCEMENT PROCEEDINGS**

## COMMISSION OBTAINS A PERMANENT INJUNCTION AND OTHER RELIEF FROM CHARLES HAGEMANN

The Commission announced that Charles F. Hagemann was enjoined in the conclusion of an offering fraud action against twelve former salespersons employed by in a Holdings, Inc., a defunct company formerly based in Woodland Hills, California. On May 31, a Final Judgment by consent was entered against Hagemann permanently enjoining him from future violations of the registration and antifraud provisions of the federal securities laws. Although the Final Judgment also orders Hagemann to pay \$53,685 in disgorgement, all but \$25,000 was waived and a civil penalty was not assessed based upon Hagemann's demonstrated inability to pay.

The Commission's complaint alleged that Hagemann made fraudulent representations in connection with his sales of the unregistered securities of two restaurant subsidiaries controlled by Papa Holdings. Papa Holdings and its restaurant subsidiaries raised over \$21 million from approximately 1,300 investors nationwide from November 1995 to January 1999. Instead of opening new restaurants, the restaurant subsidiaries used the money to pay undisclosed commissions and to cover losses incurred by existing

Papashon restaurants. None of the restaurant subsidiaries ever opened a restaurant and, due to their losses, existing Papashon Restaurants in Pasadena, Beverly Hills, Encino and Long Beach, California closed in 1999. ## JUDAH WERNICK AND LEONARD GREER ENJOINED

The Commission announced that on June 5, in a market manipulation case, Final Judgments were entered in the Southern District of New York against Judah Wernick and Leonard B. Greer, enjoining them from violating the antifraud provisions, and Greer from violating of certain securities reporting provisions, of the federal securities laws. Greer was ordered to disgorge \$257,800, plus prejudgment interest of \$203,986 and post judgment interest, and to pay a civil penalty of \$100,000. Wernick was ordered to disgorge \$218,149.71, plus prejudgment interest of \$172,936.58 and post judgment interest. Greer and Wernick consented to the entry of the Final Judgments without admitting or denying the allegations of the complaint.

In its complaint, the Commission alleged that, from January 1994 through April 1994, Wernick and Greer fraudulently manipulated the market price of the stock of AFGL International, Inc. from \$1 to \$7 per share. The Commission alleged that Wernick and Greer accomplished the manipulation by controlling the supply of AFGL stock that was available to the market; by accumulating over two-thirds of the freely-tradable AFGL stock in the proprietary account of Greer's firm, L.C. Wegard & Co.; by exerting price leadership to increase the market price of AFGL stock; and by generating tail demand for AFGL stock.

The Commission further alleged in the complaint tlat, during an intensive nine-day selling effort that began on April 20, 1994, Greer's firm, Wegard, sold over 1 million shares of AFGL stock to its customers, at artificially inflated prices, netting a profit of approximately \$3.5 million. The Commission also alleged that Wernick profited by selling AFGL securities to Greer. [SEC v. Leonard B. Greer, et al., Civil Action No. 97 Civ. 7267, MP, SDNY] (LR-17026)

## WESTERN-SOUTHERN LIFE ASSURANCE COMPANY, ET AL.

An order has been issued on an application filed by Western-Southern Life Assurance Company, Western-Southern Life Assurance Company Separate Account 1 and Western-Southern Life Assurance Company Separate Account 2 (the Separate Accounts), pursuant to Section 26(c) of the Investment Company Act, approving the substitution of shares of the Touchstone Variable Series Trust's (TVST) Touchstone High Yield Portfolio for

## IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

A proposed rule change filed by the <u>Philadelphia Stock Exchange</u> (SR-Phlx-2001-57) waiving equity transaction value charges for PACE orders has become immediately effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Publication of the proposal is expected in the <u>Federal Register</u> during the week of June 4. (Rel. 34-44381)

### APPROVAL OF PROPOSED RULE CHANGE .

The Commission approved a proposed rule change (SR-NASD-00-33) submitted by the National Association of Securities Dealers amending NASD Rule 33+0 to prohibit publication of quotations or indications of interest in a security during a trading halt. Publication of the notice in the <u>Federal Register</u> is expected during the week of June 4. (Rel. 34-44390)

#### WITHDRAWAL GRANTED

An order has been issued granting the application of Home Security International, Inc. to withdraw its Common Stock, \$0.001 par value, from listing and registration on the American Stock Exchange, effective at the opening of business on June 6, 2001. (Rel. 34-44391)
