INVESTMENT COMPANY ACT RELEASES

AB FUNDS TRUST, ET AL.

A notice has been issued giving interested persons until June 28 to request a hearing o. an application filed by AB Funds Trust, et al. for an order under Sections 6(c), 10(f), 12(d)(1)(J), 17(b), and 17(d) of the Investment Company Act and Rule 17d-1 under the Act. The order would permit certain common trust funds to transfer their assets to certain series of a registered open-end management investment company in exchange for shares of the series, and to permit certain series of the open-end management investment company (a) to invest cash reserves in an affiliated money market fund; (b) to operate as funds of funds, investing a portion of their assets directly in securities; and (c) advised by several investment advisers, to engage in principal and brokerage transactions with a broker-dealer affiliated with one of the investment advisers or to purchase securities in certain underwritings. The transactions would be between a broker-deal ind a portion of the investment company's portfolio not advised by the adviser affiliated with that broker-dealer. The order also would permit these investment companies not to aggregate certain purchases from an underwriting syndicate in which ar ffiliated person of one of the investment advisers is a principal underwriter. Further, applicants request relief to permit a portion of an investment company's portfolio to purchase securities issued by an affiliated person of an investment adviser to another portion, subject to the limits in Rule 12d3-1 under the Act. NATIONS FUND TRUST, ET AL.

An order has been issued on an application filed by Nations Fund Trust, et al. for an exemption from Section 17(a) of the Investment Company Act. The order permits certain series of Nations Funds Trust to acquire all of the assets and liabilities of certain series of Nations Fund Trust, Nations Fund, Inc., Nations Reserves and Nations I ifeGoal Funds, Inc. Because of certain affiliations, applicants may not rely on Rule 17a-8 under the Act. (Rel. IC-25000 – June 8)
