INVESTMENT COMPANY ACT RELEASES

FIRST ALLMERICA FINANCIAL LIFE INSURANCE COMPANY, ET AL.

A notice has been issued giving interested persons until July 6, 2001, to request a hearing on an application filed by First Allmerica Financial Life Insurance Company (First Allmerica) together with certain of its separate accounts, and Allmerica Investme. Inc. (collectively Applicants). Applicants seek an order under Section 6(c) of the Investment Company Act granting exemptions from the provisions of Sections 2(a)(32), 22(c), and 27(i)(2)(A) of the Act and Rule 22c-1 thereunder to permit the recapture of credits applied to contributions made under certain deferred variable annuity contracts that First Allmerica will issue. In addition, Applicants request that the order extend to any other National Association of Securities Dealers, Inc. member broker-lealer controlling or controlled by, or under common control with, First Allmerica, whether existing or created in the future, that serves as a distributor or principal underwriter for the contracts.
