INVESTMENT COMPANY ACT RELEASES

AETNA LIFE INSURANCE AND ANNUITY COMPANY, ET AL.

An order has been issued pursuant to Section 6(c) of the Investment Company Act to Aetna Life Insurance and Annuity Company (ALIAC) and its Variable Annuity Account B (VA B), Aetna Insurance Company of America (AICA), Golden American Life Insurance Company (Golden) and its Separate Account B (Account B), First Golden American Life Insurance Company of New York (First Golden), Reliastar Life Insurance Company of New York (Reliastar), Directed Services, Inc. (DSI) and Washington Square Securities, Inc. (WSS) amending a prior order granting exemptions from Sections 2(a)(32), 22(c), and 27(i)(2)(A) of the Act and Rule 22c-1 thereunder to permit the recapture of credits of up to 4% of contributions made under certain deferred annuity contracts.
