## **INVESTMENT COMPANY ACT RELEASES**

# THE DREYFUS/LAUREL FUNDS, INC., ET AL.

A notice has been issued giving interested persons until September 10, 2001, to request a hearing on two applications filed by The Dreyfus/Laurel Funds, et al. for orders under Section 17(b) of the Investment Company Act. The orders would permit certain series of the MPAM Funds Trust to acquire all of the assets and assume certain stated liabilities of certain series of The Dreyfus/Laurel Funds. Because of certain affiliations, applicants may not rely on Rule 17a-8 under the Act. (Rel. IC-25113 – August 16)

## **SELF-REGULATORY ORGANIZATIONS**

#### PROPOSED RULE CHANGES

The Government Securities Clearing Corporation filed a proposed rule change (SR-GSCC-00-09) to adopt an earlier daily trade submission deadline of 8:00 p.m. EST and to impose a fine schedule for late trade submission. Publication of the proposal is expected in the Federal Register during the week of August 20. (Rel. 34-44708)

A proposed rule change (SR-Amex-2001-58) has been filed by the <u>American Stock Exchange</u> to change the invoice due date for annual fees from December to within 30 days of the date the company receives the invoice. Publication of the proposal is expected in the <u>Federal Register</u> during the week of August 20. (Rel. 34-44712)

The Depository Trust Company filed a proposed rule change (SR-DTC-2001-11) to allow DTC to act upon instructions provided by a Central Matching Service Provider to (1) accept deliver order instructions to settle transactions between DTC participants and (2) collect service fees on behalf of a Central Matching Service Provider from DTC participants. Publication of the proposal is expected in the Federal Register during the week of August 20. (Rel. 34-44713)

# ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission granted accelerated approval to a proposed rule change and Amendment No. 1 thereto submitted by the <u>Philadelphia Stock Exchange</u> (SR-Phlx-2001-71) under Rule 19b-4 of the Securities Exchange Act of 1934 relating to the trading of standardized equity options on trust issued receipts. Publication of the proposal is expected in the <u>Federal Register</u> during the week of August 20. (Rel. 34-44709)

## IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

A proposed rule change filed by <u>Chicago Board Options Exchange</u> relating to exercise prices for FLEX equity options (SR-CBOE-2001-45) has become effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Publication of the proposal is expected in the <u>Federal Register</u> during the week of August 20. (Rel. 34-44710)

### APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change filed by the <u>Government Securities Clearing Corporation</u> (SR-GSCC-00-08) under Section 19(b)(1) of the Securities Exchange Act. The rule change will affect how GSCC calculates the amount of required clearing fund deposit from its Category 2 Dealer Netting Members and Category 2 Futures Commission Merchants. Publication of the order is expected in the <u>Federal Register</u> during the week of August 20. (Rel. 34-44714)
