COMMISSION ISSUES EXEMPTIVE ORDER TO PERMIT PRINCIPAL-TO-PRINCIPAL TRADING IN SECURITY FUTURES PRODUCTS

On August 21, the Commission issued an order to permit limited trading in security futures products to begin.

The Commodity Futures Modernization Act of 2000, which became law on December 21, 2000, lifted the ban on single stock and narrow-based stock index futures. The legislation, however, does not permit retail customers to trade these new products until December 21, 2001. Certain transactions between "eligible contract participants" may begin as early as August 21, 2001, if certain other conditions are met. Specifically, principal-to-principal trading between eligible contract participants may begin on August 21, if the National Futures Association (NFA) has adopted rules to meet the requirements for a Limited Purpose National Securities Association.

Today the NFA filed rules with the Com. Ission to satisfy most of these requirements. The Commodity Futures Trading Commission approved these rules on August 20, 2001, and they are effective when filed with the Commission today. The NFA also continues to work with the Commission, other securities self-regulatory organizations, and its members to develop additional rules to fulfill its obligations as a Limited Purpose National Securities Association.

The order issued by the Commission today allows the limited trading otherwise permitted as of August 21, 2001 to commence with only those NFA rules in place that became effective today.

COMMISSION ADOPTS RULES RELATING TO THE REGISTRATION OF BROKER-DEALERS PURSUANT TO SECTION 15(b)(11) OF THE SECURITIES EXCHANGE ACT OF 1934

On August 21, the Commission adopted new rules and amended existing rules to implement provisions in the Commodity Futures Modernization Act of 2000 (CFMA). The Commission adopted new Rules 15a-10 and 15b11-1 under the Securities Exchange Act of 1934 (Exchange Act), new Form BD-N, amendments to Rule 15b2-2 under the Exchange Act. These rules and amendments establish the notice registration procedures for futures commission merchants and introducing brokers that are interested in registering with the Commission as broker-dealers for the limited purpose of trading security futures products. In addition, the Commission amended Regulation S-P so that it is consistent with the Commodity Exchange Act, as amended by the CFMA. FOR FURTHER INFORMATION CONTACT: Christina K. COMMISSION ISSUES TEMPORARY EXEMPTION FROM BROKER-DEALER REGISTRATION FOR CERTAIN FUTURES COMMISSION MERCHANTS AND INTRODUCING BROKERS

On August 21, the Commission issued an order pursuant to Section 15(a)(2) of the Securities Exchange Act of 1934 (Exchange Act) to allow futures commission merchants and introducing broker that are registered with the Commodity Futures Trading Commission (CFTC) to participate in the limited trading in security futures products that is permitted to begin on August 21, 2001. The order provides futures commission merchants with temporary exemption from broker-dealer registration with respect to transactions in security futures products that lasts until October 21, 2001. After the exemption expires, futures commission merchants and introducing brokers will be required to file Form BD-N, which the Commission adopted today, in order to trade security futures products. ENFORCEMENT PROCEEDINGS

SEC CHARGES VINCENT NAPOLITANO AND ROBERT BREED WITH INSIDER TRADING

The Commission today filed complaints in the United States District Court for the Southern District of New York against Vincent Napolitano (Napolitano) of New York, New York and Robert Breed (Breed) of Bonita Springs, Florida. The complaint against Napolitano alleges the following: Napolitano received tips containing material, nonpublic information concerning the securities of eight companies from Jeffrey Streich, who had received them from Marisa Baridis, a former compliance employee at two Wall Street investment firms, who had access to onfidential information concerning the firms'

clients. Napolitano purchased securities while in possession of material, nonpublic information that he knew was obtained in breach of a fiduciary duty that Baridis owed her employer. Napolitano also established joint accounts with Streich in which they traded upon inside information and split the profits. Further, Napolitano recommended certain of the securities to several other persons. Napolitano and his tippees collectively traded in the eight securities and realized total profits of approximately \$400,000. In a related criminal case, Napolitano was convicted of state charges in New York Supreme Court relating to his insider trading.

The Commission's complaint against Breed alleges the following: Breed received tips containing material, nonpublic information concerning the securities of eight companies from Jeffrey Streich, who had received them from Marisa Baridis, a former compliance employee at two Wall Street investment firms, who had access to confidential information concerning the firms' clients. Breed purchased securities while in possession of material, nonpublic information that he knew was obtained in breach of a fiduciary duty that Baridis owed her employer. Further, Breed tipped, or directed the trading of, his friends and family in certain of the securities. Breed and his family and friends collectively traded in the seven securities and realized total profits of approximately \$200,000. In a related criminal case, Breed pled guilty to state charges in New York Supreme Court relating to his insider trading.

The complaint against Napolitano seeks a permanent injunction against violating Sections 10(b) and 14(e) of the Securities Exchange Act of 1934 (Exchange Act) and Rules 10b-5 and 14e-3 thereunder. The complaint further seeks disgorgement of illegal profits, prejudgment interest, and civil monetary penalties. The complaint against Breed seeks a permanent injunction against violating Sections 7(c), 10(b) and 14(e) of the Exchange Act, and Regulation T and Rules 10b-5 and 14e-3 thereunder. The complaint further seeks disgorgement of illegal profits, pre-judgment interest, and civil monetary penalties.
