ENFORCEMENT PROCEEDINGS

COMMISSION INSTITUTES STOP ORDER PROCEEDINGS AGAINST REGISTRATION STATEMENT OF TOKS INC.

On November 13, the Commission issued an Order Fixing Time and Place of Public Hearing and Instituting Proceedings pursuant to Section 8(d) of the Securities Act of 1933, in the Matter of a Registration Statement of Toks Inc. In the Order, the Division of Enforcement alleges that the registration statement Toks originally filed on August 31, 2001, and amended on September 7, 2001, contains untrue statements of material fact and omits material facts required to be stated. According to the allegations in the Order, Toks, among other things, fails to provide current and historical financial information as required by the Commission's forms and regulations governing the offer and sale of securities to the public and fails to describe adequately its purported ability to obtain \$10 billion of debt financing or to register \$2 trillion in stock to launch exchange tender offers for the securities of large public companies. A hearing will be held before an Administrative Law Judge at 10:00 a.m. on November 29 2001 to determine whether a stop order should be issued suspending the effectiveness of the Toks registration statement. ORDER MAKING FINDINGS AND IMPOSING SANCTIONS BY DEFAULT AGAINST DAVID LYNCH

An administrative law judge today issued an Order Making Findings and Imposing Sanctions by Default against David E. Lynch of Spring, Texas. While a registered representative of a certain broker-dealer, Lynch engaged in a parking scheme used to manipulate the price of certain government agency securities and conceal excessive markups charged to the broker-dealer's customers in violation of the federal securities laws. As a result if his actions, Lynch also aided and abetted the broker-dealer's violations of net capital and books and records requirements.

Lynch declined to defend the administrative proceeding. Accordingly, the administrative law judge ordered that he be barred from association with any broker or dealer; cease and desist from committing, aiding and abetting, or causing violations of certain federal securities laws; and pay a penalty of \$50,000. SEC INITIATES SUBPOENA ENFORCEMENT ACTION AGAINST DC&Z, LLC AND ITS MEMBERS

The Commission today announced that on August 23, 2001, it filed an application in federal district court in Chicago seeking an order requiring compliance with subpoenas issued by the Commission to DC&Z, LLC (DC&Z), Nunzio DeSantis, Joseph Zappala, Richard Cook, Francisco Urrea, and Greg Carabajal (the Respondents). DC&Z is a Florida limited liability company with its principal place of business in Albuquerque, New Mexico. DC&Z's members are DeSantis, Cook and Urrea, residents of New Mexico, and Zappala, a resident of New York. Carabajal, a resident of New Mexico, is also associated with DC&Z. The subpoenas sought documents and testimony relating to their investment activities.

The Respondents failed to comply with the subpoenas issued by the Commission and the Commission, in its application, argued that the Respondents had no valid justification for their failure to comply. On or around August 30, 2001, Respondents filed a Motion to Quash the subpoenas. On September 12, 2001, the Court denied the Respondent's Motion to Quash and granted all of the relief requested by the Commission. [SEC v. COMMISSION OBTAINS \$20 MILLION JUDGMENT AGAINST MICHAEL BERGER IN HEDGE FUND FRAUD CASE

On November 13, the Honorable Denise Cote of the United States District Court for the Southern District of New York issued an opinion and order granting the Commission's motion for summary judgment against Michael W. Berger, the former investment manager of a hedge fund known as the Manhattan Investment Fund, Ltd. (Fund). The judgment in SEC v. Michael Berger et al. finds Berger liable for securities fraud, orders him to pay disgorgement of \$20,007,233.68 and a civil penalty of \$100,000 and permanently enjoins him from violating the antifraud provisions of the federal securities laws. The \$20,007,233.68 disgorgement figure represents \$19,874,735.44 in management and incentive fees that Manhattan Capital Management, Inc. (MCM), the advisory firm owned and controlled by Berger, was paid by the Fund, as well as \$132,498.24 in prejudgment interest.

In its complaint filed January 18, 2000, the Commission charged Berger, MCM and the Fund with a massive fraud in violation of the antifraud provisions of the federal securities laws. Berger, 30, is an Austrian citizen who resides in New York City. The Fund was organized under the laws of the British Virgin Islands and was open to foreign investors and tax-exempt U.S. investors. MCM was the New York-based investment manager of the Fund. Berger owned and controlled MCM and was its only officer. Through MCM, Berger directed the investment activities of the Fund.

In her opinion and order, Judge Cote found that Berger commenced his fraudulent scheme almost immediately after the Fund began its operations in mid-1996. Judge Cote further found that, as a result of Berger's trading strategy, the Fund consistently suffered losses which ultimately totaled nearly \$400 million. Instead of accurately reporting the losses the Fund was experiencing, however Berger created fictitious account statements which substantially overstated the market value of the Fund's holdings. Judge Cote found that Berger caused a fictitious account statement to be forwarded to the Fund's administrator in Bermuda every month for 39 consecutive months. The Fund's administrator then calculated the Fund's net asset value and the market value of each investor's shares in the Fund based on Berger's fabricated figures, and sent monthly account statements based on these calculations to the Fund's investors. Judge Cote concluded that "the fraud was conceived and executed in New York by Berger" and that "Berger acted willfully and knowingly in carrying out the fraud."

Both MCM and the Fund are the subject of Chapter 11 bankruptcy proceedings pending in the United States Bankruptcy Court for the Southern District of New York. Mr. Berger remains the subject of a criminal proceeding brought by the United States Attorney for the Southern District of New York. [SEC v. Michael W. An order has been issued on an application filed by MassMutual Institutional Funds, et al., under Section 6(c) of the Investment Company Act, exempting applicants from Section 15(a) of the Act and Rule 18f-2 under the Act. The order permits applicants to enter into and materially amend sub-advisory agreements without shareholder approval. (Rel. IC-25260 – November 9)
