ENFORCEMENT PROCEEDINGS

SEC INSTITUTES PROCEEDINGS AGAINST W.J. NOLAN TO SUSPEND THE EFFECTIVE DATE OF ITS FORM BDW

The Commission announced that on December 28 the Commission issued an Order Instituting Proceedings Pursuant to Section 15(b) of the Securities Exchange Act of 1934 (Exchange Act) and Rule 15b6-1(b) promulgated thereunder against W.J. Nolan & Company, Inc. to suspend the effective date of W.J. Nolan's Form BDW filed on October 31, 2001.

In the Order, the Division of Enforcement alleges that on September 24, 2001 the Commission issued an Order against W.J. Nolan pursuant to its consent and without admitting or denying findings that the firm illfully violated Sections 15(b)(7) and 15(g) of the Exchange Act and Rules 15b7-1, 15g-2, 15g-3 and 15g-6 thereunder, and failed reasonably to supervise. The September 24th Order required, among other things, that W.J. Nolan pay disgorgement of \$153,218.12 plus prejudgment interest of \$38,810.17.

The Division of Enforcement goes on to allege that W.J. Nolan filed a Form BDW with the Commission on October 31, 2001 seeking to withdraw its registration with the Commission. The Division of Enforcement further alleges that W.J. Nolan has not paid the disgorgement and prejudgment interest as required by the Commission's September 24th Order.

The Order institutes public administrative proceedings to determine whether to delay the effective date of W.J. Nolan's withdrawal from registration with the Commission or to impose terms and conditions upon such a withdrawal. (Rel. 35-45208; File No. 3-10662)

JACKSON NATIONAL LIFE INSURANCE COMPANY, ET AL.

An order has been issued on an application filed by Jackson National Life Insurance Company (Jackson National), Jackson National Separate Account – I (the JNL Separate Account), Jackson National Life Insurance Company of New York (JNL New York), JNLNY Separate Account I (the JNLNY Separate Account), and Jackson National Life Distributors, Inc. granting exemptions from the provisions of Sections 2(a)(32) and 27(i)(2)(A) of the Investment Company Act and Rule 22c-1 thereunder, to the extent necessary to permit the recapture, under specified circumstances, of certain credit enhancements applied to purchase payments made under the flexible premium, deferred variable annuity contract described in the application that Jackson National will issue through the JNL Separate Account and the JNL New York will issue through the JNLNY Separate Account (collectively, the Contracts), as well as other contracts that Jackson National and JNL New York may issue in the future through their existing or future separate accounts that are substantially similar in all material respects to the Contracts. FIRST ALLMERICA FINANCIAL LIFE INSURANCE COMPANY, ET AL.

An order has been issued pursuant to Section 26(c) of the Investment Company Act to First Allmerica Financial Life Insurance Company (First Allmerica), Fulcrum Separate Account of First Allmerica Financial Life Insurance Company (First Allmerica Separate Account), Allmerica Financial Life Insurance and Annuity Company (Allmerica Financial Life Insurance and Annuity Company (Allmerica Financial Life Separate Account), Allmerica Investment Trust (AIT), The Fulcrum Trust (Fulcrum), and Gabelli Capital Series Funds, Inc. (Gabelli) (collectively, the Applicants) approving the substitution of shares of three series of AIT and one series of Gabelli for shares of series of Fulcrum held by the First Allmerica Separate Account and the Allmerica Financial Life Separate Account to support variable life insurance contracts or variable annuity contracts issued by First Allmerica or Allmerica Financial Life. The order also exempts Applicants from Section 17(a) of the Act to the extent necessary to permit the Applicants, by means of in-kind

HOLDING COMPANY ACT RELEASES

DOMINION RESOURCES, INC.

A supplemental order has been issued authorizing a proposal by Dominion Resources, Inc., (DRI), a registered holding company. The supplemental order increases the amount that DRI may invest in exempt wholesale generators and foreign utility companies from the proceeds of authorized financings to the sum of 100% of DRI's consolidated retained earnings plus \$4.5 billion. A proposed rule change filed by the <u>Municipal Securities Rulemaking Board</u> regarding changes to Rule A-4, on meetings of the Board (SR-MSRB-2001-09) has become effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission approved on an accelerated basis a proposed rule change and Amendment No. 1 thereto filed by the <u>National Association of Securities Dealers</u> amending NASD Rules 4510, 4520 and 4530 which relate to issuer entry and annual fee schedules (SR-NASD-2001-76). A proposed amendment to the National Market System Plan for Reporting of Consolidated Options Last Sale Reports and Quotation Information (Plan), (SR-OPRA-2001-03) has been filed by the Options Price Reporting Authority to exclude foreign currency options from the calculation of capacity allocation provided for in the Plan.
