### MEETING OF ADVISORY COMMITTEE ON THE CAPITAL FORMATION AND REGULATORY PROCESSES

The Securities and Exchange Commission Advisory Committee on the Capital Formation and Regulatory Processes will meet on July 26 in Room 1C30 at the Commission's main offices, 450 Fifth Street, N.W., Washington, D.C., beginning at 10:00 a.m. The meeting will be open to the public, and the public is invited to submit written comments to the Committee.

The Committee was formed in February 1995, and its responsibilities include advising the Commission regarding the informational needs of investors and the regulatory costs imposed on the U.S. securities markets.

The purpose of this meeting will be to discuss the progress of the Committee's work, to continue the discussion of possible alternative approaches to the capital formation and regulatory processes, as well as to discuss general organizational matters.

## INVESTMENT COMPANY ACT RELEASES

---

### CONNECTICUT GENERAL LIFE INSURANCE COMPANY

A notice has been issued giving interested persons until July 31 to request a hearing on an application filed by Connecticut General Life Insurance Company (CG Life), CG Variable Life Insurance Separate Account I (the Account), any other separate account established by CG Life in

the future (the Future Contracts, collectively, with the Existing Contracts, the Contracts) and Cigna Financial Advisors, Inc. The application requests an order pursuant to Section 6(c) of the Investment Company Act granting exemptions from the provisions of Section 27(c)(2) of the Act and Rule 6e-3 (T)(c)(4)(v) thereunder to permit applicants to deduct from premium payments received a charge that is reasonable in relation to CG Life's increased federal income tax burden resulting from CG Life's receipt of such premiums in connection with the Contracts. PHL VARIABLE INSURANCE COMPANY, ET AL.

An order has been issued pursuant to Section 6(c) of the Investment Company Act granting exemptions to PHL Variable Insurance Company (PHLV), PHL Variable Accumulation Account (the Account), and Phoenix Equity Planning Corporation from the provisions of Sections 26(a)(2)(C) and 27(c)(2) of the Act to the extent necessary to permit the deduction of a mortality and expense risk charge from the assets of the Account and of any other separate account established in the future by PHLV, in connection with issuance and sale of certain flexible premium variable annuity contracts. ## SELF-REGULATORY ORGANIZATIONS

### APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change filed by the New York Stock Exchange (SR-NYSE-95-05) to adopt a near neighbor approach to measuring specialist performance and to modify the capital utilization measure of specialist performance. (Rel. 34-35927)

The Commission approved a proposed rule change filed by the New York Stock Exchange (SR-NYSE-95-06) to limit the weight that the Specialist Performance Evaluation Questionnaire may be given in the Exchange's allocation decision making process. (Rel. 34-35932)

### ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission granted accelerated approval to a proposed rule change submitted by the New York Stock Exchange (SR-NYSE-95-24) for a six-month extension of the NYSE's capital utilization measure of specialist performance pilot program. (Rel. 34-35926)

The Commission granted accelerated approval to a proposed rule change submitted by the Philadelphia Stock Exchange (SR-PHLX-95-48) relating to an extension of the effectiveness of its pilot program and accompanying rules that provide for the trading of Nasdaq/National Market System securities through August 12, 1995. (Rel. 34-35933).

## IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

The Municipal Securities Rulemaking Board ("MSRB") has proposed rule change SR-MSRB-95-10, which has become immediately effective under Section 19(b)(3)(A). This is an interpretation of Board rule G-11 relating to sales of new issue municipal securities during the underwriting period. Publication of the order is expected in the Federal Register the week of July 14. (Rel. No. 34-35939)
