## ENFORCEMENT PROCEEDINGS

---

ADMINISTRATIVE AND CEASE-AND-DESIST PROCEEDINGS INSTITUTED AGAINST STUART, COLEMAN & CO., INC., VICTOR SICURANZA, BRIAN PAONESSA, INDIVIDUALLY, AND D/B/A L.P. TRANSFER SERVICES, INC., STANLEY JENKINS, PHILIP SNYDER, PAMELA WOODS AND SAM SEHON

The Commission announced that it instituted: (1) public administrative proceedings pursuant to Sections 15(b) and 19(h) of the Securities Exchange Act of 1934 (Exchange Act) against Stuart, Coleman & Co., Inc, (Stuart Coleman), a registered broker-dealer headquartered in New York, New York; Victor Sicuranza (Sicuranza) of Jersey City, New Jersey; Brian Paonessa (Paonessa), individually, and d/b/a L.P. Transfer Services, Inc., Stanley Jenkins (Jenkins) and Philip Snyder (Snyder) all of West Palm Beach, Florida; Pamela Woods (Woods) of Miami, Florida; Sam Sehon (Sehon) of Lake Worth, Florida; and (2) cease-and-desist proceedings pursuant to Section 8A of the Securities Act of 1933 and/or Section 21C of the Exchange Act against Paonessa, Jenkins, Snyder, Woods and Sehon. Paonessa is alleged to have willfully violated the antifraud provisions of the federal securities laws. Paonessa, Snyder, Woods and Sehon are alleged to have willfully violated, and Jenkins caused and willfully aided and abetted violations of the federal securities laws, in that Paonessa, Snyder, Woods and Sehon acted and conducted business as broker-dealers in securities while no application for registration as a broker-dealer on Form BD was filed or in effect with the Commission pursuant to Section 15(b) of the Exchange Act. Stuart Coleman and Sicuranza are alleged to have failed reasonably to supervise Paonessa with a view to detecting and preventing Paonessa's violations of Section 15(a) of the Exchange Act. ## CEASE AND DESIST PROCEEDING INSTITUTED AGAINST JOHN MCMILLAN

The Commission announced that it instituted cease and desist proceedings against John McMillan (McMillan) of Plantation, Florida, pursuant to Section 21(C) of the Securities Exchange Act of 1934 (Exchange Act) to determine whether he caused Keith Group of Companies, Inc. (Keith Group)

to violate Section 13(a) of the Exchange Act and Rules 12b-20, 13a-1 and 13a-13 thereunder, and, if so, whether a cease and desist order should be issued against him. The order instituting proceedings alleges, among other things, that in connection with the annual audit of Keith Group's August 31, 1991 financial statements, McMillan, a friend of a Keith Group director and the purported purchaser of certain real estate, signed an audit confirmation that falsely confirmed that he owed Keith Group \$1.44 million. #### CIVIL ACTION AGAINST INTERNATIONAL CONSULTING & MANAGEMENT, LTD., ET AL.

On August 10, the Commission commenced an action in the U.S. District Court for the Eastern District of Washington against Rankin Maurice Smith of Spokane, Washington, and several offshore entities, alleging fraud in the offer and sale of unregistered securities, including common stock, preferred stock, annuities and debentures issued by defendants International Consulting & Management, Ltd. (ICM), Providence Managed Portfolios, Ltd. (PMP), Providence International Debenture Fund, Ltd. (PIDF), Providence Annuity & Assurance, Ltd. (PA&A). The complaint also charges defendant William Thomas Warren of Largo, Florida, and his commodity trading advisory firm, Te Deum Corporation d/b/a Professional Advisors Management Corporation (PAMC), with fraud in connection with the offer and sale of these securities.

Without admitting or denying the Commission's allegations, Smith, Warren and PAMC consented to the entry of Final Judgments permanently enjoining them from violating Section 17(a) of the Securities Act of 1933, Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder. The Final Judgments waive disgorgement and civil money penalties as to Smith, Warren and PAMC based upon their demonstrated inability to pay. The charges against the offshore entities remain pending. #### INVESTMENT COMPANY ACT RELEASES

#### SECURITY LIFE OF DENVER INSURANCE COMPANY, ET AL.

A notice has been issued giving interested persons until September 1 to request a hearing on an application filed by Security Life of Denver Insurance Company (Security Life), Security Life Separate Account L1 (Separate Account), and ING America Equities, Inc. (formerly known as SLD Equities, Inc.) (collectively, Applicants) for an order pursuant to Section 6(c) of the Investment Company Act. The order would grant exemptions from Sections 27(a)(3) of the Act and Rule 6e-3(T)(b)(13)(ii)

thereunder, to permit issuance of certain variable life insurance contracts (Contracts) in which the percentage of sales charge deducted from any target premium payment could exceed that percentage deducted from any premium payment made in a prior year in excess of the target premium. #### JEFFERSON-PILOT MONEY MARKET FUND, INC., ET AL.

A notice has been issued giving interested persons until September 5 to request a hearing on an application filed by Jefferson-Pilot Money Market Fund, Inc. for an order under Section 8(f) of the Investment Company Act declaring that the Applicant has ceased to be an investment company. ### SELF-REGULATORY ORGANIZATIONS

#### PROPOSED RULE CHANGE

The Philadelphia Stock Exchange filed a proposed rule change (SR-Phlx-95-51) to amend the rules concerning accounts of employees of member or participant organizations to require prior written permission from the employer prior to opening a securities trading account and to increase the reporting requirements of such accounts. Publication of the proposal is expected in the Federal Register during the week of August 14. (Rel. 34-36096)

#### IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGES

The Depository Trust Company filed a proposed rule change (SR-DTC-95-13), which became effective upon filing, to reduce the monthly usage fees charged to DTC participants for issuing/paying agent accounts. Publication of the proposal is expected in the Federal Register during the week of August 14. (Rel. 34-36093)

The National Securities Clearing Corporation filed a proposed rule change (SR-NSCC-95-10), which became effective upon filing, to modify NSCC's procedures concerning processing of index receipts to incorporate the distribution of composition files for nondomestic index receipts. The proposal also establishes a monthly fee for the service. Publication of the proposal is expected in the Federal Register during the week of August 14. (Rel. 34-36094)
