# ADMINISTRATIVE PROCEEDINGS

#### JEROME S. GROSS BARRED

The Commission announced that Jerome S. Gross of Plantation, Florida, a respondent in the administrative proceeding, In the Matter of First Interregional Equity Corp. (FIE) et al, has been barred from association with any broker, dealer or municipal securities dealer following his failure to file an answer to the Order for Proceedings or to file an appearance.

The Commission found that Gross, a salesman in FIE's Hollywood, Florida office until in or about July 1981, wilfully aided and abetted violations of Sections 15B(c)(1) and 17(a) of the Securities Exchange Act of 1934 and Rule 17a-3 thereunder, and Rules G-8, G-15 and G-26 of the Municipal Securities Rulemaking Board relating to conformation delivery requirements and recordkeeping. # **INVESTMENT COMPANY ACT RELEASES**

#### MIDLAND CAPITAL CORPORATION

MIDDLE SOUTH UTILITIES, INC.

An order has been issued authorizing Middle South Utilities, Inc., a registered holding company, and two of its subsidiaries, Mississippi Power & Light Company and Arkansas Power & Light Company, for Middle South to acquire and for Arkansas to issue and sell 5,200,000 additional shares of \$12.50 par common stock at up to \$65 million cash consideration and for Mississippi to issue and sell an additional 2,175,000 shares of common stock at up to \$50,020,000 cash consideration through December 31, 1983.
