### **ADMINISTRATIVE PROCEEDINGS**

NASD PROCEEDINGS AGAINST LOWELL H. LISTROM & COMPANY, INC. AND FIRM'S PRESIDENT REMANDED

The Commission has remanded to the NASD disciplinary proceedings against Lowell H. Listrom & Company, Inc., a Kansas City, Missouri securities firm, and Lowell H. Listrom, the firm's president. The Commission found, as had the NASD, that the firm and Listrom transacted business in states where the firm was not registered as a broker-dealer, and failed to comply with recordkeeping, reporting, and credit extension requirements. However, the Commission set aside the NASD's findings that the firm and Listrom violated the NASD's interpretation with respect to free-riding and withholding.

The NASD's free-riding interpretation is designed to prevent NASD member firms and their associated persons from restricting the supply of public offerings for which there is a public demand by withholding shares, thereby forcing investors who want to purchase the securities to acquire them in the market at a price higher than the public offering price. In this case, the NASD construed its free-riding interpretation to cover a public offering that took the firm three months to sell, although it subsequently rose to an immediate aftermarket premium. The Commission concluded that the present language of the interpretation and its accompanying materials is not sufficiently clear to have put the firm and Listrom on notice that their sales in that offering would violate the interpretation. It suggested that the NASD might wish to consider amending the interpretation to clarify its application.

The Commission determined that, since the NASD gave considerable weight to the findings that were set aside, the proceedings should be remanded so that the NASD could reassess the sanctions in light of the findings of violation that the Commission sustained. (Rel. 34-19414)
