## ADMINISTRATIVE PROCEEDINGS

U.S. SECURITIES AND

WILLIAM C. HOGAN CONSENTS TO BAR AND ENTRY OF INJUNCTION

The New York Regional Office announced that on January 14 the U.S. District Court for the Southern District of New York entered a Final Judgment of Permanent Injunction by Consent against William C. Hogan. The injunction prohibits further violations of the antifraud provisions of the securities laws. In addition, the Commission accepted Hogan's Offer of Settlement and ordered administrative sanctions against him. By his offer, Hogan consented to: (1) findings, without admitting or denying, that Hogan, a former long maturity government bond trader at Paine Webber, Jackson & Curtis, entered into an illegal scheme to defraud Paine Webber during August 1978 through June 1980, and (2) a bar from association with the securities industry, provided that he may apply after three and one-half years to become reassociated. The scheme was accomplished through the manipulation of trades of long maturity government securities in two accounts maintained at Paine Webber. Such manipulation insured that the accounts were profitable. For his efforts, Hogan secretly received kickbacks from the profits in the accounts. (Rel. 34-19460)
