EXCHANGE COMMISSION

INJUNCTIVE RELIEF SOUGHT AGAINST TRI-STATE HOLDING GROUP, INC., OTHERS

The Commission announced on March 24 the filing of an action in the U.S. District Court for the District of Columbia seeking to enjoin Tri-State Holding Company, Inc., Duane V. Haas, and Christopher A. Jansen, individually and doing business as A.J. Christopher & Co., from violating the antifraud provision of the Securities Act of 1933 and fraud in connection with tender offers provision of the Securities Exchange Act of 1934. The Commission is also seeking to enjoin Haas and Jansen from violating proxy solicitation provisions of the Exchange Act and rules thereunder.

The Commission alleged in its complaint that Haas and Jansen, while participating in the solicitation of proxies for election to the Boards of Directors of Titan Group, Inc., in July 1981, and of Weiboldt Stores, Inc., in November 1982, and in opposition to a merger proposal to Weiboldt Stores in May 1982, made or caused to be made false and misleading disclosures and failed to make required disclosures in proxy statements and in other communications to shareholders. The Commission alleged that the false and misleading disclosures and omissions concerned arrangements and understandings of Haas and Jansen with respect to future transactions to secure payments of money from the issuers, the participants in such solicitations, the extent of their activities or proposed activities as participants and substantial direct or indirect interests of Haas and Jansen. The Commission also alleged that Tri-State, Haas and Jansen, in June 1982, filed or caused a registration statement to be filed with the Commission, in connection with a proposed exchange offer of Tri-State securities for the common stock of Wieboldt Stores, and disseminated copies of a preliminary prospectus to shareholders of Wieboldt Stores which contained false and misleading statements of material facts and omitted to disclose material facts. FILING, ACCELERATED AND TEMPORARY APPROVAL OF PROPOSED RULE CHANGE
