JUDGE SIGNS ORDER TO SHOW CAUSE AGAINST ACCOUNTANT

The New York Regional Office announced that on April 13 the Honorable Edward Weinfeld, Judge of the U.S. District Court for the Southern District of New York, signed an Order to Show Cause against Gerald Greenspan, an accountant from Union City, New Jersey, why he should not be held in Criminal Contempt of Court for violation of two Permanent Injunctions entered against him on November 10, 1960 and July 8, 1975 and an Order of Additional Equitable Relief entered against him on February 22, 1980.

The Commission's moving papers charge that between December 1982 and April 1983 Greenspan violated the injunctions by engaging in fraudulent "free-riding" activities by purchasing over \$45,000 worth of securities at five brokerage firms without intending to pay for such securities or paying for them with checks drawn on bank accounts having insufficient funds. The papers also charged that Greenspan failed to disclose the prior injunctions and a prior conviction as required by the Court's 1980 Amended Order of Permanent Injunction. Greenspan is required to appear before the Court on May 3, 1983. (U.S. ex rel. SEC v. Gerald Greenspan, 83 Cr. Misc. #1, S.D.N.Y., EW). (LR-9976)

ACCELERATED APPROVAL OF PROPOSED RULE CHANGES

The Commission has approved, on an accelerated basis, proposed rule changes filed by the following: The American Stock Exchange, Inc. (SR-Amex-83-9) to amend Rules 900C, 902C, 909C, and 918C and to adopt a new Rule 980C relating to the listing and trading of options on stock indices, and, in particular, options on the Major Market Index. (Rel. 34-19710); and the New York Stock Exchange, Inc. (SR-NYSE-83-16) to extend the operation of NYSE's Registered Representative Rapid Response program to June 1, 1983. (Rel. 34-19713)

PARTIAL APPROVAL OF PROPOSED RULE CHANGE

The Commission has approved the portion of a proposed rule change filed under Rule 19b-4 by the New York Stock Exchange, Inc. (SR-NYSE-82-13) that consolidates NYSE Rules 93 and 423 to require, in effect, that only members able to initiate transactions on the floor and their member organizations report their participations in joint accounts. The Exchange has granted another extension of time for Commission action on the remaining portion of this proposed rule change, which relates to NYSE Rule 422 (loans of and to NYSE committee members).
