EXCHANGE COMMISSION

TRI-STATE HOLDING GROUP, INC., OTHERS ENJOINED

The Commission announced on May 11 that the Honorable Howard F. Corcoran, U.S. District Judge for the District of Columbia, entered Final Judgments of Permanent Injunction against Tri-State Holding Group, Inc., Duane V. Haas, and Christopher A. Jansen, individually and doing business as A.J. Christopher & Co. Each defendant consented to the entry of a Final Judgment of Permanent Injunction, without admitting or denying the allegations which were contained in a complaint filed by the Commission on March 24. The Final Judgments enjoined the defendants from violating the antifraud provisions of the Securities Act of 1933, and the antifraud provisions of the Securities Exchange Act dealing with tender offers. The Final Judgments also enjoined Haas and Jansen from violating proxy soliciation provisions of the Exchange Act and rules thereunder. None of the defendants filed an answer to the Commission's charges prior to consenting to the entry of the Final Judgments. The defendants did not admit or deny the allegations in the Commission's complaint.

The Commission alleged, in its complaint, that Haas and Jansen, while participating in the solicitation of proxies for election to the Boards of Directors of Titan Group, Inc., in July 1981, and of Wieboldt Stores, Inc., in November 1982, and in opposition to a merger proposal to Wieboldt in May 1982, made or caused to be made false and misleading disclosures and failed to make required disclosures in proxy statements and in other communications to shareholders. The Commission alleged that the false and misleading disclosures and omissions concerned arrangements and understandings of Haas and Jansen with respect to future transactions to secure payments of money from the issuers, the participants in such solicitations, the extent of their activities or proposed activities as participants and substantial direct or indirect interests of Haas and Jansen. The Commission also alleged that Tri-State, Haas and Jansen, in June 1982, filed or caused a registration statement to be filed with the Commission, in connection with a proposed exchange offer of Tri-State securities for the common stock of Wieboldt and disseminated copies of a preliminary prospectus to shareholders of Wieboldt which contained false and misleading statements of material facts and omitted to disclose material facts. GOLDFIELD DEEP MINES COMPANY OF NEVADA, OTHERS ENJOINED; RECEIVER APPOINTED

The Los Angeles Regional Office announced that on April 19, after a six-day evidentiary hearing, the Honorable Francis Whelan, U.S. District Court Judge for the Central District of California, entered a Preliminary Injunction and other ancillary relief against Goldfield Deep Mines Company of Nevada, AAA Financial Corporation of Nevada (Triple A), City Continental Financial, AG, John C. Rebenstorf, III, C. Orin Swain and Morton Johnson. The Order enjoins defendants from further violations of the antifraud and books and records provisions of the securities laws, freezes bank accounts, enjoins dissipation of corporate assets and appoints Monte Krissman of Los Angeles, California as temporary receiver for Goldfield, Triple A and City Continental. In addition to the Order, Judge Whelan stated from the bench that he will prepare a memorandum opinion.

At the hearing the Commission presented evidence that City Continental, supposedly a Liechtenstein lending institution, does not exist. Over \$4.5 million of notes receivable, due from City Continental, were reported as assets by Goldfield in Forms 10 filed with the Commission and disseminated to OTC market makers in Goldfield common stock. These notes receivable, which represent over 75% of Goldfield's total assets are worthless.

The evidence showed that the defendants are engaged in the ongoing offer and sale of investment contracts in the form of ownership interests in a Goldfield ore purchase program (ore interests). Further, the Commission presented evidence

that, in connection with both the offer and sale of ore interests and the secondary trading of Goldfield's common stock, the defendants made misstatements and omissions of material fact regarding, among other things: the use of proceeds; the amount of assets of Goldfield; the existence of City Continental; the risks involved in purchasing Goldfield common stock or ore interests; and Goldfields', Rebenstorf's and Swain's history of securities violations.

Judge Whelan also ordered a hearing on May 16, for the defendants and creditors of the companies to show cause, if any, why a permanent receiver should not be appointed. (SEC v. Goldfield Deep Mines Company of Nevada, et al., U.S.D.C. C.D. Cal., Civil Action No. 83-2013 fw). (LR-9982)

ROBERT C. KENNEY ENJOINED

The New York Regional Office announced that on April 27 the Honorable Robert J. Ward entered a Final Judgment of Permanent Injunction against Robert C. Kenney, former treasurer of Saxon Industries, Inc. Kenney, without admitting or denying the allegations in the Commission's complaint, consented to the entry of the Final Judgment which enjoins him from further violations of the antifraud, recordkeeping and proxy provisions of the Securities Exchange Act of 1934 and rules thereunder.

The complaint, filed on January 13, alleged that, in furtherance of a scheme by former officers and employees of Saxon to falsify its books and records, Kenney knowingly and wilfully caused the creation of false inventory count sheets and the generation of computer runs reflecting, for year-end 1979 and 1980, respectively, \$6 million and \$2.5 million of non-existent inventory on the records of Saxon's Blake, Moffitt & Towne division headquartered in San Francisco. The complaint alleged that Kenney directed that some of this false inventory be transferred to other Saxon divisions, thereby causing the books and records of the receiving division to be false and misleading. The complaint further alleged that, as a result of the inventory falsifications, among other things, the financial information contained in annual and quarterly reports filed with the Commission by Saxon was materially false and misleading, and that Kenney aided and abetted such violations. Additionally, the complaint alleged that proxy solicitations based upon the false and misleading information were made by Kenney during a proxy contest in 1981. (SEC v. Robert C. Kenney, et al., 83 Civ. 0425, S.D.N.Y.). (LR-9989)

SOUTHWESTERN ELECTRIC POWER COMPANY

A notice has been issued giving interested persons until June 2 to request a hearing on a proposal by Southwestern Electric Power Company (SWEPCO), subsidiary of Central and South West Corporation, to finance additional pollution control facilities for a generating plant near Hallsville, Texas. SWEPCO proposes to enter into an installment agreement with the Sabine River Authority of Texas (District) for the issuance and sale of up to \$90 million of tax exempt, revenue bonds. SWEPCO proposes to refinance an earlier issuance of such bonds with the proceeds. SWEPCO will cover all of the District's costs associated with the bonds and will be conveyed title to the pollution control facilities upon completion of construction. (Rel. 35-22931 - May 9)
