SAM E. WHITTAKER CITED

Issue 83-116

Public administrative proceedings have been instituted under the Investment Advisers Act of 1940 against Sam E. Whittaker, a registered investment adviser located in Delray Beach, Florida. Simultaneous with the institution of proceedings, the Commission accepted the Offer of Settlement from Whittaker whereby he, without admitting or denying, consented to the entry of an Order finding that he wilfully violated the antifraud, books and records and other provisions of the Advisers Act.

The Order contained findings that: in approximately January 1982, Whittaker caused an advertisement to be distributed in a magazine of general circulation to obtain money through a false and misleading statement indicating that "The Whittakers Intelligence Report" was being published monthly when in fact such report had not yet been published; Whittaker engaged in a course of conduct whereby he accepted money from clients for annual subscriptions for monthly issues of "The Whittaker Intelligence Report," and failed to publish more than one monthly newsletter, and did not make refunds to subscribers; Whittaker entered into advisory contracts which failed to provide in substance that no assignment of the contract shall be made by the adviser without the consent of the client; from August 1979 to date Whittaker failed to keep any books and records, including a list of the names and addresses of subscribers; and, from March 31, 1980 Whittaker failed to file annually Forms ADV-S with the Commission, as required within 90 days of the end of his fiscal year.

Whittaker also consented to the entry of an Order providing that his registration as an investment adviser be revoked and that he be barred from association with any investment adviser. (Rel. IA864)

CIVIL PROCEEDINGS

COMPLAINT DISMISSED AS TO FIRST INDEPENDENT STOCK TRANSFER AGENT, INC.

The Denver Regional Office announced that on June 1 the Honorable John P. Moore, U.S. District Judge for the District of Colorado, entered an order dismissing a complaint as to First Independent Stock Transfer Agent, Inc. (FISTA) pursuant to a motion by the Commission. FISTA is no longer conducting business and has been in liquidation since September 16, 1981, the date of the complaint. On March 15, 1983 the Commission revoked FISTA's registration as a transfer agent. (SEC v. First Independent Stock Transfer Agent, Inc., et al., USDC, Colorado, Civil Action No. 81-JM-1645). COMPLAINT FILED AND SANCTIONS IMPOSED AGAINST WARREN M. CHOSET, J. BARRIS LEPLEY, JR., OTHERS

The New York Regional Office, and the New York, American, Chicago Board Options, Pacific, and Philadelphia Stock Exchanges jointly announced that on June 14 the following enforcement actions were instituted against Warren M. Choset of Bellmore, New York, J. Barris Lepley, Jr. of New York, New York, and others: (1) the Commission filed a complaint on June 14 in the U.S. District Court for the Southern District of New York against Choset and Lepley, who were responsible for the management of the Merrill Lynch, Pierce, Fenner & Smith Inc. Arbitrage Department at the time of the alleged violations, charging them with violating the antifraud provisions of the Securities Exchange Act of 1934. Simultaneously with the filing of the complaint, and without admitting or denying any of the allegations contained therein, Choset and Lepley consented to the entry of Final Judgments of Permanent Injunction enjoining them from further violations of those securities act provisions alleged to have been violated; and (2) the various exchanges imposed sanctions against Choset and Lepley, as well as five traders at Merrill Lynch, John N. Lazo, James Carpenter, Charles Levy, Robert Wazevich and William Mackenzie, for their participation in the scheme alleged in the Commission's complaint, which also violated the exchanges trading conduct rules. All of the respondents entered into settlement agreements whereby they agreed to the imposition of sanctions without admitting or denying the charges against them.

The Commission's complaint alleged that on December 24, 1981, Choset and Lepley engaged in a fraudulent scheme to inflate the value of various options and stocks held in the Merrill Lynch Arbitrage Department's portfolio by, among other things, effecting transactions in such securities at prices higher than the existing market. (SEC v. Warren M. Choset and J. Barris Lepley, Jr., 83 Civ. 4460, S.D.N.Y., [WCC]). (LR-10036)

DIRKS AND SCOTT ORDERED TO SUBMIT TO ACCOUNTING AND DISGORGE PROCEEDS FROM CAYMAN RE OFFERING

> Donald N. Malawsky, Regional Administrator of the New York Regional Office, announced that on June 15 the Honorable William C. Conner of the U.S. District Court for the Southern District of New York, found, following a trial on the merits, that Raymond L. Dirks and Michael C. Scott had wilfully violated the antifraud provisions of the securities laws in the underwriting and public offering of the securities of Cayman Islands Reinsurance Corp., Ltd. (Cayman Re). At the relevant time, Dirks was a limited partner of John Muir & Co., the underwriter for Cayman Re's public offering; Scott, a Canadian citizen who resides in Canada, was then chief executive officer of Cayman Re.

The Court ordered that Dirks and Scott submit to an accounting and disgorge all proceeds obtained by each of them from the Cayman Re offering. In addition, the Court ordered that Scott be permanently enjoined from further violations of the antifraud violations but declined to issue a permanent injunction against Dirks. (SEC v. Raymond L. Dirks and Michael C. Scott, 82 Civil 1166, S.D.N.Y., [WCC]). (LR-10037)
