U.S. SECURITIES AND EXCHANGE COMMISSION

REPORT OF INVESTIGATION PUBLISHED
CONCERNING AETNA LIFE AND CASUALTY COMPANY

The Commission has published a report of investigation, under Section 21(a) of the Securities Exchange Act of 1934, concerning the accounting practice employed by Aetna Life and Casualty Company of currently recognizing as income during the first three quarters of 1982 the anticipated future tax benefits of net operating loss carryforwards.

The report states that, without disputing Aetna's assertion that it proceeded in good faith, it is the Commission's position that Aetna did not meet the standard imposed by Accounting Principles Board Opinion No. 11 (APB 11) which permits the recognition of the tax benefits of loss carryforwards as income only when actually realized, except in unusual circumstances when realization is assured beyond any reasonable doubt at the time the loss carryforwards arise.

The report further states that Aetna, without admitting or denying the validity of the Commission's position on the application of APB 11 to Aetna, has agreed to restate its financial statements for the first three quarters of 1982. The restated financial statements will not recognize currently as income the tax benefits related to tax loss carryforwards. Aetna will also conform certain other financial statements to the restated financial statements.

The report also states that, in recognition of Aetna's restatement of its financial statements, the Commission has determined not to take any further action with respect to Aetna as a result of its accounting treatment of tax loss carryforwards in 1982. (Rel. 34-19949)

## **ADMINISTRATIVE PROCEEDINGS**

### NASD ACTION AGAINST DANIEL C. ADAMS AFFIRMED

The Commission has affirmed sanctions imposed by the NASD on Daniel C. Adams of Santa Ana, California, who was associated with an NASD member firm. The NASD censured Adams and fined him \$5,000. The Commission found, as had the NASD, that for an extended period of time Adams refused to supply the NASD with information it had requested. The information sought by the NASD concerned Adams' solicitation and sale of a tax shelter, International Monetary Exchange's "Gold for Tax Dollars."

In affirming the sanctions that the NASD imposed, the Commission stated: "Adams' misconduct was very serious. A refusal to supply requested information substantially undermines the NASD's ability to carry out its self-regulatory functions. The NASD's requests for information cited the clear and unequivocal rule pursuant to which its requests were made. Yet Adams chose to prefer his own interests and those of his clients to the obligation he had undertaken when he became associated with an NASD member firm." (Rel. 34-19915)
