COMMISSION ANNOUNCEMENTS

U.S. SECURITIES AND EXCHANCE COMMISSION

STOP ORDER PROCEEDINGS INSTITUTED AGAINST ORTHOMOLECULAR, INC.

The Commission announced the issuance of an Order Fixing Time and Place of Public Hearing under Section 8(d) of the Securities Act of 1933 to determine whether a Stop Order should be issued suspending the effectiveness of the registration statement filed by Orthomolecular, Inc. of Lander, Wyoming.

The hearing has been set for 10:00 a.m., August 22, 1983 at the Denver Regional Office, 410 Seventeenth Street, Denver, CO 80202.

The Commission initiated the proceeding because of alleged untrue, false and misleading statements made in and omissions in the registration statement concerning, among other things: (1) the eligibility of the "Libby Technique" for health insurance coverage, the charges which will be covered by patient health insurance, type of treatment rendered patients, and effectiveness of such technique for drug related problems; (2) the circumstances under which billings for patients were prepared and submitted to insurance carriers and the fact that certain such billings are false, misleading or unsubstantiated regarding the true identity of the provider, the type of services performed, services actually rendered and accommodations provided patients; (3) the earnings and financial condition of the Registrant; (4) the affiliation of, loans to, stock ownership of, agreements with, payments, to and involvement of Dr. A. Scott DeVous of Green River, Wyoming with the Registrant and John L. Vidakovich, president of Registrant; (5) the results of treatment of and subsequent hospitalization required for certain patients and the lack of follow up care; and (6) investigations or inquiries being conducted or reasonably anticipated to be conducted by insurance carriers and others concerning billings for patients which have been submitted for payment and impact on Registrant's operations. JOJOBA OIL & SEED INDUSTRIES S.A. (PANAMA) PLACED ON FOREIGN RESTRICTED LIST

> The Commission has received information that securities of Jojoba Oil & Seed Industries S.A., a Panamanian corporation purportedly doing business in Costa Rica, are being offered for sale in the United States by use of the mails and means and instruments of transportation and communication in interstate commerce. No registration statement under the Securities Act of 1933 has been filed with the Commission covering these securities. Accordingly, these offers may be in violation of Section 5 of the Securities Act.

> In view of the foregoing, the Commission has placed Jojoba Oil & Seed Industries S.A. on the Foreign Restricted List.

CRIMINAL PROCEEDINGS

TEXAS MAN SENTENCED IN BOSTON

The Honorable William F. Weld, U.S. Attorney for the District of Massachusetts, and Willis H. Riccio, Administrator for the Boston Regional Office, announced that on August 3 Reginald Bernard Chisholm, also known as Doctor Reginald Bernard, was sentenced to serve four years on seven counts of an 18-count indictment which had been returned on March 10, 1983 involving securities violations, mail and wire fraud. On June 21, 1983 Chisholm entered a guilty plea to seven counts of the indictment. Chisholm was also ordered to make full restitution of 1.4 million dollars. Chisholm, of San Antonio, Texas, pleaded guilty to raising over \$1 million from investors in New England and throughout the United States through the fraudulent sale of unregistered securities.

Chisholm's indictment followed a Commission action filed on June 7, 1979 [SEC v. Reginald Bernard Chisholm, et al., D.C. MA 79-1114-Z] which resulted in the entry on June 11, 1979 of permanent injunctions against him and three of his corporations from further violations of the registration and antifraud provisions of the securities laws.
