U.S. SECURITIES AND

CIVIL PROCEEDINGS

DATAMETRICS CORP., OFFICERS, FORMER OFFICER ENJOINED

The Commission announced the filing, September 12, 1983, of a civil action for injunctive relief in the U.S. District Court for the District of Columbia against Datametrics Corporation ("DMC"), a defense contracting firm, Garland White, President, Keet O. Johnson, Chief Financial Officer, and R. Douglas Shute, a former Vice President and former President of DMC's wholly-owned subsidiary, Malibu Electronics Corporation ("Malibu").

The complaint alleges, among other things, that DMC, in fiscal 1980, overstated revenue by at least \$381,000, overstated gross profit by at least \$1,169,000 and reported net income of \$426,740 when DMC actually had losses of at least \$220,000. The Commission alleges that, during fiscal 1980, DMC inappropriately recorded revenue and gross profit relating to the purported sale of 195 Model 165 printers, when in fact such printers were sold on consignment, and 125 of the 195 printers had not even been manufactured by the end of the 1980 fiscal year.

The complaint also alleges that DMC, in fiscal 1980, inappropriately recognized gross profit of \$790,629 on two major defense contracts. It is further alleged that DMC failed to reserve for a loss of at least \$200,000 on a third defense contract when cost estimates showed that DMC would suffer such a loss.

The complaint further alleges that DMC, in fiscal 1981, failed to devise and maintain sufficient internal accounting controls, and that the defendant officers misrepresented or failed to disclose material facts to DMC's independent accountants.

All of the defendants consented to the entry of permanent injunctions, without admitting or denying the allegations of the complaint. DMC is enjoined from violating the antifraud, reporting, books and records and internal control provisions of the federal securities laws. Garland White is enjoined from violating and from aiding and abetting violations of the antifraud, reporting and books and records provisions of the federal securities laws. Keet O. Johnson and R. Douglas Shute are enjoined from violating and from aiding and abetting violations of the antifraud, reporting, books and records and internal control provisions of the federal securities laws.
