# **COMMISSION ANNOUNCEMENTS**

U.S. SECURITIES AND EXCHANCE COMMISSION

JOHN HUBER NAMED DIRECTOR OF CORPORATION FINANCE DIVISION

> Chairman John S.R. Shad announced today the appointment of John J. Huber as Director of the Division of Corporation Finance. Mr. Huber succeeds Lee B. Spencer, Jr., who has returned to the private practice of law. Mr. Huber has been Deputy Director of the Division for the past two years.

> Mr. Huber, 35, joined the Commission as a staff attorney in the Division of Corporation Finance in 1975. He became a Special Counsel in the Division's Office of Disclosure Policy the following year and in 1978 was named a Senior Special Counsel in the Office of the General Counsel. In 1979 Mr. Huber was appointed Chief of the Disclosure Policy office; in 1980 Deputy Associate Director of the Division of Corporation Finance; and in October 1981 Deputy Director of the Division.

> Mr. Huber received B.A. and J.D. Degrees from the University of Wisconsin in 1968 and 1974 and an L.L.M. Degree in Taxation from the Georgetown University Law Center in 1978. He is an adjunct professor of law at Georgetown and American Universities. Before joining the Commission he was a law clerk in the office of the Wisconsin Commissioner of Securities. (PR-83-42)

# **CIVIL PROCEEDINGS**

WESTERN PACIFIC SECURITIES, INC. ENJOINED

The Los Angeles Regional Office announced that on August 8, 1983, the Honorable Lawrence T.Lydick of the U.S. District Court for the Central District of California issued an Order of Permanent Injunction ("Order") against Western Pacific Securities, Inc. ("Western Pacific"), a broker-dealer located in Los Angeles, California.

Western Pacific was charged in the complaint, filed on July 1, 1983, with violations of the net capital and customer protection provisions of the Securities Exchange Act of 1934.

The Order permanently enjoins Western Pacific from violating Section 15(c)(3) of the Securities Exchange Act of 1934 and Rules 15c3-1 and 15c3-3. Earlier, on July 1, 1983, the Court entered a Temporary Restraining Order restraining Western Pacific from further violations of the same provisions of the federal securities laws. The entry of the Orders was consented to by Western Pacific without admitting or denying the allegations of the Commission's complaint.

On July 11, 1983, the Court, based upon the application of the Securities Investor Protection Corporation, ordered the appointment of a trustee for the liquidation of the business of Western Pacific pursuant to the Securities Investor Protection Act of 1970. (SEC v. Western Pacific Securities, Inc. U.S.D.C., C.D. Cal., Civil Action No. 83-4251-LTL). (LR-10121)

JAMES L. DOUGLAS A/K/A JAMES L. COOPER ORDERED TO PROVIDE ANCILLARY RELIEF

The Chicago Regional Office announced that on August 26, 1983, the Honorable Nicholas J. Walinski, District Judge, U.S. District Court for the Northern District of Ohio, Western Division, entered an Order Directing Ancillary Relief ("Order"), which directs Douglas to make payments of \$200,000 into a fund administered by the Court for ultimate distribution to investors in installments over a three-year period. The Order also provides that an additional \$20,000 in the Court registry from a related action shall be distributed to investors along with the \$200,000, and further directs Douglas to cancel outstanding indebtedness owed to his company by investors potentially worth several million dollars. Douglas consented to the Order without admitting or denying the allegations in the Commission's complaint.

The Commission's complaint, which charged Douglas with violations of the registration and antifraud provisions of the Federal securities laws, was filed on January 18, 1982 on which date the Court entered an order of permanent injunction against Douglas prohibiting those violations. Douglas also consented to the permanent injunction without admitting or denying the allegations in the Commission's complaint.

## **CRIMINAL PROCEEDINGS**

INDICTMENTS DISMISSED

The Fort Worth Regional Office and the Texas State Securities Board jointly announced that on September 1, 1983, the Dallas County District Court dismissed indictments charging Don G. McKay ("McKay") and Abdul Amir Al-Tabatabaie ("Al-Tabatabaie"), both of Dallas, Texas, with violations of the Texas Securities Act in connection with the offer and sale of securities, namely, interests in oil wells located in Warren County, Kentucky, to a Dallas County investor. As part of the dismissal, the defendants were required to make complete restitution to certain investors who had purchased interests in the oil wells.

The indictment, returned on April 26, 1982, alleged that in October 1980, McKay and Al-Tabatabaie sold interests in five oil wells to investors by fraudulently representing that Dima Oil Company of Texas, Inc., a Texas corporation of which McKay and Al-Tabatabaie were executive vice president and a director, respectively, owned the oil and gas leases and that the wells drilled on those leases were producing oil when, it is charged, neither such representation was true.
